# **Regular Meeting:**

Thursday, March 7, 2024

The Regular Meeting of the Board of Native American Commissioners of the City of Fargo, North Dakota, was held in the Commission Chambers at City Hall at 12:00 p.m., Thursday, March 7, 2024.

#### Item 1. Welcome and Introductions

Vice Chair Littlewolf welcomed Members to the meeting and introductions were made.

#### Item 2. Approve Order of Agenda & Minutes

Member Littlewolf provided and update from the Housing Subcommittee that the community conversation held two weeks ago on ending homelessness went well with great events and conversation. She shared that she participated in a panel that was held at the Fargo Theatre in the evening.

Director of Planning and Development Nicole Crutchfield provided an update on the Savannah's Day Resolution and noted updated wording would come before the full Board at an upcoming meeting. She additionally noted that the James Mathy visit on ending homelessness went well as Member Littlewolf previously shared and stated a recap has been requested regarding the event.

Ms. Crutchfield shared that a Fair Housing and Evictions event will be held on April 11 at the Fargo Theatre at 6:30 p.m.
