## COMMUNITY DEVELOPMENT COMMITTEE MINUTES

Regular Meeting: Tuesday: August 15, 2017

The Regular Meeting of the Community Development Committee of the City of Fargo, North Dakota, was held in the City Commission Room at City Hall at 3:00 p.m., Tuesday, August 15, 2017.

## Item 1. Welcome

Chairperson Strand welcomed Members to the meeting and introductions were made.

## Item 2. Approval of Minutes: Regular Meeting of July 18, 2017

Mr. Fundingsland moved the minutes of the July 18, 2017 Community Development Committee meeting be approved. Second by Mr. Hill. All Members present voted aye and the motion was declared carried.

## Item 3. Update from the Fargo Housing and Redevelopment Authority

Lynn Fundingsland, Fargo Housing and Redevelopment Authority (FHRA), presented a summary and overview of the public housing projects that are in need of rehabilitation which include the Lashkowitz High Rise, New Horizons Manor, and Pioneer Manor. He outlined the proposed plans to upgrade the buildings and the financial costs of the projects. Discussion was held on Fargo's current needs for public housing and the estimated needs in the upcoming years.

## Item 4. Update on the Affordability Analysis

Community Development Administrator Dan Mahli gave a brief summary of the pilot Community Development Policy Fellowship held this summer.

Assistant Planner Tyrone Grandstrand presented a background of the affordability study and the goals of the Fellowship. Catlyn Christie, Katie Black, and Mary-Bianca Fuller, Community Development Policy Fellows, presented their research, findings, and recommendations on affordability to the Community Development Committee. Discussion was held on the three presented recommendations of the affordability study, which are to: 1) Establish a Community Land Trust (CLT); 2) Amend the Tax Increment Financing (TIF) policy to require affordability; and 3) Increase assistance for home energy retrofits.

Mayor Mahoney present.

Discussion continued on the implementation of these recommendations and the expectations of the City of Fargo.

## Item 5. Review 2018 Community Development grant calendar, application, and goals

Mr. Mahli reviewed with the Board a summary of the Community Development Committee's goals and the 2018 Community Development calendar including the timeline of the grant application cycle as reviewed by the Community Development Committee's workgroup. He

added staff would like to proceed with the Community Development grant calendar, application, funding considerations, and goals for 2018.

Ms. Klebe moved to approve the application process as presented. Second by Ms. Fischer. On call of the roll Members McDonald, Eidenschink, Hill, Mahoney, Fischer, Fundingsland, Redlinger, Klebe, and Strand voted aye. The motion was declared carried.

## Item 6. Other Business

Mr. Stand proposed exploring the availability of board members to change the meeting time to 2:30 p.m. instead of 3:00 p.m.

Mr. Grandstrand expressed thanks to Dr. Matthew Lindholm, Associate Professor at Concordia College, and his help with the Fellowship program.

Discussion was held on issues related to financing condominiums in relation to affordable housing.

The CD Committee's focus is on the following community development goals.

## 1) Affordable Housing & Homelessness


- Create or maintain affordable housing stock
- Increase homeownership
- Reduce homelessness in the community

## 2) Poverty Reduction

- Support efforts to increase self-sufficiency and personal well-being
- Expand economic opportunities for low-income individuals
- Promote the principles of fair housing and acceptance of diversity



- Help ensure that all Fargo neighborhoods are neighborhoods of choice
- Promote the development of downtown and older neighborhoods



## 4) Planning/Administration

 Use for administration of community development programs, general planning activities, and studies

## Responsibilities

The Community Development Committee evaluates how the City's housing and development programs are working. It also examines new programs, proposed changes and grant/funding opportunities. In addition, the CD Committee may recommend and initiate special studies and plans.

## **Community Development Grants**

Community Development Grants are made by the Fargo City Commission, with the recommendation of the Community Development Committee.

## The City of Fargo will not fund:

- Partisan, political, or denominational programs
- Endowment campaigns
- Individuals
- Requests that are not in writing
- Programs located outside the City of Fargo, unless directly benefiting Fargo residents

## **Funding Considerations**

Size of request	Minimum grant award - \$1,000 Maximum grant award (non-capital) - \$25,000		
Type of request	The City prefers to fund buildings/facility/space needs but will consider overhead and operating expenses, as well as program-related expenses. <sup>1</sup>		
	Federal funds available for non-capital requests are limited and will generally be targeted to projects that are either new or expanding an existing level of service. The Community Development Committee intends to prioritize grant requests that support an organization's facility/space needs.

## **Housing and Community Development Programs**

## **Housing Rehab**

The Fargo Housing Rehab Program preserves existing housing stock in the City's older neighborhoods by providing assistance to low and moderate income homeowners. With a little financial help, these homeowners can improve their homes and the overall condition of the neighborhood in which they live. Housing rehab assists homeowners to maintain their residences as safe, sanitary dwellings that meet local housing codes and helps prevent houses from becoming dilapidated properties. Since 1975, the program has assisted over 1,000 homeowners make more than \$12 million in home improvements. The Housing Rehab Program is funded with HOME and CDBG funds.

## Neighborhood Revitalization Initiative (NRI)

The Fargo Neighborhood Revitalization Initiative (NRI) is a program designed to improve neighborhood quality of life and encourage investment in the City's existing housing stock in older neighborhoods. The program offers incentives for residents to renovate their owner-occupied houses by providing homeowners with a low-interest loan for significant home improvements (currently 2.25%). Loans are repayable over a 10-year term and can range from \$10,000 to \$75,000. Homeowners also sign a land use covenant that restricts the property to owner-occupancy. The program is funded locally.

## **Special Assessment Assistance**

The Special Assessments Assistance Program helps alleviate the burden that special assessments can place on low and moderate income homeowners while at the same time facilitating the improvement of neighborhood infrastructure. The assistance is allocated from both local and federal sources on an annual basis. Property owners who are assessed for eligible projects with an assessment that is greater than \$500 can apply for this program. The assistance is targeted to projects that replace/upgrade infrastructure in existing neighborhoods. It is funded with local and Community Development Block Grants from HUD.

## **Snow Removal Assistance**

The City of Fargo funds a program that helps low income elderly and/or disabled homeowners pay for snow removal. The City pays a contractor to remove snow from sidewalks and walkways for persons who are eligible for the service. To be eligible, a person must live in a household where the annual income is at or below 60% of the area median.

## Storefront Rehab/Downtown Projects

The Storefront/Downtown Rehab Program is designed to renovate deteriorated properties and eliminate conditions of blight in the downtown area. Interested property owners may apply for a 50% matching grant, which can be used to complete the rehabilitation of a building exterior, demolish blighted buildings for redevelopment, or to make other exterior improvements. Since 2000, 90 projects have been completed utilizing over \$1.2 million in CDBG funds to leverage millions of dollars invested in downtown.

## Homebuyer Assistance

First-time homebuyers in Fargo are eligible to receive down payment and closing cost assistance from the ND Housing Finance Agency to purchase a home in Fargo. The Down Payment and Closing Cost Assistance (DCA) program provides zero-interest deferred payment loans to help low and moderate income households meet closing cost requirements. Homeowners are eligible to receive the greater of \$3,000 or 3% of the purchase price of the home. Funds for the program are HOME funds from HUD to the ND Department of Commerce.

## Residential New Construction Tax Exemption & Remodeling Tax Exemption

Newly constructed single family, duplex, townhome, or condominium properties may be eligible for an exemption on part of their valuation for up to two taxable years following the taxable year that construction began. In addition, existing buildings that are at least 25 years old are also eligible for an exemption on the increase in valuation resulting from the remodeling project. The residential tax exemption programs are administered by the Assessment Dept.

## **Community Development Projects**

Community Development projects include grants and zero-interest loans for unique projects that serve low-to-moderate income individuals, families and neighborhoods. These projects include Community Development housing projects, the Gladys Ray Shelter and Veterans Drop-In Center, the Emergency Food Pantry relocation project, Habitat for Humanity projects, High School student build partnerships, and various neighborhood activities, to name a few.
