COMMUNITY DEVELOPMENT COMMITTEE MINUTES

Regular Meeting: Tuesday: October 17, 2017

The Regular Meeting of the Community Development Committee of the City of Fargo, North Dakota, was held in the City Commission Room at City Hall at 2:30 p.m., Tuesday, October 17, 2017.

The Community Development Committee Members present were as follows:

Item 1. Welcome

Chairperson Strand welcomed Members to the meeting and introductions were made.

Item 2. Approval Minutes: Regular Meeting of August 15, 2017

Ms. Fischer moved the Order of Agenda be approved as presented. Second by Mr. Hill. All Members present voted aye and the motion was declared carried.

Mr. Fundingsland moved the minutes of the August 15, 2017 Community Development Committee meeting be approved. Second by Mr. Hill. All Members present voted aye and the motion was declared carried.

Item 3. Update from the Skills Development Project on job skills training and education for low-income and New American individuals

Community Development Administrator Dan Mahli introduced this item stating the program began in 2002, and noted the City of Fargo was one of the original partners of this new and innovative program. In honor of the retiring Director of the Skills Development Project, Janie Hulett, Mr. Mahli read a proclamation prepared by Mayor Mahoney recognizing Ms. Hulett and declaring Thursday, October 26, 2017 as *Janie Hulett Day*.

Ms. Hulett shared the background of how this project/program developed, the types of employment the school trains for, and the process participants complete to achieve their goal of graduation and employment. She stated that staff determines if and when a participant is ready to enter the programs, and highlighted the program's outcomes and successes.

Member Klebe present.

Board discussion followed regarding how staff addresses language barriers; assistance available for individuals needing additional support before they are ready to participate in the training program; job skills assessed to make sure applicants meet the needs of employers; how the program is promoted in the community; the availability of daycare and transportation for participants; and what more we can do to invest and continue the program's success.

Deanne Sperling, incoming Director of this project/program, shared her background and experience. She stated she is looking forward to moving the Skills Development Project forward.

Item 4. Update from the Fargo VA Medical Center on housing and support for veterans that are homeless

Diana Hall, Program Director for the VA Medical Center for Homeless Veterans in Fargo, updated the Board on what their program is doing to ensure safety and housing to homeless Veterans locally. She talked about the "housing first" philosophy their program has developed and the success within our community. She thanked the City of Fargo for its partnership at the Gladys Ray Shelter and other places throughout the city.

Ms. Hall shared how the VA's Homeless Program has evolved over the years; its goal to ensure that every homeless veteran in the area has access to housing and support services; and a vision for collaborative opportunity through a community outreach facility in the future.

Lynn Fundingsland, Executive Director of the Fargo Housing and Redevelopment Authority (FHRA), shared how the FHRA is a partner with the VA by providing HUD Veterans Assistance Housing Vouchers (VASH) to homeless veterans.

Item 5. Update on 2018 Community Development grant application and calendar Mr. Mahli reported the Community Development Grant applications are due by Friday, October 27, 2017. He explained information in the applications will be compiled into a worksheet for the grant review subcommittee and its recommendations will be presented to the Community Development Committee.

Mr. Mahli also reviewed the items included in the packet for the 2018 Community Development Calendar, the 2018 Community Development Budget, the Community Development Committee's roles and responsibilities, Community Development Grants funding considerations, scoring criteria, and the various housing and community development programs that currently exist.

Item 6. Discuss creating a subcommittee to study community land trusts

Assistant Planner Tyrone Grandstrand explained that a community land trust (CLT) is an innovative way to offer affordable housing in communities. Chairperson Strand asked for a motion to create a subcommittee and volunteers to serve on the task force. He asked Tyrone Grandstrand to work with the subcommittee.

Mr. Hill moved to create a subcommittee task force to study community land trusts. Second by Ms. Klebe. All Members present voted aye and the motion was declared carried.

The following Community Development Committee Members volunteered to serve on the subcommittee: Linda Klebe, Lynn Fundingsland, Shara Fischer, and John Strand. It was also suggested that a representative from the FM Area Foundation be included on the subcommittee.

Item 7. Other Business

No other business was presented.

Item 8. Adjourn

Ms. Klebe moved to adjourn the meeting at 3:40 p.m. Second by Mr. Hill. All Members present voted aye and the motion was declared carried.

The Office of Community Planning and Development (CPD) is striving to strengthen its working relationship with our State and local government partners to help achieve greater results in meeting the housing and community development needs of our low- and moderate-income customers. One of our important responsibilities in this ongoing process is the periodic assessment of your accomplishments and performance in the administration of funds provided by CPD and in meeting key program and Departmental objectives, as mandated by the statutes governing these programs.

This review examines information provided by the City of Fargo for its 2016 program year. In conducting this assessment, we examined your activities for consistency with the priorities and objectives outlined in the Consolidated Plan and Annual Action Plan. We used the information contained in the Consolidated Annual Performance and Evaluation Report (CAPER), the Line of Credit Control System (LOCCS) and the Integrated Disbursement Information System (IDIS), as well as any monitoring reviews conducted during the course of the program year.

Our assessment report that is enclosed covers the following areas:

- Meeting the statutory purposes of the programs
- Consistency with strategies and goals in the Consolidated Plan and Annual Action Plan
- Fair Housing and Equal Opportunity
- Timeliness
- Match for HOME
- Caps on Obligations CDBG and HOME

Based upon our analysis and examination of the data available to us, we have determined that Fargo's overall progress has been satisfactory during the most recent program year. The City of Fargo appears to be administering its programs in a manner consistent with the applicable regulatory requirements. During the period of May 1, 2016 through April 30, 2017, Fargo has carried out its program substantially as described in its Consolidated Plan and has the continuing capacity to carry out its approved program in a timely manner. These conclusions on your overall

program performance are based solely upon the information available to this office and do not constitute a comprehensive evaluation or approval of specific activities.

You have the opportunity to provide us with your review and comment on the draft Annual Community Assessment. Please provide any review and comment within 30 days of the date of this letter. We may revise the Assessment after considering your views. If we do not receive any response by the end of the 30-day period, the draft Annual Community Assessment will become final without further notice.

The final Annual Community Assessment must be made readily available to the public. You can assist us in this regard by sharing the final Annual Community Assessment with the media, with a mailing list of interested persons, with members of your advisory committee, or with those who attended hearings or meetings. You must also provide a copy of the final Annual Community Assessment to your independent public auditor. HUD will make the final Annual Community Assessment available to the public upon request and may provide copies to interested citizens and groups.

ANNUAL COMMUNITY ASSESSMENT

JURISDICTION – Fargo, North Dakota PROGRAM YEAR START – May 1 PERIOD COVERED BY ASSESSMENT – May 1, 2016 - April 30, 2017

The Department of Housing and Urban Development (HUD) is required to conduct an annual review of performance by grant recipients according to the provisions of the Housing and Community Development Act and the National Affordable Housing Act. We must determine that each recipient is in compliance with the statutes and has the continuing capacity to implement and administer the programs for which assistance is received. This is to report the results of our review of the 2016 program year Consolidated Annual Performance and Evaluation Report (CAPER), covering the second year of Fargo's five-year Consolidated Plan.

Part I. Summary of Consolidated Plan/Action Plan Review and Assessment

Fargo is meeting the primary objective of the Community Development Block Grant (CDBG) and HOME Investment Partnerships Program (HOME). The Consolidated Plan provided for five goals of affordable housing, neighborhoods, poverty reduction, homelessness, and planning/admin/fair housing. Projects funded in 2016 are consistent with strategies and goals in the Consolidated Plan and Annual Action Plan.

As demonstrated in the above table, overall Fargo has met most of their proposed project goals. A couple large brick and mortar projects were not completed, but they are on track to be completed in Program Year (PY) 2017. The 2015 CHDO project which funded three HOME units for low-income seniors in a 38-unit affordable housing project, was completed in PY16. This year's CHDO project did not move forward as it did not receive Low-Income Housing Tax Credits (LIHTC) as anticipated. Fargo will reapply in 2018, and if the tax credits are not awarded again, the funds will be reallocated to a different project. The 2016 Golden Ridge Community Center project was not completed but the renovation is currently underway. Additionally, two slum and blight projects from 2015 were completed in PY 2016, while the PY 2016 slum and blight projects are nearing completion. The Great Plains Food Bank project was cancelled because the Food Bank failed to reach its capital campaign goal and could not move forward with the facility upgrade.

Last year Fargo received a Concern regarding the City's data integrity due to inconsistencies with their goal outcome indicators and units of measurement across reports. This continues to be an issue, though it has improved from last year. The CPD Representative provided technical assistance again with the 2016 CAPER submission and requests that the City of Fargo carefully review all CAPER accomplishment data both in IDIS and in the CR-05 screen prior to future submissions to ensure that all beneficiary data is accurate and accounted for.

Part II. Summary of Grantee Performance

Community Block Grant Program

CDBG has the following primary objective: the development of viable urban communities by providing decent housing, a suitable living environment and expanding economic opportunities, principally for persons of low- and moderate-income (LMI). Consistent with this primary objective, not less than 70 percent of the aggregate of the Federal assistance shall be used for the support of activities that benefit persons of low- and moderate-income (LMI). According to the Integrated Disbursement and Information System (IDIS) PR26 report, the City expended 88 percent of the CDBG funds on the LMI population in the 2016 program year; far exceeding the statutory requirement and meeting the primary purpose of the CDBG program.

The regulations require that sixty days prior to the end of the grantee's current program year, the amount of entitlement grant funds available but undisbursed by the U.S. Treasury be not more than 1.5 times the entitlement grant amount for the current program year. The City had 1.06 grant years of funds remaining in the Line of Credit at the most recent timeliness test on March 2, 2017. We congratulate the City on being timely and urge you to continue to meet this important measure of performance.

The City is limited to a 20 percent cap on obligation of grant funds and current year's program income for administrative and fair housing expenses. Based on HUD's calculation from

the PR-03 CDBG Activity Summary Report, Fargo obligated \$141,645 in administration and fair housing, or 13 percent, which is within the allowable limit. Public service obligations are likewise limited to 15 percent of grant funds and prior year program income. Fargo obligated \$100,041, or 14.58 percent of the funding to public service activities which is within the allowed amount.

HOME Investment Partnerships Program

The HOME program requires that not less than 15 percent of such funds are reserved for investment only in housing to be developed, sponsored, or owned by community housing development organizations (CHDO). According to the HOME Compliance Status Report, Fargo's HOME program has met this requirement for its most recently completed test date of July 31, 2017. Fargo has reserved \$165,000, or 47 percent of HOME funds for use by CHDOs, which greatly exceeds the required amount. The next test date is scheduled for July 31, 2018.

Administrative funds are limited to 10 percent of the grant and prior year program income. IDIS will only allow a maximum of 10 percent to be obligated; with \$35,632, or seven percent, obligated for administration per IDIS, Fargo has not exceeded the 10 percent cap. The HOME Match Report and Minority and Women Business Enterprise (MBE/WBE) Report were submitted as part of the CAPER. Match commitments reported were within the most recently completed Federal fiscal year immediately preceding the end of the program year, October 1, 2015 through September 30, 2016. The match reported exceeds the 2016 program year requirements.

The CAPER also indicates that monitorings were conducted in June 2017 at eight HOME-assisted projects. On-site inspections of affordable rental housing found all properties to be in compliance with local housing codes and other applicable regulations. It was noted that the City of Fargo is also monitored by the State of North Dakota for State-funded HOME projects per the established monitoring schedule.

Integrated Disbursement and Information System (IDIS)

The IDIS reports indicate that the City is consistently recording data into the IDIS system; however, Fargo is not correctly inputting beneficiary goals and accomplishments for public facility projects in the eCon Planning Suite. Under the goal outcome indicator "Public Facility or Infrastructure Activities other than Low/Moderate Income Housing Benefit", Fargo has used the quantity of "1" or "2" persons assisted for major neighborhood facility projects. They were setting their goals with the intent of measuring whether or not the facility had been complete, rather than using the number of persons who would be benefited by the project. The CPD Representative provided technical assistance to the City and they have updated the accomplishment data in the CR-05 CAPER screen accordingly. Fargo is reminded to continue using this approach to setting goals and accomplishments for future public facility and infrastructure projects.

Fair Housing and Equal Opportunity / Public Participation

The Office of Fair Housing and Equal Opportunity (FHEO) received your CAPER and provided a review of Grand Forks' compliance with civil rights laws, implementation of regulations, and civil right related program requirements. The City of Fargo maintained their rating of "Moderate" based on the information within the CAPER. An email was sent from HUD Equal Opportunity Specialist Deborah Manigault to Dan Mahli, Community Development Administrator, on September 6, 2017 with guidance and a request for further information. The City of Fargo was asked to conduct an Analysis of Impediment as soon as possible that contains all the fundamental parts, essential elements, and core components described within the "Fair Housing Planning Guide." Please contact Ms. Manigault for further assistance on this request.

As a reminder, please start considering the process and preparation of your jurisdiction's plan for compliance with the new Affirmatively Furthering Fair Housing regulations. For your program, the first plan will be due on August 5, 2019. We look forward to working closely with you to ensure a smooth process.

Part III. HUD Evaluation and Conclusions

OVERALL EVALUATION

Overall, the City of Fargo appears to be making strides in providing affordable housing and addressing its community development needs through its 2016 program year activities.

В. CONCLUSIONS AND FINDINGS

> Community Planning and Development, Region VIII, has reviewed available facts and data pertaining to the performance of the City of Fargo for its Consolidated Plan and the formula Community Planning and Development Programs specified in that Plan [Community Development Block Grant, HOME Investment Partnership Act] during the period of May 1, 2016 to April 30, 2017. Based on the overall review record and the information summarized above, CPD makes the following findings:

- During the period specified above, Fargo has carried out its program 1. substantially as described in its Consolidated Plan as approved.
- 2. The Consolidated Plan, as implemented, complies substantially with the requirements of applicable laws and regulations.
- Fargo has the continuing capacity to carry out its approved program in a 3. timely manner.


