Message From the Chief



Mayor Walaker, Fire Commissioner Williams, Board of City Commissioners, and Citizens of Fargo,

The dedicated men and women of the Fargo Fire Department (FFD) work every day to protect the citizens and visitors of the City. This annual report provides an overview of their efforts.

In 2012, the FFD responded to 6,970 calls for service. This was an 11.5 % increase from 2012 and a 35% increase from 2010. Our crews responded to 3,767 Emergency Medical calls, 1,407 false alarms, 221 fires, 124 hazardous materials responses, and 1,427 other calls for service. In 2013, two citizens lost their lives to fire. Our total property loss due to fire was \$2.47 million. This was \$872,237 less than 2012. We are continuing to see additional calls for service in the southern end of

the city. We anticipate this to continue to grow as homes and businesses continue to populate that area.

In August the Fargo Fire Department was visited by an ISO representative to conduct a review. The department supplied information on operations, call response times, training, inspections, and equipment. We also facilitated the gathering of information from the Water Department and Red River Regional Dispatch. We anticipate a final determination of our classification in July of 2014. Currently the ISO rating for Fargo is a Class 3 out of 10.

In 2013 the Fargo Fire Department completed its third year as an accredited fire department. The accreditation was initially granted for a five year period. Out of 32,000 fire departments in the United States, there are 155 accredited fire departments. The Fargo Fire Department is the only fire department in North Dakota that is accredited. During the interim years fire departments are asked to submit annual compliance reports. The FFD submitted its report in August and received information that we continue to be a member in good standing.

It has been my sincere honor to serve as the Fire Chief for the City of Fargo for the past year. I am extremely proud to serve the City of Fargo, its citizens, and employees.

I owe all that has been accomplished in the past year to the hard work and dedication of the men and women that make up the Fargo Fire Department. I consider myself very blessed to work with and be associated with such an outstanding group of people. 2013 Year Review



Services

The Fargo Fire Department Operations Division responds to all fires, fire alarm notifications, emergency medical calls, hazardous materials responses, and technical rescues. The operations members also perform company level inspections in all businesses within the city. This division also works in conjunction with the City of Fargo Hydrants and Mains Division to flush all 6,400 fire hydrants in the city.

The Administration Division is staffed with an Assistant Fire Chief, one Emergency Manager/Battalion Chief, and 2 Training Captains. This division is responsible for all training conducted within the department. This division also oversees all equipment, maintenance, and training records for the department. The Administration Division coordinates all public relations activities, Community Emergency Response Teams (CERT), and the HeartSafe Fargo Public Access Defibrillation Program (PAD).



The Fire Prevention Bureau is staffed with 4 Fire Inspector/Investigators and an Assistant Chief who serves as the Fire Marshal. The FPB annually inspects all schools, churches, gas stations, medical facilities, bars and restaurants. The FPB also provides the "Learn Not to Burn Program" in all schools in the city.

Resources

The Fire Department operates out of 7 fire stations strategically located throughout the City. Our daily staffing is 35 personnel with a minimum of 27 personnel on duty each day. There are 7 engine companies and 2 truck companies and 2 command vehicles in service each day to serve the needs of the citizens and visitors of the City of Fargo.



The Fargo Fire Department has entered into two Memorandums of Understanding (MOU) with the State of North Dakota. The MOU's are for Hazardous Materials response and Technical Rescue response to the Southeast Region of the State.

Insurance Services Organization (ISO)

In August the Fargo Fire Department was visited by an ISO representative to conduct a review. The department supplied information on operations, call response times, training, inspections, and equipment. We also facilitated the gathering of information from the Water Department and Red River Regional Dispatch. We anticipate a final determination of our classification in July of 2014. Currently the ISO rating for Fargo is a Class 3 out of 10.





Mission

The mission of the Fargo Fire Department is: Protect lives and property from fire and other emergencies; to respond to emergencies in a professional and courteous manner; to reduce the rate of emergencies through public education and code enforcement.



Center for Public Safety Excellence (CPSE) Accreditation

In 2013 the Fargo Fire Department completed its third year as an accredited fire department. The accreditation was initially granted for a five year period. Out of 32,000 fire departments in the United States, there are 155 accredited fire departments. The Fargo Fire Department is the only fire department in North Dakota that is accredited. During the interim years fire departments are asked to submit annual compliance reports. The FFD submitted its report in August and received information that we continue to be a member in good standing.





All Operations Division personnel completed annual EMT training and were recertified.

All Fire Companies completed annual training evolutions in accordance with EPA, NFPA, and OSHA standards.

There were two fire fatalities as the result of a fire that occurred on April 6, 2013. National statistics show that a community the size of Fargo can expect one to two fire fatalities annually.

HeartSafe Fargo Public Access Defibrillator program placed 62 PADS and trained 104 citizens in CPR.



The Fire Prevention Bureau continues to reduce risk through public education programs, fire prevention inspections, and fire investigations.

Public education is a critical component of fire prevention. One way we educate the public is the "Learn not to burn" program for kindergarten, 1st, and 2nd graders. As a part of this program we spent time in January teaching "Exits" to 2795 children. In October 2878 children learned about the 911 system.

At risk young community members were provided with additional fire safety information by distributing "Spot something hot" safety books to Fargo YMCA childcare centers, the YWCA Emergency shelter, and Nokomis child care centers.

Our adult education system gave safety talks, presentations, and fire extinguisher training to 98 individuals. The audience included apartment building managers, building safety professionals, and childcare providers. "Cooking Safety Tips" pamphlets were delivered to the Fargo Housing Authority to be distributed to new tenants.

Annually, in October we participate in the National fire prevention week and place fire prevention posters throughout the community to raise fire prevention awareness.

Fire Prevention

Inspections are done to determine compliance with the Fire Code. The city of Fargo adopted the International Fire Code 2012 edition effective August 2013. The fire prevention bureau along with suppression personnel inspect commercial and residential occupancies. A few of the fire prevention bureau's responsibilities include: permit inspections, new construction/remodels, fire alarm and sprinkler system installations, plan reviews, and complaints.







Runs per Station Area/Planning Zone




Operations

As the City of Fargo continues to grow, so do the number of emergency calls that the FFD responds to. In 2013 the FFD went on 6,984 calls for service which is an increase of 722 from 2012. The average number of calls per day is 19.13. This is an increase of 60% from 5 years ago.

55 Firefighters received training and were transitioned from the current EMT-Basic standard to the new EMT standard for national certification with the remainder to be transitioned in the upcoming year.

107 firefighters were trained in the knowledge, skills and abilities required to provide quality emergency medical care. Some areas of training include:

- Patient assessment
- •Care and treatment for potentially life threatening medical conditions
- •Care and treatment for traumatic injuries
- •Emergency cardiac care
- Auto extrication

Roughly 75% of the emergency calls responded to by the Fargo Fire Department are medical in nature. The fire department is committed to ensuring that the citizens of Fargo receive the highest quality emergency medical care possible.

308 citizens were trained in traditional CPR, Compression Only CPR, and Automated External Defibrillator Use and the Apple App Store.

Pulsepoint.org was added to our growing list of Heartsafe partners:

- •It provides the user with the location of emergency.

The Fargo Fire Department continued its partnership with Essentia Health and the American Red Cross in an attempt to increase sudden cardiac arrest survival rates in the Fargo community by increasing awareness, the number of trained citizens in our community and public access to Automated External Defibrillators.



Fire Training




Captain Lee Soeth trained and evaluated the entire department on company level firefighting skills. These skills are designed so each firefighter can train with the equipment needed to accomplish the wide variety of fire ground tasks. Fire suppression personnel completed an average of 180 hours per person of fire ground training. Additional training hours were completed in technical rescue, driver/pump operator, and hazardous materials. The fire department also conducted two recruit classes that added four new firefighters. Each recruit completed 250 hour of classroom and hands on training

The Fargo Fire Department maintains a Hazardous Materials Response Team based out of Fire Station 7. The team is comprised of 30 members divided between three shifts. We respond to all calls in the city of Fargo and are contracted as the Southeast Regional Hazardous Materials Response Team for the State of North Dakota. As part of the Regional team, we respond to Haz Mat incidents in Barnes, Cass, Dickey, Kidder, LaMoure, Logan, McIntosh, Ransom, Richland, Sargent, and Stutsman Counties. The team also provides personnel to back up the Moorhead Fire Department Haz Mat Team. The primary funding of the Haz Mat Team comes from grants distributed by the ND Department of Emergency Services. This year grants have helped purchase a Chevy Suburban support vehicle, Haz Mat entry suits, monitors, communication equipment, and consumable supplies.

Hazardous Material Continued...

The Haz Mat team trains on a monthly basis to maintain competency in a skill set derived from National standards and local needs. This past year we supplemented our monthly training with several special classes and drills including:



In February, a WMD Radiological/Nuclear Responder Operations class taught by instructors from the Center for Rad/Nuke Training, Nevada Test Site. In May, a drill with the MFD Haz mat team simulating a chlorine leak at their water treatment plant.

In June, a training session with the Mobil Deployment Detection Unit, a rapid response trailer of equipment for radiological monitoring/detection that is sent to large events such as the Super Bowl and Political Conventions.

In August, a three day drill with the National Guard Civil Support Teams from North Dakota, Minnesota, and Wyoming, the FBI, and the Moorhead Fire Department Haz Mat Team. This drill simulated stolen radiological components to be used for terrorist activities.

Hazardous Material Continued...



In Sept the Haz Mat team participated in a table top drill in West Fargo simulating a crude oil train derailment with fire between Fargo and West Fargo.

In November, the team participated in a Railway Emergency Response class with BNSF that included a hands-on portion with a full sized rail car training prop.

We accomplished a major goal this year with the writing and approval of Standard Operating Guidelines for use by all of the Regional Haz Mat Response Teams in ND. In 2014 the team will work to attain Pro Board Certification for Hazardous Material Technicians.

The team had several deployments in the past year. We responded to chemical spills, meth labs, petroleum releases, and most notably train derailment with fire just outside of Casselton, ND. In Casselton, the team assisted the local Incident Commander with gathering and interpreting information to make decisions on evacuation vs sheltering in place.


