WHEREAS, The Board of City Commissioners of the City of Fargo, North Dakota, has created Improvement District No. UN-15-E in the City of Fargo, North Dakota, as required by law; and

WHEREAS, Plans and Specifications and the Engineer's Report prepared by the City Engineer, have been considered.

NOW, THEREFORE, BE IT RESOLVED, That the Plans and Specifications and Engineer's Report for the construction of Improvement District No. UN-15-E in the City of Fargo, North Dakota, be and the same are hereby approved and ordered filed in the Office of the City Auditor.

<u>Direct City Auditor's Office to Call for Bids for Improvement District No. UN-15-E:</u>

Direct City Auditor's Office to publish a Notice, as required by law, calling for bids for the construction of Improvement District No. UN-15-E in the City of Fargo, North Dakota.

Second by Williams. On call of the roll Commissioners Sobolik, Williams, Piepkorn and Mahoney voted aye.

No Commissioner being absent and none voting nay, the motion was declared carried.

Retirement Resignation from the Civic Center Director Approved:

The Board received a communication from City Administrator Pat Zavoral stating he received a letter from Chair of the City Hall - Auditorium Commission Dan Armbrust. The letter states, he said, that the Auditorium Commission took two actions at its last meeting, one was to accept the retirement resignation from the Civic Center Director Bob Getz, and the other was to ask that Mr. Getz be allowed to stay on as a contract employee for up to 12 months. He said the Auditorium Commission also asked that the job description for the Director be reviewed in light of possible changes to the management responsibilities of the position over the next 12 months. He said this request is based on discussions being undertaken at the City Commission level relating to the combining of the Fargodome and Civic Auditorium management.

Commissioner Piepkorn moved to accept the retirement resignation of Civic Center Director Bob Getz, and to direct the City Administrator and appropriate staff to negotiate a contract with Mr. Getz for up to 12 months.

Second by Williams. On call of the roll Commissioners Piepkorn, Williams, Sobolik and Mahoney voted aye.

No Commissioner being absent and none voting nay, the motion was declared carried.

Proposal from HVS/JLG/Schuler Shook for Completion of a Feasibility Study to Evaluate the Repurposing of the Civic Center into a Multi-Purpose Performance Facility Approved:

The Board received a communication from Enterprise Director Bruce Grubb stating the City Commission approved the advertisement of a Request for Proposals for consulting services related to the potential repurposing of the Civic Center into a multi-purpose performance facility. He said the Civic Center Task Force prepared an RFP and on February 6th seven proposals were received from consultant teams. He said based on the proposal reviews, the Civic Center Task Force scheduled five follow-up interviews with the consultant teams and subsequently selected HVS/JLG/Schuler Shook as the preferred consultant team.

Commissioner Williams moved the proposal from HVS/JLG/Schuler Shook in the amount of \$107,800.00 for completion of a feasibility study to evaluate the repurposing of the Civic Center into a multi-purpose performance facility be approved.

Second by Piepkorn. On call of the roll Commissioners Williams, Piepkorn, Sobolik and Mahoney voted aye.

No Commissioner being absent and none voting nay, the motion was declared carried.

<u>State Water Commission Cost Reimbursement Request for FM Diversion Flood Project Costs Approved:</u>

Finance Director Kent Costin said the expenditures listed in the reimbursement request are for \$470,398.00.

Commissioner Sobolik moved the cost reimbursement request to the State Water Commission for FM Diversion Flood Project costs in the amount of \$470,398.00 be approved.

Second by Piepkorn. On call of the roll Commissioners Sobolik, Piepkorn, Williams and Mahoney voted aye.

No Commissioner being absent and none voting nay, the motion was declared carried.

Application Filed by PAC DAK Hospitality, LLC d/b/a Holiday Inn Express and Suites I-94 for an Alcoholic Beverage License Approved:

A Hearing had been set for this day and hour on the application filed by PAC DAK Hospitality, LLC d/b/a Holiday Inn Express and Suites I-94 for a Class "ABH-Limited" Alcoholic Beverage License at 4711 19th Avenue South, notice of which had been duly published in the official newspaper for the City of Fargo.

City Auditor Steve Sprague said he has recently had discussions with staff and there are certain parameters in this ordinance that the Health and Police Departments are not 100% on board with. He said they would like to make a couple of amendments to the ordinance that was just passed. He said one of staff's recommendations was that the cooler needs to be under lock and key at all times, as well as a couple of other things that staff is recommending. He said the applicants are aware of the request and will make the appropriate accommodations.

No written protest or objection to the granting of the application has been received or filed in the office of the City Auditor, and said application has been approved by the Police Department as to the character of the applicant.

The Board determined that no person is present at this Hearing to protest or offer objection to the granting of the application.

Commissioner Piepkorn moved the application be approved.

Second by Williams. On call of the roll Commissioners Piepkorn, Williams, Sobolik and Mahoney voted aye.

No Commissioner being absent and none voting nay, the motion was declared carried.

Application Filed by FCH Fargo HIE, LLC d/b/a Holiday Inn Express for an Alcoholic Beverage License Approved:

A Hearing had been set for this day and hour on the application filed by FCH Fargo HIE, LLC d/b/a Holiday Inn Express for a Class "ABH-Limited" Alcoholic Beverage License at 4010 40th Street Southwest, notice of which had been duly published in the official newspaper for the City of Fargo.

No written protest or objection to the granting of the application has been received or filed in the office of the City Auditor, and said application has been approved by the Police Department as to the character of the applicant.

The Board determined that no person is present at this Hearing to protest or offer objection to the granting of the application.

Commissioner Piepkorn moved the application be approved.

Second by Williams. On call of the roll Commissioners Piepkorn, Williams, Sobolik and Mahoney voted aye.

No Commissioner being absent and none voting nay, the motion was declared carried.

<u>Discussion Regarding the Downtown Circulator Bus:</u> <u>Commissioners Williams and Piepkorn Appointed to the Downtown Circulator Task Force:</u>

Commissioner Piepkorn said the circulator bus is a great concept and he thinks it will be very successful. He said he has asked Planning Director Jim Gilmour to determine if there are any potential parking spots in downtown Fargo that can be used, since it will be Fargo taxpayer's money funding the bus.

Planning Director Jim Gilmour said the most of the City-owned lots are at or near capacity. He said the need for downtown parking is not just for the City Hall campus but for any other business looking to expand downtown that will not be able to find parking for their employees. He said the circulator could be a win/win for a lot of downtown workers and businesses. He said he and the Mayor went to a Moorhead City Council meeting and they would like to form a Technical Committee to look at this idea. He said they have already appointed two council members to serve on the Committee.

Commissioner Piepkorn said he would like to look at other options within the City of Fargo, as he wants to see businesses in Fargo grow.

Transit Manager for MATBUS in Moorhead Lori Van Beek said buses and cars cross the river, Fargo and Moorhead are one community and it would be wonderful to see the downtowns grow in both communities.

Economic Development Director for the City of Moorhead Matt Maslowski said several of the businesses surrounding the Moorhead Center Mall area that he spoke to last week were very supportive of this idea. He said his City Council is definitely

open to have a discussion about putting resources into this idea. He said this could be a great test run for something bigger.

Commissioner Sobolik moved Commissioners Williams and Piepkorn be appointed to serve on the Downtown Circulator Task Force along with any additional staff that may be needed.

Second by Williams. On call of the roll Commissioners Sobolik, Williams, Piepkorn and Mahoney voted aye.

No Commissioner being absent and none voting nay, the motion was declared carried.

Setback Waiver Request for the Proposed City Hall Structure Approved:

The Board received a communication from Division Engineer Nathan Boerboom stating the Engineering Department has reviewed the setback waiver submitted by Houston Engineering on behalf of T.L. Stroh Architects for the proposed City Hall structure. He said the proposed structure is located entirely outside of the minimum disturbance zone setback (MDZS) and appears to meet the City's floodproofing construction requirements by providing for a floodproof perimeter around the structure. He said included within the proposal are complete geotechnical reports that were completed for the proposed City Hall structure design and the planned flood mitigation project along 2nd Street North. He said after reviewing the submittal, City staff feels that the waiver meets all of the necessary requirements of the City flood proofing code and policy.

In response to a question from Commissioner Piepkorn as to what the river level is on the first floor of the structure, Michael Love from Houston Engineering said the level is at 34.5 feet.

Commissioner Sobolik moved the setback waiver request for the proposed City Hall structure be approved.

Second by Williams. On call of the roll Commissioners Sobolik, Williams and Mahoney voted aye.

Commissioner Piepkorn voted nay.

The motion was declared carried.

Virginia Clark Johnson Reappointed to the Airport Authority:

The Board received a communication from Mayor Mahoney recommending that Virginia Clark Johnson be reappointed to the Airport Authority.

Commissioner Piepkorn moved Virginia Clark Johnson be reappointed to the Airport Authority for a five-year term ending April 8, 2020.

Second by Sobolik. On call of the roll Commissioners Piepkorn, Sobolik, Williams and Mahoney voted aye.

No Commissioner being absent and none voting nay, the motion was declared carried.

Blake Nelson and Nancy Jordheim Appointed to the Fargo Dome Authority:

The Board received a communication from Mayor Mahoney stating the terms of Dennis Fuhrman, Park District nominee, Darrell Vanyo, Cass County Commission and Deb Mathern, Board of Education nominee on the Fargo Dome Authority expire on April 1, 2015. He said he is recommending that Blake Nelson as the Park District nominee, Chad Peterson as the Cass County Commission nominee and Nancy

Jordheim as the Board of Education nominee be appointed to the Fargo Dome Authority.

Commissioner Piepkorn said he would like the Commission to consider nominating Darrell Vanyo to retain continuity on the Board.

Commissioner Williams moved Blake Nelson, Chad Peterson and Nancy Jordheim be appointed to the Fargo Dome Authority for four-year terms ending April 1, 2019.

The motion died for the lack of a second.

Commissioner Sobolik moved Blake Nelson, Darrell Vanyo and Nancy Jordheim be appointed to the Fargo Dome Authority for four-year terms ending April 1, 2019.

Second by Piepkorn. On call of the roll Commissioners Sobolik and Piepkorn voted aye.

Commissioners Williams and Mahoney voted nay.

The motion died for a lack of a majority.

Commissioner Piepkorn moved Blake Nelson and Nancy Jordheim be appointed to the Fargo Dome Authority for four-year terms ending April 1, 2019.

Second by Williams. On call of the roll Commissioners Piepkorn, Williams, Sobolik and Mahoney voted aye.

No Commissioner being absent and none voting nay, the motion was declared carried.

Commissioner Sobolik moved that the Cass County Commission nomination be referred back to the Cass County Commission, requesting a letter of recommendation for one nominee to the Fargo Dome Authority.

Second by Piepkorn. On call of the roll Commissioners Sobolik, Piepkorn, Williams and Mahoney voted aye.

No Commissioner being absent and none voting nay, the motion was declared carried.

Legislative Issues:

City Administrator Pat Zavoral reviewed the 2015 Legislative issues matrix and shared the legislative hearings that will be held this week.

Second by Piepkorn. On call of the roll Commissioners Sobolik, Piepkorn, Williams and Mahoney voted aye.

No Commissioner being absent and none voting nay, the motion was declared carried.

Commissioner Piepkorn moved that the Board adjourn to 5:00 o'clock p.m., Monday, March 30, 2015.

Second by Sobolik. All the Commissioners voted aye and the motion was declared carried.

The time at adjournment was 5:51 o'clock p.m.
