Annual Status Report of Defined Benefit Pension Funds Received and Filed:

Consulting Actuary Mark Meyer from Van Iwaarden and Associates provided a status update on recently completed actuarial studies and the current funding status of the City's three defined benefit pension funds. He commended the Board for their work three years ago in addressing the pension issues and adopting a policy that is working the way it should; however, he said, the funding status for all three plans has gone down. He said there are changes in reporting requirements, as well as some changes in the actuarial standards of practice. Starting at the end of 2015, he said, new accounting rules under GASB 68 require the entire unfunded pension liability, previously a footnote on the balance sheet, be placed on the books as a true balance sheet liability, thus changing the figure from \$7.3M to \$46.2M for an increase of \$40M. The practical impact of the change is virtually nothing, he said, due to this number having previously been recorded in the footnote. Also, he stated, this number will not impact the City's bond rating. A 7.5% investment return assumption is being used, he said, and a mortality table from 2014 has been adopted, replacing the one being used from 2000.

In response to a question from Commissioner Piepkorn asking if the 7.5% return assumption is too optimistic since last year it was 5.5 to 6%, Mr. Meyer said he believes the return is historically reasonable and forward looking.

Commissioner Piepkorn said it is disappointing that both the employee and City are contributing more and it is still going backward.

Mayor Mahoney said while the growth is slower than wanted, it is on track.

Commissioner Williams moved the update and financial status report for the City's defined pension funds be received and filed.

Second by Piepkorn. All the Commissioners voted age and the motion was declared carried.

<u>Five-Year Consolidated Plan for Housing and Community Development and 2015 Annual Action Plan for Housing and Community Development Approved:</u>

A Hearing had been set for this day and hour on the draft 2015-2019 Consolidated Plan for Housing and Community Development Activities. The 2015-2019 Consolidated Plan includes an Action Plan for how Community Development resources will be used in fiscal year 2015.

Community Development Administrator Dan Mahli said the Planning and Development Department receives federal funds annually through the US Department of Housing and Urban Development (HUD). He said to receive the Community Development Block Grant (CDGB) and HOME Investment Partnership funding, the City is required to prepare a five-year Consolidated Plan and Annual Action Plan. He shared the draft Consolidated Plan for years 2015-2019 and the 2015 Annual Action Plan. He said under guidance from the Community Development Committee, the findings are the result of consultations with housing and community development partners, public meetings and program history. Upon approval by the Board, he said, the Plans will be forwarded to HUD for final review and approval. He said Fargo expects to have available \$680,000.00 in Community Development Block Grant (CDBG) funds and \$400,000.00 in HOME funds. He said the projects in the 2015 Action Plan include the following activities:

HOUSING:

Housing Rehabilitation-Owner Occupied - \$265,300 to be available for rehabilitation of existing owner-occupied housing units. This includes \$50,000 in CDBG and \$215,300 in HOME funds.

Beyond Shelter, Inc. CHDO Projects - \$150,000 in HOME funds for construction of affordable senior housing at 4835 28th Avenue South.

Special Assessment Assistance - \$15,000 in CDBG funds to assist low income homeowners with annual special assessments.

Fargo Housing & Redevelopment Authority - \$400,000 in CDBG funds for land acquisition to be used for the development of affordable housing.

DOWNTOWN PROJECTS:

\$100,000 in CDBG funds for projects that address slum and blight conditions in downtown Fargo.

PUBLIC SERVICE PROJECTS:

Fargo Homeless Initiatives - \$68,000 in CDBG funds to support Fargo's emergency homeless shelter as well as a police liaison to the homeless population.

Snow Removal Assistance - \$2,000 in CDBG funds to offer snow removal assistance to low income senior households and people with disabilities.

Metro Transportation Initiative - Opportunities Under Transit (OUT) \$2,000 in CDBG funds to provide transportation to low and moderate income participants.

Job Training - \$10,000 in CDBG funds to provide job skills training and development for refugees and low income persons.

Homebuyer/Tenant Education - \$20,000 in CDBG funds to support general and financial education for low income new homebuyers and renters.

FACILITIES/CAPITAL:

Neighborhood Project - \$150,000 in CDBG funds will be used for a community project in a low income neighborhood in Fargo.

TNT Kid's Fitness - \$75,000 in CDBG funds to improve accessibility and accommodations for kids with disabilities.

Fargo Public Schools - Agassiz Playground - \$50,000 in CDBG funds for a playground in the Agassiz neighborhood.

ADMINISTRATION:

\$136,000 in CDBG funds for project development, planning, and administrative costs associated with the delivery of the CDBG program. HOME funds will provide an additional \$34,700 for administration.

Commissioner Sobolik moved the 2015-2019 Consolidated Plan for Housing and Community Development, and the 2015 Annual Action Plan be approved.

Second by Williams. On call of the roll Commissioners Sobolik, Williams, Piepkorn and Mahoney voted aye.

No Commissioner being absent and none voting nay the motion was declared carried.

Resolution Adopted Approving a Vacation of Public Utility Easement Located on Lot 3, Block 4, Westrac First Addition (3117 Westrac Drive South):

The Board received a communication from Planning Administrator Nicole Crutchfield stating the Reciprocal Release and Relinquishment of Easement is intended to extinguish a portion of a public utility easement established by Plat (Westrac First Addition) on January 2, 1975. The easement does not contain any utilities, she stated, and is unlikely to be needed in the future.

Commissioner Piepkorn offered the following Resolution and moved its adoption:

WHEREAS, a public utility easement was established as a result of a Plat dated December 10, 1974, and recorded in the Office of the Recorder for Cass County, North Dakota on the 2nd day of January, 1975, as document number 486069, for which a public utility easement was appurtenant to the following described real property:

Resolution Adopted Approving The Aspens First Addition (5000 Prosperity Way South):

Planning Administrator Nicole Crutchfield said the applicant is seeking approval for a minor subdivision plat, entitled The Aspens First Addition, which is a replat of Lot 22, Block 5, Timber Creek First Addition into one block and 26 lots. She said the property is located at 5000 Prosperity Way and encompasses approximately 6.96 acres. She said the applicant intends to develop a 26-unit attached housing development consisting of six, 4-unit townhome buildings and one 2-unit building arranged around a shared private driveway off of Prosperity Way. It is a unique layout, which includes a cul-de-sac, she stated, and is somewhat complicated for a minor subdivision. She said plans have been reworked over the past six months for issues involving the utilities, easements and access.

In response to a question from Commissioner Piepkorn about whether the Fire Department is satisfied with the plans, Ms. Crutchfield said fire access is included as part of the site plan review process and radiuses and access points meet the fire code.

In response to Commissioner Piepkorn's question about whether it is clear it is a private drive, and understood the City is not responsible for maintenance, Ms. Crutchfield said when you enter the subdivision, it will have the look of a driveway and not a public street.

In response to a question from Commissioner Williams about the storm water runoff, since there is no curb and gutters, City Engineer April Walker said the City will own the sanitary sewer and water line; however, the storm sewer will be private and connect into the City line to the north and benefits from the pond constructed for Timber Creek. She said there is a loop system for water shut offs in the easements the City will control. She said in the developer's agreement, if their pavement is disturbed as part of getting to the City's lines, it is the developer's responsibility to repair the pavement since they chose to have infrastructure under the paving. Efforts were made to keep it out of the pavement as much as possible, she said, with much of it at the edge of the pavement. She said the requirements of the fire code were met in the cul-de-sac for turnaround at the end.

Tyrone Leslie, President of Heritage Homes, said the development blends well in the area and he sees a market for this type home for people downsizing, offering well designed layouts, no steps and high quality.

Commissioner Williams said part of the benefit of being located in the City is the great delivery of services. He said he sees it as a good project; however, he has safety concerns with there being only one access point in and out.

Commissioner Sobolik offered the following Resolution and moved its adoption:

Commissioner Williams voted nay.

The motion was declared carried.

Parcels of Land on Blocks 19, 20 and 21, All of Vacated 5th Street South, 6th Street South and 2nd Avenue South, and All of Vacated Alleys Within Blocks 19-21, Original Townsite Addition and a Portion of the North Half of Section 7, Township 139 North, Range 48 West Rezoned (333 4th Street South; 302, 410 and 450 7th South; and 400 and 502 1st Avenue South):

At a Hearing held on April 7, 2015 the Fargo Planning Commission recommended approval of a change in zoning from SR-2, Single-Dwelling and GC, General Commercial to P/I, Public and Institutional on Blocks 19, 20 and 21, all of vacated 5th Street South, 6th Street South and 2nd Avenue South and all of vacated alleys within Blocks 19-21, Original Townsite Addition and a portion of the North Half of Section 7, Township 139 North, Range 48 West.

The City Auditor's Office published a Notice of Hearing stating this is the time and date set for said Hearing at which time all interested persons could appear and would be heard.

Planning Administrator Nicole Crutchfield said the applicant is seeking approval of a zoning map amendment to rezone an area encompassing approximately 38 acres, and contains Island Park and the downtown YMCA. She said in January, the YMCA submitted a building permit application for a proposed addition to the existing YMCA building at 400 1st Avenue South. Upon review, she said, it was found that several zoning related issues would prohibit the addition as proposed. She said the addition would be located over a property line within an easement granted to the YMCA by the Fargo Park District resulting in the building being located within both the GC, General Commercial and the SR-2 Single-Dwelling zoning districts. She said the issue is that a community service use such as the YMCA is not a use permitted by right in the SR-2, Single-Dwelling zoning district, but is a conditional use. To address these zoning issues, she said, it was suggested by staff that all the property be rezoned to Public and Institutional to accommodate the building addition, being the best fit with the existing uses of community service, parks and open space.

President of the Cass-Clay YMCA Paul Finstad said their plan is to expand the swimming pool facilities to the south which will take about a year.

Commissioner Williams offered the following Resolution and moved its adoption:

WHEREAS, All legal requirements in connection with the above-described request for rezoning have been complied with; and

WHEREAS, There have been no written or verbal protests to the request for rezoning and no one is present to protest thereto.

NOW, THEREFORE, BE IT RESOLVED, That the findings of staff be accepted and the rezoning be approved on the basis that the proposal satisfactorily complies with the Comprehensive Plan, Standards of Section 20-0906.F (1-4) and all other applicable requirements of the LDC.

Second by Piepkorn. On the vote being taken on the question of the adoption of the Resolution Commissioners Williams, Piepkorn, Sobolik and Mahoney voted aye.

No Commissioner being absent and none voting nay, the Resolution was adopted.

First Reading of an Ordinance Rezoning Certain Parcels of Land Lying in the Original Townsite Addition to the City of Fargo and Part of the North Half of Section 7, Township 139 North, Range 48 West, to the City of Fargo, Cass County, North Dakota:

Commissioner Williams moved the requirement relating to receipt of the Ordinance by the Commission one week prior to first reading be waived and that the Ordinance Rezoning Certain Parcels of Land Lying in the Original Townsite Addition to the City of Fargo and Part of the North Half of Section 7, Township 139 North, Range 48 West, to the City of Fargo, Cass County, North Dakota be placed on first reading.

Second by Piepkorn. On call of the roll Commissioners Williams, Piepkorn, Sobolik and Mahoney voted aye.

No Commissioner being absent and none voting nay, the motion was declared carried.

<u>Text Amendment to Section 20-0805 of Article 20-08 of Chapter 20 of the Fargo</u> Municipal Code Relating to the Arts and Culture Commission Approved:

A Hearing had been held by the Fargo Planning Commission on April 7, 2015 for the purpose of considering a request for a text amendment to Section 20-0805 of Article 20-08 of Chapter 20 of the Fargo Municipal Code (Land Development Code) relating to the Arts and Culture Commission and the Fargo Planning Commission at such Hearing recommended to the Board of City Commissioners that the request be approved.

The City Auditor's Office published a Notice of Hearing stating this is the time and date set for said Hearing at which time all interested persons could appear and would be heard.

There have been no written or verbal protests to the request and no one is present to protest thereto.

The Board received a communication from Assistant City Attorney Jason Loos stating the planning Commission unanimously approved a text amendment to the

Land Development Code which amends the Arts and Culture Commission membership and terms. He said the amendment removes a City Commissioner and adds an at-large member and extends the terms of the members six months.

Planning Administrator Nicole Crutchfield stated this is a staff initiated text amendment for minor edits relating to the newly appointed Arts and Culture Commission, specifically to change the membership requirements and to move term expiration dates. She said the original Ordinance had nine members, of which one was to be a current member of the City Commission; however, it is suggested by Commissioner Sobolik and the members to instead have nine citizens. Also, she said, when David Bertolini was appointed as Chair at the first meeting, it was noted his term would end in January of 2016 and they did not want to appoint a Chair for such a short term. She said with most reappointments happening around June, it is proposed the term ending dates be changed from January 1 to June 1, beginning in 2016.

Commissioner Sobolik said a new representative of the DCP will be named at their next meeting to fill a vacancy that resulted from an appointment of a member who is not a resident of Fargo.

Commissioner Sobolik moved the request be approved on the basis the proposed Text Amendment complies with Section 20-0904.E (1-3) of the Land Development Code.

Second by Williams. On call of the roll Commissioners Sobolik, Williams, Piepkorn and Mahoney voted aye.

No Commissioner being absent and none voting nay, the motion was declared carried.

<u>First Reading of an Ordinance Relating to Section 20-0805 of Article 20-08 of Chapter 20 of the Fargo Municipal Code Relating to Arts and Culture Commission:</u>

Commissioner Sobolik moved the requirement relating to receipt of the Ordinance by the Commission one week prior to first reading be waived and that the Ordinance Relating to Section 20-0805 of Article 20-08 of Chapter 20 of the Fargo Municipal Code Relating to Arts and Culture Commission be placed on first reading.

Second by Williams. On call of the roll Commissioners Sobolik, Williams, Piepkorn and Mahoney voted aye.

No Commissioner being absent and none voting nay, the motion was declared carried.

Three-year Lease with BOAS Northport Fargo LLC Approved:

Director of Finance Kent Costin said the City Assessor's Office is currently leasing office space at 404 4th Avenue North and has been at that location for twelve years. He said notice was recently received to vacate the space since the building owner will be redeveloping the property as soon as the Assessor's Office is relocated. He said this is a first in a number of chain reaction moves as a result of the Downtown flood control project. A commercial real estate agent has not been able to locate a downtown space that will meet the needs of the City Assessor's Office, he said. A location in the Northport Mall has been identified, he stated, and is currently vacant. He said the terms of the lease will be for a three-year period at a rate of \$8.00 per square foot, along with common area fees of \$2.40 per square foot. It is a large empty space and some fit up costs for additional rentals of portable partitions is being

recommended rather than permanent office walls, as well as some electrical and remodeling, he said. The City Assessor is negotiating a final agreement for the space and details of the fixed cost agreement on the sharing of the fit-up costs will be brought back with the final results of the negotiation. He said the hope is that in two or three years the Assessor's Office would be able to move into the new City Hall.

Commissioner Piepkorn said that building has been vacant for some time and suggested negotiating with the landlord for fit-up costs.

Commissioner Piepkorn moved a three-year lease with BOAS Northport Fargo LLC for the City Assessor's Office relocation, with a rental rate of \$62,400.00 per year, be approved and the City Assessor be authorized to negotiate final fit up costs needed to make the space functional.

Second by Williams. On call of the roll Commissioners Piepkorn, Williams, Sobolik and Mahoney voted aye.

No Commissioner being absent and none voting nay, the motion was declared carried.

"Yes" Vote on the FM Flood Risk Mitigation District No. 1 Voting Approved:

The Board received a communication from the Finance Committee stating the Cass County Joint Water Resource District is moving through the legal process to establish a special assessment district for future FM Diversion financing. They said as part of this process, property owners within the proposed district are voting on direct benefits, which are the amounts that have been directly allocated to property parcels. He said an indirect benefit has also been assigned and will be voted on by local government units. The need for the special assessment district, they said, is to help obtain the most cost effective borrowing process for the project. An affirmative vote of the Board on both the direct and indirect benefits is requested so those votes may be individually signed as required by law. They said a "yes" vote confirms support for establishing the district and authorizes assessments of up to \$725 million for the project. Sales tax revenues from Fargo and Cass County will be used to pay for future bonded indebtedness, they stated.

Finance Director Kent Costin said there is a tall stack of ballots waiting to be signed and returned. He said the amount of direct benefit votes total \$4,423,470.85, and the indirect votes total \$185,285,581.10. He said as part of establishing this district, the FM Diversion Assessment Committee met over the past two years to identify geographic districts and boundary lines reflective of the amount of flood mitigation risk benefit.

City Administrator Pat Zavoral said initially it was considered to assess almost down to the elevation of a parcel; however, that was too difficult administratively. Rather, he said, parcels of similar elevations were grouped together, based on LiDAR information. Properties south of 52nd Avenue have the highest degree of assessment, he said, with another degree for those north of 52nd up to I-94 and another north of I-94.

Commissioner Williams said he understands it is a back-up assessment and everyone will be in trouble in a 45 foot, 500-year flood. He said he believes more information needs to be shared with the public for their support.

Commissioner Piepkorn said the assessment is unfair. He said it appears the only people that matter in this vote are people that own property and renters have no say. Even if the public were to vote 100% "no" government can trump their vote, he

said, and it is not right to use private property as collateral. He stated he is glad it will be Mayor Mahoney's signature on the ballots for the City of Fargo and not his.

Mr. Zavoral said 50 percent of the community lives in apartments and are not able to vote as property owners, so indirect votes are built into the formula.

In response to a question from Mayor Mahoney about what other options there are to fund a diversion, Mr. Zavoral said sales tax is being used; however, a problem with that is that when selling bonds using sales tax as a backup, sales tax revenue cannot be projected out to increase the size of the bonding issue. In addition, he said, about thirty percent is taken from current sales tax for escrow so bonds can be repaid in the event there is a loss in sales tax. He said to flip that is to have special assessments as a backup. Assessment bonds use sales tax as backup, he said, and sales tax collection has been historically strong, so hopefully it will never have to be special assessed. He said this can be used as a backstop, and more and more funding methods will continue to be looked at as the project moves forward.

In response to a request from Mayor Mahoney for an explanation of certified versus noncertified assessments, Mr. Costin said certified assessments are those billed each year, while noncertified assessments such as these, are essentially levied and deferred indefinitely with sales tax being used for payment. He said Cass County would maintain a database of the assessment amounts. It is important to get funding solidified prior to borrowing large portions of bonded debt to get the project up and running, he said.

Commissioner Sobolik said there was discussion at the last FM Diversion Authority meeting about how the City and Cass County will need to enter an agreement that there will be a vote renewing the sales tax, making it clear there is a commitment to raising sales tax funds to cover the assessment. It is important the public see that the intention is for funding through sales tax, she said. One question she has received, she said, is whether the full assessment would happen if the sales tax were to come up short, for example, 10 percent short. People are concerned they may be assessed at 100 percent of their assessment, she said' however, in that example it would be at 10 percent.

In response to a question from Commissioner Piepkorn about whether a one hundred percent "no" vote from property owners could override "yes" votes by the government entities, City Attorney Erik Johnson said it is his understanding that it would not. When there is a City-wide special assessment, a 60 percent vote is needed, he said; however, this is not a City of Fargo special assessment, nor is it a City-wide assessment. He said this is a special assessment by the Cass County Joint Water Resource District.

Commissioner Sobolik moved a "yes" vote on the FM Flood Risk Mitigation District No. 1 being established by the Cass County Joint Water Resource District be approved and Mayor Timothy Mahoney be the authorized signer on the ballots for the City of Fargo and that the votes be filed no later than April 30, 2015.

Second by Williams. On call of the roll Commissioners Sobolik, Williams and Mahoney voted aye.

Commissioner Piepkorn voted nay.

The motion was declared carried.

Addition of an Incentive/Disincentive and Creation of Water Main Replacement, Street Reconstruction, Streetscape with Cycle Track and Incidentals Improvement District No. BR-15-B (NP Avenue):

The Board received a communication from City Engineer April Walker stating the Engineering Department recommends the addition of an incentive/disincentive for Water Main Replacement, Street Reconstruction, Streetscape with Cycle Track and Incidentals Improvement District No. BR-15-B. She said the project in question is scheduled for a May 20, 2015 bid opening with a substantial completion date of October 30, 2015 and a final completion date of June 1, 2016. She said staff has evaluated the project and determined that there will be four phases in order to facilitate continued access to properties located along the project. The most critical phase, she stated, will be Phase 2 which will contain underground work as well as paving associated with the mainline traffic movements for approximately 570 center line (CL) lineal feet of the reconstruction portion of the project that has a total CL lineal footage of 1,020. She said this phase is estimated to take 70 working days to complete. It is important to note that this phase does not include complete installation of all facilities, she said, for example, the cycle track will only be reinstalled where necessary to facilitate access to private property and the boulevard areas will not be reinstalled at the end of this phase. The total construction estimate for the project is \$2,020,000.00, she stated, with a total estimated project cost of \$2,527,340.00 with all Engineering and Admin fees. She said Engineering evaluated traffic volumes on this portion of NP and determined the appropriate incentive for completion of phases to be \$1,000/day, with a disincentive for days that extend the estimated working days by phase, in addition to all other applicable liquidated damages associated on the project. It is further recommended, she said, that the incentive be capped at 1% of the total construction cost or \$20,000.00.

Commissioner Piepkorn moved the addition of an incentive/disincentive of \$1,000.00/day, not to exceed 1% of the total construction cost for Improvement District No. BR-15-B be approved.

Second by Williams. On call of the roll Commissioners Piepkorn, Williams, Sobolik and Mahoney voted aye.

No Commissioner being absent and none voting nay, the motion was declared carried.
