MINUTES OF THE FARGO DOME AUTHORITY MEETING

A regular meeting of the Fargo Dome Authority was held on Tuesday, February 27, 2024 at 3:30 p.m. in the FARGODOME Conference Room with President Michael Ellingson presiding.

President Michael Ellingson called the meeting to order at 3:32 p.m.

David requested to add a discussion on Survey FARGODOME to the agenda under additional items.

Troy Goergen made a motion, seconded by David Suppes, to approve the minutes from the January 30, 2024 Fargo Dome Authority meeting. Motion carried.

Rob Sobolik presented the General Manager's report as follows:

- Year-to-Date Net Income through January 2024 is stated at -\$192,684 which is a negative variance (to budget) of \$18,373.
 - Upon review, David Suppes made a motion, seconded by Rick Steen, to approve the January 2024 financial statements as presented.

 Audited Financial Statements. Please see attached report.
 Upon review, the Finance Committee accepted a motion to approve the 2023
 Audit Report as presented.
- January 2024 Financial Statements: The January 2024 Financial Statements were approved by the Finance Committee at the meeting on February 21, 2024.
- Project and Capital Budget Updates:
 - Football Turf: AstroTurf will be back to the building in April or June 2024 to repair and straighten the turf.
 - Upcoming Capital Budget Requests: Rob noted that there would be upcoming capital budget requests, to be paid for out of the permanent fund, to purchase a new basketball floor and to replace a video wall. More information on these items to come at upcoming meetings.
- Escrow Balance & Performance Reports: The committee reviewed the escrow balance as of December 2023.

Rob noted an amendment to the 2023 Audit Report that was presented on February 21, 2024. Note 3 (Cash and Cash Equivalents) on the financial statements on page 9 of the audit was updated to include langue regarding coverage of the amount in bank deposit accounts that exceed the federally insured limits.

Rick Steen made a motion, seconded by David Suppes, to approve the 2023 Audit Report as amended.

Survey FARGODOME – David Suppes updated the group on a recommendation from FARGODOME and City of Fargo representatives to move forward with a proposed survey of Fargo citizens on their thoughts toward FARGODOME and a potential expansion and/or improvements. Prime46 would manage the survey at a cost of \$25,000. The survey would be conducted by phone and the goal would be to get 400 responses completed in 30 days.

David Suppes made a motion, seconded by Rick Steen, to move forward with the survey at a cost of \$25,000 through Prime46.
