

MINUTES OF THE FARGO DOME AUTHORITY MEETING

A regular meeting of the Fargo Dome Authority was held on Tuesday, April 25, 2023 at 3:30 p.m. in the FARGODOME Conference Room with President Michael Ellingson presiding.

Rick Steen made a motion, seconded by Troy Goergen, to approve the minutes from the March 28, 2023 Fargo Dome Authority meeting. Motion carried.

Rob Sobolik presented the General Manager's report as follows:

- Year-to-Date Net Income through March 2023 is stated at \$124,855 which is a positive variance (to budget) of \$71,618.
