# Non-Binding Agreement of Intent with the Garrison Diversion Conservancy District for the Delivery of Water Through the Red River Valley Water Supply Project Approved:

The Board received a communication from City Administrator Pat Zavoral submitting a non-binding Agreement of Intent with Garrison Diversion Conservancy District (GDCD) to enter into a water service contract for sometime in the future to deliver water in the Sheyenne River to Fargo's intake facility in that river. Mr. Zavoral stated the water will be brought from the Missouri River canal system into Lake Ashtabula reservoir and released when Fargo's current permitted water supplies are not available. He said the need for this non-binding Agreement of Intent is to allow GDCD staff to determine the quantity of water needed by water districts and communities in the 13 counties in eastern North Dakota that are members of the Lake Agassiz Water Authority and have joined together to implement the Red River Valley Water Supply Project (RRVWSP). He said determining the quantity of water will allow the GDCD staff and consultants to begin planning and sizing the water treatment and delivery system to the Valley and to solidify the cost of the project. At this time, he continued, the Agreement of Intent calls for a \$5,000 non-refundable deposit and a declaration of how much water Fargo intends to purchase. He said the Fargo staff and consultants have been involved with the RRVWSP since its inception and the projected water need for Fargo is 38 cubic feet per second which translates to about 25 million gallons a day. Mr. Zavoral stated the City's current average usage is about 9 million gallons a day in the winter months and 13 million gallons a day during the summer months. He said a feature of the RRVWSP, which is different from other state water projects such as the Southwest Water Authority sponsored project and the Northwest Area Water Supply project, is that those projects deliver treated water to each resident or business while the RRVWSP delivers raw water to Fargo's Sheyenne River intake. He said there are more treatment and delivery costs involved in delivering this water to the citizens once the water is taken from the Shevenne and this is all background information for the question as to how much the RRVWSP will cost the Fargo taxpayers. He said it appears when this project is implemented, water rates can expect to increase from \$2 to \$5 a month per household for this raw water supply project. He said staff is preparing a draft rate schedule for all of the water infrastructure needs, including the RRVWSP costs, for the next 25 years which will be presented to the Board in the very near future. Mr. Zavoral stated it is staff's recommendation to accept this non-binding Agreement of Intent and if the project cannot move forward in a timely manner, the City will have the option to withdraw. He said federal actions, such as acceptance of the Environmental Impact Statement, authorization of the project and final appropriation of the federal share of the project, will need to be implemented. He said state action needed includes additional funding allocation and permitting of the project.

Mr. Zavoral made a presentation on the flows of the Red River. He said the first phase of this project will cost \$660 million with the local share being \$220 million and the City of Fargo would pay 50% of the local share. The City Auditor's Office published a Notice of Hearing stating this is the time and date set for a Hearing on the 2009 Budget at which time all interested persons could appear and would be heard.

Mayor Walaker stated there will be no increase in the mill levy or City fees for 2009.

Lon Cooke, 1385 High Point Drive North, stated he was born and raised in Fargo and his wife and he recently returned after 50 years. He said the property tax in Fargo is double what he was paying and there is something wrong when the property taxes are at that high of a level. He said there are a lot of people who have been taxed out of their homes and something needs to be done.

Mayor Walaker stated he does take Mr. Cooke's concerns seriously and the City Commission is doing what they can to hold the line in Fargo.

Commissioner Piepkorn stated he agrees with Mr. Cooke's comments and suggested that he take his concerns to the state legislature in Bismarck this spring. He said when he was campaigning for City Commission that was the citizens' number one concern.
