# Regular Meeting: Wednesday: August 16, 2017:

The Regular Meeting of the Arts and Culture Commission of the City of Fargo, North Dakota, was held in the City Commission Room at City Hall at 5:00 o'clock p.m., Wednesday, August 16, 2017.

Chair Bertolini called the meeting to order and welcomed Members to the meeting.

## Item 1: Order of Agenda

Preston moved to approve the order of agenda. All Members present voted aye and the motion was declared carried.

## Item 2: Minutes: Regular Meeting of May 17 and June 21, 2017

Jung moved the minutes of the May 17 and June 21, 2017 Arts and Culture Commission meeting be approved. Second by Preston. All Members present voted aye and the motion was declared carried.

## Item 3: Appointment of Chair and Vice Chair

Chairman Bertolini announced that he was stepping down as chair but would remain on the Commission. He also introduced the three new Commissioners---Mark Johnson, Denese Odegaard, and Jon Offutt. New intern Brittany Rakowitz was also introduced.

Bertolini then opened the floor for nominations for chair. Williams moved to nominate Preston for chair. Second by Jung. On a voice vote, all Members present voted aye and the motion was declared carried.

## Item 4: New Meeting Time

## Item 5: Folkways Canoe Parade

Joe Burgum of Folkways presented his request to transfer the \$3,500 remaining from the grant he had received from the Commission for the Sudden Park project to the canoe parade project. Burgum presented the plan for the canoe parade and answered Commissioners questions. Crutchfield confirmed the Commission could make the requested change on its own. Below is a monthly report corresponding to the agenda items for the September 20<sup>th</sup> meeting. In lieu of creating a memo for each item, we recognize that a "report" for non-action items would be more efficient.

#### Item 3) Madison Skate Park Sculpture Update

MSUM Art Professor Brad Bachmeier was enlisted two years ago by Mary Jean Dehne, the Director of The Legacy Children's Foundation in Fargo for help in her vision of transforming a neighborhood. The goal was to figure out how art might play a role in helping to revitalize a drug-infested neighborhood park in the economically challenged Golden-ridge subdivision of Fargo into a skate and bike park where children could play safely and a community could celebrate diversity, culture and pride.

To ensure an authentic project that reflected community culture and values, Brad and his assistants conducted home visits, interviews and research while involving over 300 community members, children, artists and teachers that were enlisted to help create two large-scale brick sculpture projects and an accompanying mosaic mural. The completed park was a true public/private collaboration of the Children's Legacy Foundation, The City of Fargo, The Fargo Park and Recreation Department, Scheels Sports, Hebron Brick and many other donors.

#### Item 6) Social Media Update

City Staff has received approval to create a Twitter account for the Arts and Culture Commission. Social media is an important tool that will aid the ACC with their external communication, visual arts literacy, tourism, audience broadening, as well as, the ability to connect with local established and emerging Artists. In order to build a more unified brand for the Arts and Culture Commission, City Staff will begin the process of creating a logo which will be utilized across multiple communication platforms and outreach efforts.

## Item 7) Outreach Strategy for Public Arts Master Plan

Regarding the public outreach process, we are intending to meet with the FM Visual Artists on two occasions—with their board for a brief presentation on September 20, and with their full membership for a more detailed presentation and the annual membership meeting on Saturday, October 21. We have also contacted the school district and park district regarding which forum within their organizations is best suited for our presentation.

On June 22 the Fargo Park District and FM Convention and Visitor's Bureau (F-M CVB) announced that it was seeking visual artists for a public art piece to be located at the Fargo Park District main offices in downtown Fargo. Artists were asked to create and submit a signature design which would representative of Fargo to be transferred to a vehicle wrap placed on a railway carriage car currently located at 701 Main Avenue, Fargo. For optimal visibility and viewing, plans are in the works to shift the parking spaces to allow for lighting and improved pedestrian access to enjoy the art piece.

Working with Dayna Del Val and Tania Blanich at The Arts Partnership (TAP) a Call for Artists was created. The artwork will be exhibited for at least three years. After that time, the Fargo Park District and the F-M CVB will evaluate the project and make a determination as to the next plan for use of the trains.

The deadline for applications was July 28, 2017. Four artists submitted applications. On August 9 representatives from the Fargo Park District, F-M CVB and TAP met to review the applications. The four artists that submitted applications were Chris Coen, Jeff Knight, Star and Steve Knutson. Steve Knutson was chosen.

The Park District asked for estimates from local sign companies to install the artwork. Office Sign Company was chosen to do the installation. Currently the artist is completing the final watercolor piece to be transferred to a digital format and then lighting and improved pedestrian access is still in the design phase and is expected to be installed in the spring. The expected installation date for the artwork is the beginning of October.
