The Regular Meeting of the Arts and Culture Commission of the City of Fargo, North Dakota, was held in the Commission Chambers at City Hall at 5:00 p.m., Wednesday, October 16, 2019.

Chair D. Williams called the meeting to order and welcomed Members to the meeting.

Item 3 presented

Item 1: Order of Agenda

Member Odegaard moved to approve the Order of Agenda. Second by Member J. Williams. All Members present voted aye and the motion was declared carried.

Item 2: Minutes: Regular Meeting of August 21, 2019

The City of Fargo Arts and Culture Commission (ACC) is currently accepting qualifications for a light installation piece along a gateway, common place, or passage in Fargo, North Dakota. This public art opportunity is for an artist or team of artists to design, fabricate, and install public art with an emphasis on light elements that is integrated into the public infrastructure, with a specific focus of co-creation with the Fargo community. The ACC is committed to integrating art in public spaces, supporting local artists, and bringing quality art and creative expression to the Fargo Community.

Funding: A competitive stipend and supply budget will be awarded to the successful applicant.

About Fargo

With a population of 122,359, Fargo is the most populous city in North Dakota and is the core city of the Fargo-Moorhead, ND-MN Metropolitan Statistical Area, which contains an overall population of 241,356. The City of Fargo serves as a regional economic hub for the Upper Midwest with a robust and diverse economy having specific strengths in the medical, agricultural, education, entrepreneurial, and retail industries. Arts and Culture Commission

In 2015, the City established its first Arts and Culture Commission (ACC), an outgrowth of the City's in-depth Go2030 comprehensive planning effort adopted in 2012. The Arts and Culture Commission makes recommendations to the Fargo City Commission regarding public art investments by the City and encourages participation in public art by all citizens, developers and property owners. Since its inception, a major goal of the ACC was to develop a master plan for the City's growing public art program. The Arts and Culture Commission is



committed to increasing the City of Fargo's access to the creation of public art, and works to expand and facilitate arts development, provide opportunities for local and emerging artists and promote the creative capacity of Fargo.

Public Art Master Plan

Fargo's Public Art Master Plan was approved in 2016, and was designed as an actionable tool that provides a road map for the City Commission, the ACC, City departments, program staff, artists, community stakeholders, and others interested in helping grow the future of Fargo. The plan establishes priority goals and objectives and clarifies the ACC's role with both City-generated art and community generated art.

Fargo's public art plan recognizes the importance of balancing the leadership of City-initiated projects with nurturing grassroots efforts developed by individuals, neighborhood groups, local businesses and others seeking to enhance the public realm. The ACC annually supports City-generated public art, including: public art planning, policy development, and program management; visual art displays in City buildings featuring local artists; commissioning of artworks for public spaces in the city; and granting funds to artists for independently-developed projects. The ACC also responds as needed to community-generated art, requests and proposals from private groups, city agencies and others.

Five themes are identified within the plan to identify what public art should aspire to address in the community. The themes include:

- The City on the Great Plains
- Embrace Water and Seasonality
- Water Appreciation
- Celebrate the River
- Nurture Emerging Cultural Diversity

Public Art Program

The mission of Fargo's Public Art Program is to implement the Public Art Master Plan, ensuring the City's ongoing commitment to encouraging and supporting the growth of diverse, high-quality and meaningful public art throughout the City of Fargo. The master plan includes 10 goals:

- Continue developing current projects
- Build the capacity of the ACC and the effectiveness of the Public Art Program
- Provide adequate care and maintenance for City-owned public art
- Establish a clear and easily accessible process for artists and the private sector
- Identify and secure permanent funding and support systems for public art
- Ensure that public art is citywide
- Pursue artistic excellence
- Cultivate partnerships
- Establish incentives for developers
- Focus on site of opportunities as outlined in the plan

The master plan articulates that it is critical to honor this commitment through the lens of the following guiding principles:



- Citywide and regional mindfulness
- Equity, Fairness and Transparency
- Cultural Diversity: people of color, new immigrants and indigenous peoples
- Education and Lifelong Learning

About This Opportunity

After the completion of the Public Art Master Plan, funds were set aside to implement the plan through a public art project. A committee was formed to determine a process for the project. One of the first efforts was to engage the community through one-on-one interviews and a public art survey to seek input to guide public art projects.

Based on the results of the public art survey (provided in a link below), the committee determined this first project would be a light installation project that is integrated with public infrastructure. A concept developed with the possibility to expand on the type of infrastructure throughout the City would be of interest. This project will require collaboration and coordination across several fields—art, design, engineering, construction — with style and function being equally important.

The project must be designed to fit the context of the site, with a table of locations below of the themes of Gateways, Places and Passages. See additional information below.

The light installation piece must be co-created with the community, and engage the community while simultaneously respecting the history and culture of Fargo and the Upper Midwest. Functionally, the piece must be durable, as it will be installed in a high-traffic location that is exposed to extremes of weather and other stresses, and is expected to function over a 20-year lifespan.

Attached is a list of project considerations, which is intended to be a guide and not all inclusive of all aspects related to a project.

Possible Site Locations

Below are several locations identified with the themes of Gateways, Places and Passages. These locations were identified as possibilities as they target high traffic areas and are signs of welcoming to our community as over thousands of people interact with these locations a day. The artist might find other locations that also meet their needs. The artist is to select the final location with approval from the City of Fargo.

Gateways

- Broadway and Main Avenue intersection
- 2nd Street and Main Avenue intersection
- 2nd Street North Underpass (just north of Main Avenue)
- Pedestrian Bridge over Interstate 94
- Interstate exit/entry ramps
- Hector International Airport

Places

- Roosevelt Park
- Island Park
- Block 9 Plaza (Downtown Fargo)



- Civic Plaza (Downtown Fargo)
- Fargo-Moorhead Convention and Visitors Bureau Center
- West Acre's Mall
- Wet side of floodwalls
- Development in South Fargo

Passages

- Shared use paths and bridges
- Downtown underpasses
- Downtown bridges
- Skyway system (Downtown)
- Underpass near West Acres (Interstate 29)

Selection Process Overview

Artists' submissions will be pre-screened to ensure all applicants meet eligibility requirements. A selection committee will select a group of up to three finalists/finalist teams to invite to Fargo for an interview (phase 1). The selection committee may elect to conduct short phone interviews with select artists in order to further evaluate proposals prior to selecting finalists. Finalists will be offered a \$1,500 stipend to travel for an interview. The committee's recommendations will be forwarded to the City Commission for final action. Upon approval, one artist/artist team will be commissioned to develop, fabricate, and install a permanent artwork. Please see the following timeline for further details.

As part of the capacity-building focus of the ACC's mission, the artist or artist team selected will be asked to mentor an emerging artist from the local community throughout the design and construction process. Depending on the artist or artist team's location, these may be a mix of virtual and in-person interactions. The City of Fargo sees this aspect of the project as vital to developing our local artist community and providing opportunities for aspiring, young artists.

Eligibility

- Must have completed two commissioned outdoor public works of \$75,000 or more
- Must have an understanding of light/lighting systems
- Must have a history of projects that include light/lighting systems
- Must have a history of working with communities and/or neighborhoods
- Must be able to come to Fargo for an interview

Selection Criteria

Phase 1: Selection of finalists will be based on the following criteria:

- Quality of letter of interest
- Quality of work samples
- Demonstration of inspiration and/or knowledge of Fargo community
- Ability of artist(s) to complete project based on bio and prior work experiences
- Ability and willingness to include a local artist (if applicant not local) for capacity building



Phase 2: Selection of proposal by finalist(s) will be based on the following criteria:

- Community engagement and co-creation process (please address this criteria in letter of interest)
- Respect for the history and culture of Fargo
- Showcases light as a major component of the piece
- Interactive and engaging
- Distinctive and attractive in daylight and at night
- Ability of piece to be designed within the context of the site
- Must be low maintenance and durable, and able to withstand extreme weather conditions
- Fabrication method that minimizes maintenance and allows repair/replacement of components as required

Submissions

Artists are to submit an electronic version of the proposal to the City via the following URL: [insert URL]. Submittals must be submitted by [date and time]. Proposals received later than the time and date specified will not be considered. Proposals must provide the following:

- Contact information for lead artists and all team members
- One-page letter describing interest in project and approach to design; please include statement addressing eligibility criteria and community engagement
- Three references [contact information only] for recently completed projects
- One-page biographical information or resume. If you have multiple team members, please keep biographical information for each team member to one paragraph.
- One-page document listing each work sample. Please provide a brief description and budget for each
- Work samples: up to 10 digital images of your recent projects. Save all images as standard JPEG files and label each with applicant's name and number in sequence with list of work samples.

Project Considerations

The following are items to consider as a project is planned. It is intended to be a guide and is not all inclusive of all aspects related to a project.

Location

- Private Property
- Public and right-of-way
 - Be aware there are ordinances and requirements that pertain to the right-of-way.

Stakeholder Coordination

- Neighborhood Associations, including the Downtown Neighborhood Association
- City Departments (Engineering, Public Works, Planning and Development, etc.)
- Fargo Police and Fire Departments
- The Fargo Park District
- North Dakota Department of Transportation



- State and Federal Jurisdictions
- Utility Providers

Site Conditions

- Impact: Consider the impact the project may have on neighbors.
- Lighting: Consider location of electricity; if electrical permit is required; include all associated costs.
- Water: Consider location of available water and feasibility of getting water to project; consider the impact of storm and rain water on the project.
- Maintenance: What is the maintenance for the project; who will maintain it and how will it be maintained; what is the expected cost of maintenance;
- Weather: Consider the unique weather of our area, such as temperature, humidity, wind, precipitation and other environmental conditions.
- Red River/Storm Basins: Consider the unique water conditions of our area, such as river flooding and basins.
- Durability: What is the lifespan of the project; is the project susceptible to vandalism?

Logistics

- Does the project need to be secured to the site or ground; are soil excavation or footings needed;
- Professional Designer: Does the project require a professional, such as structural engineer or other;
- Permits: Does the project require any permits from the City of Fargo, such as building, electrical, plumbing, erosion control, allowances in the right-of-way, etc.?
- Insurance: Will the project need insurance coverage?
