1. Introduction


The 2016 Fargo Community Development Action Plan addresses the City's allocation of \$1.06 million in Federal funds for the purpose of furthering the creation and retention of affordable housing, revitalizing blighted areas, and assisting low-income households and neighborhoods.

The activities included in this Action Plan address priority needs in the areas of housing, homelessness and non-housing community development. Specific goals focus on affordable housing, homeownership, homelessness, neighborhoods, employment, transportation, fair housing/diversity, and poverty reduction.

Over the years, the City of Fargo has exhibited a commitment to these issues in previous action plans and has demonstrated capacity in successfully implementing the proposed projects. The 2016 Annual Action Plan outlines the City's approach to sub-recipient and self-monitoring, which includes regular file monitoring and periodic on-site visits to assisted projects.

The City of Fargo is a Community Development Block Grant (CDBG) entitlement community and a HOME Participating Jurisdiction. This plan will address the following topics related to the use of CDBG and HOME funds in the City of Fargo in the 2016 program year (May 1, 2016 to April 30, 2017).

- Source of Funds, including expected grant and program income receipts
- Specific Consolidated Plan Objectives met by 2016 activities
- Summary of 2016 budget and programmatic expenditure limits

4. Summary of Citizen Participation Process and consultation process

Summary from citizen participation section of plan.

The City of Fargo provides citizens, public agencies, and other interested persons with reasonable and timely access to information and records relating to housing and community development plans and programs and the use of housing and community development funds. There is open access to all meetings, and documents related to Fargo Housing and Community Development programs are made available upon request.

A public meeting was held on November 19, 2015, seeking community discussion on needs and priorities. An advertisement was published in *The Forum* newspaper, information was posted on the City's website, and 125 notices were mailed to individuals, community agencies, and nonprofit groups. On January 7, 2016, another public meeting was held with the Community Development Committee to

give residents an opportunity to discuss needs and priorities. A draft 2016 Action Plan was made available and a 30-day comment period gave citizens, public agencies, or other interested parties an opportunity to provide input. The 2016 Action Plan was presented at a public hearing to the Fargo City Commission on February 29, 2016 in the Commission Room at Fargo City Hall.

Citizens of Fargo are encouraged to participate in the development of housing and community development programs and plans. This participation is of great use to the City in identifying community development needs, assessing the effectiveness of ongoing programs, and developing housing and community development priorities. Citizens are also encouraged to participate through organizations. Participation by low and moderate income persons, residents of blighted areas, residents of predominantly low and moderate income neighborhoods, minority populations, non-English speaking persons, and persons with disabilities is especially encouraged. The Community Development division maintains a database which is made up of hundreds of organizations representing these groups and individuals. Staff also attends gatherings of community groups, neighborhood organizations, and ethnic and senior communities. When the Planning and Development Department is notified that a significant number of non-English speaking persons are interested in participating in a community development meeting, contacts are made to obtain translation assistance. Information is also distributed to persons and organizations with an interest in housing and community development through direct mail to stakeholders, public meetings, newsletters, City's website, brochures, and news media.

5. Summary of public comments

- Individuals and families in Fargo are facing housing cost burdens, especially for those earning 30% and below Average Median Income.
- The City is becoming more diverse and social infrastructure is growing. This includes community groups, neighborhood organizations, ethnic communities, and senior communities.
- There is concern about vulnerable neighborhood areas and crime.
- More communication is needed to help community programs, as well as housing and service providers, anticipate the needs.

 Housing tax credits are a powerful resource. Support for the ND Housing Incentive Fund and Federal Low Income Housing Tax Credits offers additional affordable housing resources and leverage. Specific populations in need include low-income elderly populations, people with

- disabilities/special needs, workforce populations and families, as well as individuals and families that are homeless or precariously housed.
- There are declining resources to support public housing facilities. Although the housing voucher program is stable, available units with rents low enough to use the vouchers are needed.
- Land is needed to support future affordable housing development.
- There is a service gap for housing case management, specifically for people with mental illness. Housing units are available, but the shortfall appears to be in case management and supportive housing services. The Landlord Risk Mitigation program is proving to be a successful solution.
- There is a growing need for services and secure buildings to ensure safety for people escaping domestic violence situations.
- There is a need for more awareness of where to go to connect to services.
- More affordable childcare solutions are needed.
- Affordable transportation options are needed.
- Continue to address the needs of veterans in the local homeless population, specifically those dealing with mental health, substance abuse, and addiction.
- It is difficult to find people to work in areas related to housing, community development, nonprofit and support services.
- Cultural understanding, meeting the needs of diverse people, creating a welcoming atmosphere, and support for coalitions of Native American and New American groups.
- There is a need for more neighborhood centers.
- Fargo has a low vacancy rate, growing labor force, and accelerating K-12 school enrollment projections.

A five-member City Commission governs the City of Fargo. All of the Commissioners are elected at large and serve four-year terms.

The Community Development Committee recommends the specific allocation of funds and oversees the administration of community development programs for the City of Fargo. The City Commission appoints this Committee. The Committee consists of eight voting members, which include two City Commissioners, City Administrator, Planning Commission Chair, three at-large community representatives, Housing Authority Director, and a member of the Fargo School Board. Ex officio members include representatives of the United Way, Home Builders Association, and Downtown Community Partnership. All budgetary decisions are made final at the City Commission level.

The Fargo Housing and Redevelopment Authority (FHRA) is governed by a five-member Board of Directors, which is appointed by the Mayor and confirmed by the City Commission.

The Department of Planning and Development is the lead agency in the implementation of the City of Fargo's community development program. The above public entities work in cooperation with various non-profit, public and private entities to further the goals of Decent Housing, a Suitable Living Environment, and Expanded Economic Opportunity.

1. Introduction

For the development of this Action Plan, the City of Fargo followed its Citizen Participation Plan by distributing information that outlines the community development planning process to persons and organizations in the community. The Division of Community Development sent a notice to 125 organizations and individuals for the November 19, 2015 meeting requesting public input on the preparation of the Action Plan for Housing and Community Development. Information was also posted on the City's website.

On January 7, 2016, the Community Development Committee reviewed the Annual Community Development Action Plan with funding levels for projects and programs and made a recommendation to the Fargo City Commission. Notification of the Action Plan was published in *The Forum* newspaper, distributed to persons interested in housing and community development and the news media, and posted on the City's website (www.cityoffargo.com). The notice explains the contents and purposes of the plan, locations of where it is available for review, and how to obtain a copy. The City also provides a reasonable number of free copies of the Action Plan to citizens or groups that request it.

There was a 30-day period given for public comment on the proposed Plan. On February 29, 2016, the City Commission held a public hearing on the proposed Plan, at which time the Commission reviewed and considered all comments received during the public comment period and at the public hearing. The City Commission approved the Annual Community Development Action Plan and directed it to be submitted to HUD.

The City of Fargo works closely with the Fargo Housing and Redevelopment Authority, which is authorized to allocate Federal government resources to address the housing needs of the City's lowest-income households. The City also has ongoing relationships with housing providers working on housing development activities (CHDOs and non-CHDOs). Through support and engagement in the ND Continuum of Care process, the local Coalition for Homeless Persons, and other supportive housing collaborations, the City maintains relationships with mental health providers, homeless shelter and service providers, and other governmental agencies with specific responsibilities to assist homeless individuals and families. In addition, the City participates in a variety of other coalitions that seek to address issues that relate to housing and service needs.

Describe coordination with the Continuum of Care and efforts to address the needs of homeless persons (particularly chronically homeless individuals and families, families with children, veterans, and unaccompanied youth) and persons at risk of homelessness.

City staff works actively with the North Dakota Continuum of Care and local Homeless Coalition through the City's Department of Planning and Development, the City-operated Gladys Ray Emergency Shelter and Veteran's Drop-In Center, as well as a number of local nonprofit housing, shelter and support partners. Staff participates in regularly scheduled meetings and point-in-time surveys. The City also provides administrative and general fund support to supplement Continuum of Care initiatives in Fargo and the State of North Dakota.

Staff from the City participate in the development of the Continuum of Care, working with area service providers, to include City resources and HMIS reporting in the provision of service to homeless individuals and families in Fargo. In addition, the City is represented on and attends meetings of the ND Governor's Interagency Council on Homelessness, which works to track and report activities in ND's 10 Year Plan to End Long-Term Homelessness.

1. Summary of citizen participation process/Efforts made to broaden citizen participation Summarize citizen participation process and how it impacted goal-setting

Stakeholder participation is central to the City in identifying community development needs, assessing the effectiveness of ongoing housing and community development programs, and developing community development priorities. The City of Fargo published a public notice in *The Forum* announcing the availability of the 2016 Action Plan for review.

The Community Development Committee gathered input in the months leading up to submission of the Plan. The list of consultations in the Consultation section represents the formal contacts made to gather information and to further coordination of program delivery. The City Commission held a public hearing for the Plan on February 29, 2016. The plan was made available to the public on the City's website at cityoffargo.com and in paper format.

It is important to use all available methods to determine community development needs, assess effectiveness of existing programs, and develop community development plans. The City of Fargo obtains citizen input through conversations with people, consultation with housing and service providers, and adjacent units of local government, in an effort to better ascertain Fargo's community development needs.

Prior to the solicitation and selection of the 2016 community development projects, a series of meetings were held. Staff met with representatives of area municipalities and local governments, community-based organizations, in addition to service and housing-related agencies to encourage citizen participation. A citywide public input meeting was held to inform the public about the CDBG and HOME programs, community development assets and needs, types of projects eligible for funding, and the process for selecting projects. The low-moderate income population in Fargo is not in one concentrated area. For that reason, the public forum and hearings were held downtown, which include the City's Census Tracts and Block Groups that contain the most sizable population of very-low and low-income residents.

Upon becoming a HOME Participating Jurisdiction, the City of Fargo became responsible for documenting appropriate match in conjunction with receiving HOME funds. For the 2015-2019 Consolidated Plan, \$100,000/year in matching fund liability is anticipated. The sources of match will include homeowner contributions and local payments in lieu of taxes. The City also anticipates \$50,000/year in HOME program income.

Additional funding that is expected to be available during the next five years includes the Public Housing Capital Fund, Section 8 Vouchers, City General Social Service Funds, and PILOT and Capital Bonds.

The City regularly applies for competitive federal, state, and foundation grants when it meets the application criteria, as do many non-profit and for-profit organizations. However, the nature and amount of such funding is unknown at this time.

Annual Action Plan 2016

If appropriate, describe publically owned land or property located within the jurisdiction that may be used to address the needs identified in the plan

The City will consider the use of publicly-owned land for the construction of affordable housing for low-to-moderate income households.

Discussion

In 2016, the City will use CDBG and HOME in partnerships to leverage private, state and local funds to address goals and strategies outlined in Fargo's Consolidated Plan. The City will also continue to identify strategies to be used for a variety of activities with respect to affordable housing and community development.

Describe the reasons for allocation priorities and any obstacles to addressing underserved needs

The 2016 Action Plan attempts to allocate funding across a range of projects, to ensure that community development efforts are comprehensive. Fargo neighborhoods have diverse needs and funding is dedicated to many different types of projects to make a difference. This includes housing rehabilitation, fair housing activities, facility improvements, infrastructure assistance, and public services. HOME funding is used for owner-occupied housing rehabilitation and multi-family construction.

Over the next year, the City will work to support low and extremely-low-income households by focusing community development efforts on working comprehensively in neighborhoods that contain some of the City's most vulnerable populations. By working comprehensively to revitalize entire neighborhoods, the City plans to use funding as effectively as possible. The Community Development Division will also work to increase its capacity to effectively partner with local nonprofit, public, and for-profit organizations to identify emerging community needs and resources.

The primary beneficiaries of all listed projects are low/moderate income households in the City of Fargo. In Fargo, most of the low/mod areas are concentrated in the core of the City, which are also some of Fargo's oldest neighborhoods. Approximately 65% of the budgeted funds are targeted to the low/moderate income areas.

The City's strategy for prioritizing community development activities is to target neighborhoods that are low/mod, where affordable housing is available, and that are older (developed pre-1920).

These neighborhoods typically share a number of characteristics that warrant community development interventions. There are opportunities for comprehensive neighborhood planning efforts that identify issues in a strategic way while at the same time empowering residents to act in concert with the City to address those needs. The housing stock is generally in good condition but is in need of reinvestment/improvement. Oftentimes, residents' concerns about safety and public service provision are beginning to emerge. It is at this point that the City feels it can be most effective in using community development resources to affect the lives of the citizens of these neighborhoods as well as the quality of life in the community as a whole.

The Fargo Housing and Redevelopment Authority (FHRA) and City continue to address the needs of its public housing inventory and encourage residents to be involved in its operations.

Actions planned during the next year to address the needs to public housing

In Fargo, there are 13 affordable housing properties providing rental assistance to 789 very low income households. In addition, Fargo Housing And Redevelopment Authority provides 1,294 Section 8 rental vouchers. The FHRA meets the needs of its tenants through regular physical, operational, and management improvements, which are listed in its Five-Year Agency Plan and annual updates. The FHRA is engaged in efforts to improve its housing stock and the overall living environment for residents. The Lashkowitz High Rise is an example of this endeavor. The Lashkowitz project is in its planning phase to improve the overall condition of affordable units in the City and meet the long-term needs of tenants.

Actions to encourage public housing residents to become more involved in management and participate in homeownership

The FHRA works to engage, educate, and empower residents by providing opportunities for personal development, economic stability, education, health, and fostering family and community life.

If the PHA is designated as troubled, describe the manner in which financial assistance will be provided or other assistance

Not applicable. The FHRA is not designated as troubled.

AP-65 Homeless and Other Special Needs Activities – 91.220(i) Introduction

Homelessness encompasses a population that is elusive, hidden, highly mobile, and characterized by diverse and complex circumstances. In order to identify the needs of persons who are homeless in Fargo, the City works closely with the local homeless coalition, service and housing providers, as well as the ND Coalition for Homeless People, which manages the Continuum of Care and Homeless Management Information System (HMIS) for North Dakota.

Describe the jurisdictions one-year goals and actions for reducing and ending homelessness including

Reaching out to homeless persons (especially unsheltered persons) and assessing their individual needs

The City Planning Department continues to be involved in local and statewide Continuum of Care efforts and regularly provides CDBG funds to support the planning process. In addition, the Planning Department continues to move forward with the goals and objectives of Fargo's "10-Year Plan to End Long-Term Homelessness", which brings together public and private partners from the metropolitan area to craft a local strategy for addressing the needs of this homeless population. Funds are set aside in the 2016 budget to support project ideas that have come out of that process (Project #5).

Addressing the emergency shelter and transitional housing needs of homeless persons

CDBG funds will be utilized to provide operating support at Fargo's Gladys Ray Shelter, which serves the Fargo homeless population. The 2016 Action Plan also includes funding a homeless liaison position within the Fargo Police Department and funds to assist with supportive housing and shelter facility improvements. In addition, Project HART in Fargo is a transitional residential facility/program for veterans that are homeless. It provides housing for 48 individuals.

Helping homeless persons (especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth) make the transition to permanent housing and independent living, including shortening the period of time that individuals and families experience homelessness, facilitating access for homeless individuals and families to affordable housing units, and preventing individuals and families who were recently homeless from becoming homeless again

Veterans Manor provides permanent housing for Veterans, and contains 8 apartments. The Cooper House Apartments consist of 42 units designed to provide permanent supportive housing for people

who are coming out of homelessness.

Helping low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who are: being discharged from publicly funded institutions and systems of care (such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions); or, receiving assistance from public or private agencies that address housing, health, social services, employment, education, or youth needs.

As part of Fargo's 10-Year Plan to End Long-Term Homelessness, the City plays an important role in supporting emergency solutions for persons experiencing homelessness and prevention strategies to keep people from becoming homeless in the first place. The City operates the Gladys Ray Shelter and Veterans Drop-In Center and supports a homeless liaison position within the Fargo Police Department. These efforts, in addition to general fund and human resource support to local shelters, service and housing providers are key to addressing the needs of individuals entering and exiting the criminal justice system; working to incorporate housing into the discharge planning being done by healthcare facilities; and identifying solutions to address concerns of youth homelessness and kids aging out of foster care. This work is critical toward ensuring that the issue of homelessness is addressed along a community-wide continuum of prevention and intervention strategies.

AP-75 Barriers to affordable housing – 91.220(j)

Introduction:

The 2016 Action Plan demonstrates significant support for the maintenance and creation of affordable housing in the community.

Actions it planned to remove or ameliorate the negative effects of public policies that serve as barriers to affordable housing such as land use controls, tax policies affecting land, zoning ordinances, building codes, fees and charges, growth limitations, and policies affecting the return on residential investment

The Housing Rehab program helps remove significant barriers to affordable homeownership by assisting with critical repairs and maintenance to Fargo's existing housing stock, much of which is considered affordable housing. The Action Plan also includes funds to assist homeowners with special assessments levied for infrastructure repairs near their home. Direct efforts to remove barriers to affordable housing include assistance with the development of affordable senior housing with the HomeField Senior Housing apartments at 4245 28th Avenue South.

The City of Fargo has worked to address the problem of increased foreclosures in the area through the Neighborhood Stabilization Program (NSP), which was authorized by Congress under Title III of the Housing and Economic Recovery Act of 2008. Fargo received over \$5 million to acquire and redevelop foreclosed and abandoned properties that might otherwise have become sources of abandonment or blight. The NSP funds have been an excellent source of funding to address increasing numbers of foreclosed or vacant properties. The funds allocated to the City have been obligated and spent; however, approximately \$395,000 in program income remains and can be utilized to address foreclosures and abandoned property. Additional program income may be generated during 2016.

AP-85 Other Actions – 91.220(k)

Introduction:

The City will undertake, or support the efforts of other agencies that meet the needs of low-income persons and households.

Actions planned to address obstacles to meeting underserved needs

The City will work with funding agencies, including Cass County, United Way of Cass-Clay, FM Area Foundation, Dakota Medical Foundation, and the Impact Foundation to coordinate and meet the needs of the community.

The City will seek opportunities to increase funding available for affordable housing.

The City will work to inform lenders and households regarding Fair Housing laws, and in particular, to encourage greater participation by minorities and ethnic groups disproportionately represented in homeownership.

Actions planned to foster and maintain affordable housing

Most of the City's affordable housing inventory is owned and managed by non-profit housing providers. There is little risk that projects will be lost from the affordable housing inventory. Regardless, the City will work with these providers when time comes to ensure continued viability of the housing.

The City will work with homeowners and owners of private multifamily rental units to identify obstacles and opportunities for rehabilitation and preservation.

Actions planned to reduce lead-based paint hazards

All housing rehabilitation efforts on homes that were built before 1978 will include lead-based paint hazard evaluations. All hazards will be addressed, either through abatement or interim controls to minimize the hazards.

The City will continue to provide educational information about the hazards of lead-based paint.

Actions planned to reduce the number of poverty-level families

The City continues to support the efforts of nonprofit and public agencies that work to reduce the

number of families living in poverty.

Actions planned to develop institutional structure

The City is a partner in identifying ways to coordinate and improve the effectiveness of the institutional systems, housing and community development needs.

The City will continue to work with all housing and human service agencies to coordinate and improve communications. The Community Development Committee is one mechanism for hearing issues and addressing ways to improve the service delivery and housing system in Fargo.

Actions planned to enhance coordination between public and private housing and social service agencies

The City will continue to support the efforts of housing and service agencies in the community. Fargo continues to expand its representation and presence with housing, social and human service agencies. Last year, the Community Development Committee oversaw the development of the 2015 Fargo Housing Study. Around the same time, a Workforce Study was completed by the Fargo Moorhead Economic Development Corporation. The available data was instrumental in the creation of a Build Housing Workgroup, which includes multi-sector representation from the region and focuses specifically on attainable housing to support upward mobility for people in low-wage, basic skill jobs. The result has contributed to the coordination of public and private housing organizations in Fargo's annual action plan through partnerships to develop employer funded housing, tenant and homebuyer education (which the Village Family Service Center stopped offering in 2015), create a regional housing trust fund, and support local and statewide housing programs and policies.

All HOME funded projects in Fargos 2016 Action Plan are subject to the recapture provision, as opposed to the resale provision. The HOME CHDO project is required to follow the Citys recapture policy.

3. A description of the guidelines for resale or recapture that ensures the affordability of units acquired with HOME funds? See 24 CFR 92.254(a)(4) are as follows:

All HOME funded projects in Fargos 2016 Action Plan are subject to the recapture provision, as opposed to the resale provision. The recapture option follows the provisions in 24 CFR 92.254(a)(5)(ii), which allows for recapturing the HOME investment based on specific criteria that are established within the Citys Recapture Policy. Only direct subsidy to the homebuyer is subject to recapture. The provisions do not limit the amount to be recaptured based on net proceeds available from the sale. Any recaptured funds must be used to carry out eligible HOME activities. In the case of CHDO proceeds, the City of Fargo permits Beyond Shelter, Inc. to retain any CHDO proceeds resulting from the HOME investment with the condition that the proceeds be used to develop additional affordable housing in the City of Fargo (24 CFR 92.3000(a)(2)). In addition, all CHDO proceeds and uses will be reported to the City.

4. Plans for using HOME funds to refinance existing debt secured by multifamily housing that is rehabilitated with HOME funds along with a description of the refinancing guidelines required that will be used under 24 CFR 92.206(b), are as follows:

Fargo does not intend to use HOME funds to refinance existing debt that is secured by housing that is being rehabilitated with HOME funds (as per 92.206(b)). The City will use only the forms of

investment described in 24 CFR 92.205(b) (grants, deferred payment loans, non-interest bearing loans).

For HOME ownership projects in the City, the after rehabilitation value will not exceed 95% of the median purchase price in the area. The 95% is based on the Citys assessed value and is stated in the Housing Rehab program policy.



CDBG/HOME Public Meeting City of Fargo 2016 Action Plan November 19, 2015 – 3:30 p.m.

Dan Mahli, Community Development Administrator, reviewed graphs from a recently completed Fargo Housing Study. He stated the population growth is being driven by youth and seniors. He spoke about three (3) factors that stand out related to housing in Fargo: accelerating population growth, high amount of housing construction, and disparity between rental and home ownership. Mr. Mahli highlighted a few of the study's findings and recommendations including: a low vacancy rate, the need for affordable homes as the labor force grows, accelerating K-12 school projections, and homeownership rate disparities for Native American and Black/African American households.

Mr. Mahli reviewed the Housing and Community Development in Fargo handout findings, needs assessment, and Community Development goals and objectives. He stated Fargo anticipates receiving a total of \$1.2M in 2016; \$660,000 in CDBG funds, and \$300,000 in HOMF funds to be used for the housing rehab program to preserve housing stock as well as rental projects. Mr. Mahli stated the City Social Service Fund, which has recently been separated from the City Art Fund, totals \$250,000.

Dan Mahl said Fargo is relatively affordable, but there is a burdon on families carning 30% and below Average Median Income (AMI). He spoke about the community noting the diversity, as well as the makeup of the social infrastructure which includes community groups, ethnic communities, and senior communities.

Robin Nelson, Boys & Girls Club/Fargo Youth Commission, stated although Fargo is ranked as 17th in the nation for affordable living, there is an issue for those earning 30% and below Average Median Income (AMI) to find affordable housing.

Julie Gunkolman, CHARISM, mentioned the new crime element in the city. She said in the Jefferson/McCormick Park neighborhood, their tasks are getting harder. She noted the Countryside Trailer Court is being cleaned up a bit by some of the poor condition homes being removed. She voiced concerns over the vulnerable, troubled neighborhood and requested the city pay special attention to the area. She feels the City needs to invest heavily on the front end to make it once again a safe, whole neighborhood. Julie said this neighborhood is full of diversity and a lot of opportunity. She stated the need to use this neighborhood in a positive way, Julie noted the Police Department now has community trust officers out in the community. Dan Mahli noted City staff will work with Jefferson neighborhood residents this spring/summer to create a Jefferson neighborhood plan through a series of coordinated meetings and conversations. He stated possible topics of discussion could include street lights and safety.

Robin Nelson commented about a topic of recent discussion at a schoolboard meeting. She said as housing becomes subsidized, it brings a large influx of lower income people to an area, which in turn affects the Boys & Girls Club/Fargo Youth Commission programs. She stated her dealre for more communication to help community program.

CDBG/HOME Public Meeting

providers anticipate these needs. Ms. Neison asked if other agencies are finding service needs in the community are growing.

Brian Arett, Valley Senior Service, stated the demand for their services are growing as the population ages, which puts pressure on the agencies providing the services.

Dan Madler, Beyond Shelter, inc., stated the need for affordable housing is huge and noted the amount of households that would qualify for the housing provided far outweigh the number svailable.

Julie Haugen, YWCA, echoed the trouble in finding affordable housing for their clientele.

Arry Nash, FM Coalition for Homeless Persons, noted the obstacle is not only getting individuals into housing, but also breaking down barriers. She stated the need for more innovative approaches.

Shirley Dykshoom, Lutheran Social Services of North Dakota, talked about the need for homeownership initiatives offered to different effinic populations and asked how minority homeownership could be increased. She said those new to homeownership need to engage with partners who have the skills and tools to educate. Dan Mahli addressed Ms. Dykshoom's question by saying service providers need to connect with committees and groups such as Daughters of the Earth or the Native American Commission. He said ideas need to come from the community. He said there are opportunities for creative housing types in redevelopment areas and noted it is hard to build new, affordable housing in growth areas where special assessments are high. He noted the GO2030 Comprehensive Plan focuses on walkable communities with mixed use centers.

Cody Schuler, FM Coalition for Homeless Persons, questioned what is being done to bring private sector resources to the table. Dan Mahli stated resources such as these could be used to support or leverage private/public properties.

Dan Madler spoke about his experience with using housing tax credits, saying it is a powerful resource.

Dan Mahli concluded the meeting by stating there is need for more affordable housing.

Housing and Community Development in Fargo

An examination of community characteristics helped identify briefly needs that should be addressed with community development funds.

AFFORDABILITY

The City of Pargo and surrounding communities are fortunate to have a cost of living that is low compared to most other urbanized areas. However, a more in depth examination of the personal economic picture of area becaseholds would reveal affordability concerns for the lower income portion of the population. Certain segments of the population de face significant affordability issues. Most rental households earning less than 30 parcent of area median income face a severe cost burden. And, for homeownership to remain within reach for households earning less than 120 percent of area median income, new construction of affordable concernoccupied housing is needed.

HOMEOWNERSHIP

Homeownership rates in Fargo are low. The City is likely to have a low homeownership rate relative to the state and national rates because of some of the characteristics of the population (high percent of student and elderly households, small household size) but the fact remains that the rate could be increased. Efforts to encourage minority homeownership and homeownership for low income households (50-80% of median boome) are key initiatives in Fargo. Additionally, working to ensure a variety of homeownership options throughout the community will encourage increases in homeownership across all income and age groups.

HOMELESSNESS

Homelesaness is also an issue that has a different scale in North Dakota and in the City of Fargo than it does in larger, more urbanized, areas. The most recent survey of homelessness in Fargo counted 446 homeless persons, 29% of whom could be considered chronically homeless. Even though Fargo is home to approximately 16% of the state's population, it is home to more then one-third of the state's homeless population. The City has a good emergency shater system, some transitional housing and permanent supportive housing units. However, continuing the work to address crisis housing situations and to provide a robust continuum of housing options will allow people to move from homelessness to housing stability.

DIVERSITY

Fargo is a more diverse community, immigrants come from two distinct groups — a highly educated and relatively affluent group associated with the metro area's universities and medical institutions, and a relatively disadventaged group of refugees that have been resettled to the United States to avoid persecution in their notive lands. In addition, Native American people exhibit the most need (as measured by poverty, education levels, termsownership). Community systems and residents must continue to adjust to accommodate this diversity of language, culture, and need.

INFRASTRUCTURE

A neighbor/rood's physical and social infrastructure combine to show the strength and long term visibility of a place. Continued investment in the physical infrastructure of the City's neighborhoods (finusing, streets, utilities, neighborhood facilities, parks and open space) and aggressive elimination of blight will encourage vitality in older and more fragile neighborhoods. In addition, investing in social infrastructure may be just as important. Social infrastructure involves leadership development and support for the activities of grass roots organizations (i.e. neighborhood groups, ethnic communities).

. POVERTY

Efforts to reduce poverty levels by increasing carning power and family self-sufficiency have a major impact on community and Individual well-being. In Faygo, as well as throughout the Stats of ND, extremely low income households face the most extreme cost burdens and overall life challenges. They are unlikely to own a home and as such, are unlikely to be accumulating wealth in the form of a housing asset. Their lack of personal financial resources increases the difficulty associated with meeting basic food and shelter needs, as well as transportation and childcare. In general, this group of people is thing in a precedure situation, Efforts to support atability for extremely low income/powerty households are important because this is the group in greatest need.

- Find housing options for hard to house populations (bad credit, criminal background, behavioral issues, et al)
- Ensure culturally appropriate housing and support service solutions to maximize successful reduction in homelessness, particularly for the American Indian population which makes up a disproportionate share of the community's homeless and precariously housed population
- Provide support to extremely low income households (<30 percent area median income) because they are
 the most precariously housed non-homeless.
- Support efforts of the Contineum of Care and State agencies to bolster discharge planning practices to prevent newly discharged individuals from becoming homeless.
- Increase public awareness of homelessness and the needs of fals population.

Non-Housing Community Development Needs

- Self sufficiency enhancement, particularly for extremely low income households (English language soudstlon, transportation, job skills, entrepreneurship, microenterprise support)
- Leadership development within local otheric communities (i.e., Native and New Americans) to facilitate selfdetermined activity and successful integration into the community fathric
- Neighborhood based youth/family facilities in low income and/or "fragile" neighborhoods
- Elimination of deteriorated property and blighted conditions in both residential neighborhoods and the central business district

Item 1. Welcome

Item 2. Approval of Minutes: Regular Meeting of October 1, 2015

Mr. Paulsen moved the minutes of the October 1, 2015 Community Development Committee meeting be approved. Second by Ms. Klabe. All Members present voted ayo and the motion was declared carried.

Item 3. Review 2016 Community Development Budget and Requests

Community Development Administrator Dan Mahli presented handouts to the Board regarding Missing Middle Housing, Income and Health. He discussed Fargo-Moorhead communities in relation to their low cost-of-living compared to other urbanized areas; affordability concerns for the lower-income portion of the population; the relationship between household income and fair/poor health status; and the issues of affordable housing and the development of policies that will address needs.

Linda Boyd present.

Discussion was held regarding ways to address affordable housing needs including a strategic planning process.

Mr. Mahli gave a brief summary of the 2018 Community Development Grant requests. He stated Fargo anticipates \$668,000 in Community Development Block Grant funds (CDBG) and \$346,000 in HOME Partnership funds to be available, approximately \$50,000 in HOME program income, as well as \$253,000 in City Social Service funding and \$110,000 in City Art funding.

Activities in the 2016 Action Plan include the following:

HOUSING

- Housing Rehabilitation-Owner Occupied \$307,726 to be available for rehabilitation of existing owner-occupied housing units. This includes \$261,502 in HOME funds and \$43,985 in CDBG.
- Special Assessment Assistance -- \$10,000 in CDBG funds to assist low-income homeowners with annual special assessments.
- Community Housing Development Organization (CHDO) \$100,000 in HOME funds to support CHDO affordable housing projects.

- Habitat for Humanity to support partnership to construct Habitat houses on City-owned lots starting with 705 12th Street North
- DOWNTOWN PROJECTS \$100,000 in CDBG funds for projects that address slum and blight conditions in downtown Farge,

PUBLIC SERVICE PROJECTS

- Fargo Homeless Initiatives \$80,000 in CDBG funds to support homeless initiatives at the Gladys Ray Shelter, homeless police liaison, and 10-year plan activities.
- Snow Removal Assistance = \$2,000 in CDBG funds to offer snow removal assistance to low-income senior households and people with disabilities.
- High Plains Fair Housing Center \$6,000 in CDBG funds to provide comprehensive outreach and education on fair housing.
- Metro Transportation Initiative Opportunities Under Transit (OUT) -- \$3,000 in CDBG funds to provide transportation to low-and-moderate Income participants.
- Job Training \$15,000 in CDBG funds to provide job skills training and development for refugees and low-income persons.

Mark Johnson, Project Manager for The Kilbourne Group, discussed the details of the storefront façade renovation including the history of the buildings, timeline of the project, and the eligible components of the renovation.
