SUBJECT: Program Year 2023 Annual Community Assessment

Dear Ms. Crutchfield:

As a recipient of grant funds provided by the U.S. Department of Housing and Urban Development (HUD), each jurisdiction that has an approved Consolidated Plan shall annually review and report to HUD on the progress it has made in carrying out its Consolidated Plan and Annual Action Plan. The performance report is submitted to HUD's Office of Community Planning and Development (CPD) in the form of the Consolidated Annual Performance and Evaluation Report (CAPER). Furthermore, the Consolidated Plan regulations at 24 CFR § 91.525 require the Department to evaluate and report to the public on a community's overall progress in the management of its program funds, compliance with the Consolidated Plan, the accuracy of performance reports, and the extent to which progress has been achieved toward the statutory goals identified in Section 91.1.

This letter serves to acknowledge your Program Year 2023 CAPER submission and to apprise you of our assessment of the City of Fargo's overall progress. HUD acknowledges the City of Fargo's programmatic accomplishments during the program year. Based on our Office's review of your Program Year 2023 CAPER, we have concluded that the City of Fargo has the capacity to carry out its CPD programs and has met its reporting requirements.

The review revealed that no Program Year 2023 activities were completed in the program year and funds were only drawn for one 2023 activity. An attached "Assessment of Objectives and Accomplishments" document provided a detailed explanation of the progress of activities for 2023 and prior years. Typically, Fargo allocates funding to housing projects annually without having a particular project identified, and then submits an amendment once a project has been identified. The time between submitting the Annual Action Plan and identifying a housing project has often led to delays in expending those funds. Fargo may want to consider not allocating funding to housing projects in future years' Annual Action Plans until a specific project has been determined. Fargo is currently at 1.82 adjusted grant years' worth of funds in its

line of credit prior to its timeliness test date of March 2, 2025. Funding shovel-ready projects may assist Fargo in meeting its timeliness requirements.

A financial review identified a concern with the City of Fargo's overall benefit requirement. Fargo has a 3-year certification period of 2023, 2024, 2025. For 2023, only 58% of expenditures went towards benefiting low-and-moderate income persons, which is below the required 70%. The City of Fargo will need to ensure that low-and-moderate income national objective expenditures for program years 2024 and 2025 are sufficient to meet the required 70% threshold over the three-year certification period.

Finally, please ensure that future CAPERs include a list of units inspected in each HOME project monitored in the CR-50 HOME screen.
