CR-05 - Goals and Outcomes

Progress the jurisdiction has made in carrying out its strategic plan and its action plan. 91.520(a)

This could be an overview that includes major initiatives and highlights that were proposed and executed throughout the program year.

This CAPER covers the fifth year of the 2020-2024 Consolidated Plan. It includes accomplishments of 2024 Action Plan activities and prior year activities that were accomplished in the 2024 program year (May 1, 2024 – April 30, 2025). The 2024 Action Plan projects focused on the homelessness goal. CDBG funds were used for projects related to operational support for street outreach services, substantial rehabilitation of an emergency shelter’s HVAC system, and fair housing. CDBG-CV funds were used for projects related to homelessness, including the provision of a mobile medical unit, which was used to help close healthcare service gaps for vulnerable populations. Allocation priorities were a result of the citizen participation and plan development process, including the impacts of COVID-19.

The proposed versus executed activities are outlined in the charts in this section, and even further in the *Assessment of Objectives and Accomplishments* document, which is attached. This attachment shows any progress or accomplishments made in the 2024 program year from 2024 and pre-2024 Action Plan activities, including CDBG-CV projects.

To note, as of the end of July 2025, the City of Fargo completed a 30-day public comment period for substantial amendments to its 2023 Action Plan and 2024 Action Plan (also included in this 30-day public comment period was Fargo’s 2025-2029 HUD Consolidated Plan and 2025 Action Plan). By the beginning of August 2025 at the latest, the City will submit its 2025-2029 HUD Consolidated Plan and 2025 Action Plan in HUD’s Integrated Disbursement and Information System (IDIS). After the public hearing and public comment period at the end of July, the City will also be submitting its substantial amendments for the 2023 Action Plan and 2024 Action Plan. Since the 2024 CAPER is due at the end of July (and the public hearing and public comment period for the 2024 CAPER will not be completed until the end of July), the substantial amendments for both the 2023 Action Plan and 2024 Action Plan were not submitted, reviewed, and approved (with an IDIS status of “review completed”) by the time the 2024 CAPER was entered into IDIS due to time constraints. As a result, these amendments will not have carried over into the IDIS version of the 2024 CAPER by the time the CAPER is to be submitted in IDIS. Attached is a packet (titled *Amendments to 2024 Action Plan*) which includes documentation of these recent, substantial amendments.

Provided below are specific narratives for both the 2024 Action Plan Community Development Block Grant (CDBG) and HOME Investment Partnerships (HOME) programs, including narratives on recently-amended activities:

Community Development Block Grant (CDBG) Progress

Low-Mod Benefit

Over a period of three years (2023-2025), the City is required to spend a cumulative minimum of 70% of its CDBG funds on projects benefiting low to moderate income people. At the end of the 2024 Program Year, 78.82% of the funds subject to this requirement (non-administrative funds) were spent on such projects. The CDBG-funded projects include: homeless prevention and diversion efforts, eviction prevention, improvements to an emergency shelter, and fair housing.

Acquisition for Affordable Multi-Family Rental Housing Activity (2024 & 2023)

2024 CDBG funding in the amount of \$336,000 was allocated and set up as a 2024 Action Plan project titled *Acquisition for Affordable Multi-Family Rental Housing Development* and 2023 CDBG funding in the amount of \$150,000 was allocated and set up as a 2023 Action Plan project titled *Acquisition for Affordable Multi-Family Rental Housing Development*. Both the 2023 and 2024 CDBG funding was to be utilized for acquisition of land for new construction of an affordable, multi-family rental housing complex in partnership with Beyond Shelter, Inc. at a location that was yet to be determined.

Due to delays and, following a reassessment of project feasibility, capacity, and risk, both the 2023 Action Plan project and 2024 Action Plan project for land acquisition were canceled through a substantial amendment process that was recently completed and approved by City Commission at the end of July 2025. The CDBG funds were reallocated to other eligible, proposed projects in the 2025 Action Plan that will benefit low to moderate income persons, support priority needs, and contribute to overall program goals.

HOME Investment Partnerships Program (HOME) Progress

Affordable Multi-Family Rental Housing Activity (2024)

As part of the 2024 Action Plan, \$500,000 in HOME funding was allocated to a project titled *Affordable Multi-Family Rental Housing Development*. This project was intended to support the new construction of an affordable, multi-family senior and elderly rental housing complex in partnership with Beyond Shelter, Inc. at a location that was yet to be determined.

Community Housing Development Organization (CHDO) Activity (2024 & 2023)

HOME 'set-aside' funding in the amount of \$95,000 was allocated and set up as a 2024 Action Plan project titled *Community Housing Development Organization (CHDO)*. This project was to utilize HOME funds for creation of affordable housing in partnership with a Community Housing Development Organization at a location that was yet to be determined.

In addition, 2023 HOME 'set aside' funding in the amount of \$100,000 was allocated to a 2023 Action Plan project titled *Community Housing Development Organization (CHDO)*. This funding was also to be used for the development of affordable housing in partnership with a Community Housing Development Organization at a location that was yet to be determined.

Due to delays and, following a reassessment of project feasibility, capacity, and risk, all of the above HOME-funded affordable housing projects were canceled through a substantial amendment process that was recently completed and approved by City Commission at the end of July 2025. The HOME funds were reallocated to other eligible, proposed projects in the 2025 Action Plan that will benefit low to moderate income persons, support priority needs, and contribute to overall program goals.

Affordable Single-Family Housing for Ownership Activity (2023)

Lastly, 2023 HOME funding in the amount of \$400,000 was allocated to a 2023 Action Plan project titled *Affordable Single-Family Housing for Ownership*. This funding was to be used by Lake Agassiz Habitat for Humanity towards new construction of an affordable, single-family residential twinhome (resulting in two housing units) at two, adjacent sites in Fargo.

This proposed HOME-funded twinhome new construction activity is being canceled due to various federal constraints associated with larger-scale development, which contributed to extended project delays and lack of available, qualified contractors. These HOME funds were reallocated to proposed, eligible projects outlined in the 2025 Action Plan (through a recently-approved substantial amendment process).

Community Development Block Grant – Coronavirus (CDBG-CV) Progress

During program year 2020, the City of Fargo received over \$1 million in funding from HUD through the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) to be used to prevent, prepare for, and respond to the coronavirus (COVID-19). At the end of program year 2024, only one of the five projects identified to reduce the spread of COVID-19 remains open.

Accomplishments realized during program year 2024 are outlined in the attached *Assessment of Objectives and Accomplishments* document. This attachment also includes accomplishments from pre-2024 Action Plan activities that were made during the 2024 program year.

Fargo’s Consolidated Plan outlines goals that are the focus of Fargo’s annual community development activities and plans: Affordable Housing, Ending and Preventing Homelessness, Neighborhood Improvements and Initiatives, and Assistance for Vulnerable Populations. All of the 2024 activities fit within each of these goals and priorities, with a focus on the following goal:

Ending and Preventing Homelessness Goal

- Downtown Engagement Center Operations
- YWCA Cass-Clay Emergency Shelter Facility Improvements

Highest Priority Activities Addressing Plan Priorities & Specific Objectives

Substantial rehabilitation of an emergency shelter’s HVAC system is the highest priority use of CDBG funding in the 2024 Action Plan. In addition, public service activities in the 2024 Action Plan included funding for operations related to the Downtown Engagement Center, which serves people who are at risk of homelessness, recently homeless, or who are currently homeless. Funding these operations will allow for continued assistance for people with finding housing, maintaining housing, healthcare, life skills, therapy, etc.

2024 CDBG funding, in the amount of \$336,000, was allocated and set up as a 2024 Action Plan project titled *Acquisition for Affordable Multi-Family Rental Housing Development*. This funding was to be utilized for acquisition of land for new construction of an affordable, multi-family rental housing complex in partnership with Beyond Shelter, Inc. at a location that was yet to be determined. This 2024 Action Plan project was canceled through a recently-approved 2024 Action Plan amendment, and the CDBG funds were reallocated to proposed projects in the 2025 Action Plan.

Initially, the main priority of HOME-funding in program year 2024 was the addition of affordable, multi-family rental housing to be occupied by low-to-moderate income households. The 2024 Action Plan HOME-funded projects included \$95,000 in HOME ‘set-aside’ funds for creation of affordable housing in partnership with a Community Housing Development Organization (CHDO) and \$500,000 in HOME funds for new construction of an affordable, multi-family senior and elderly rental housing complex. Due to delayed timelines and reassessment of project feasibility, including capacity and risk analysis, these two HOME-funded, affordable housing projects were canceled and funds reallocated to

proposed affordable housing projects in the 2025 Action Plan.

Narrative

The City of Fargo received a CDBG award of \$822,824 for Program Year 2024. This represents a decrease of \$18,133 from the prior year. Also available was \$720,477.84 in prior year resources, and \$35,258.25 in program income collected during PY2024, for a total of \$1,578,560.09 in CDBG funding available (includes obligations for 2023 activities underway during Program Year 2024). The City received a HOME award in the amount of \$444,620.36, a decrease of \$105,147.64 from the prior year. Other available HOME funds included \$132,228.97 in HOME program income and \$25,000 in recaptured funds collected during Program Year 2023 and made available in Program Year 2024, as well as \$820,484.25 in prior year resources, for a total of \$1,422,333.58 in HOME funding available. Additionally, \$11,788.29 of the \$1,044,369 CARES Act Community Development Block Grant (CDBG-CV) funds awarded in Program Year 2020, were available to be used for activities to prevent, prepare for, and respond to coronavirus (COVID-19) during Program Year 2024.

Narrative

While there were no specified “Target Areas” identified in the 2024 Action Plan, the City of Fargo does prioritize its community development activities to neighborhoods that are predominately low to moderate income areas.

Neighborhoods with the highest percentage per capita of residents who live below the poverty level include: Roosevelt/NDSU neighborhood (44.6%); West Acres (40%); Washington (27.4%), Downtown (24.5%), Amber Valley (23.7%), Madison/Unicorn Park (20.8%), and Stonebridge (20.7%).

Leveraging

Explain how federal funds leveraged additional resources (private, state and local funds), including a description of how matching requirements were satisfied, as well as how any publicly owned land or property located within the jurisdiction that were used to address the needs identified in the plan.

The City combined its federal entitlement allocations with funding from other public and private sector sources to address its priority needs. Generally, funding is leveraged through the use of Subrecipients and Developers accessing private, local, and other state dollars or subsidies. The City leverages HUD funds by funding some project proposals with City General Fund, which opens up more funding and HUD administrative capacity for HUD-assisted projects.

Other leveraging includes Public Housing Capital Fund, Section 8 Vouchers, Section 8(bb) HAP vouchers, City General Social Service funds, Neighborhood Revitalization Initiative (NRI) rehabilitation loan funds in partnership with Gate City Bank, state and federal resources including those from the ND Housing Finance Agency, tax credits and incentives, and PILOT and Capital Bonds.

802 32 Street North and 3129 7 Avenue North

In February of 2023, the City utilized Community Development Block Grant (CDBG) funds and American Rescue Plan Act (ARPA) funds to purchase two adjacent parcels located at 802 32 Street North and 3129 7 Avenue North in Fargo. In the future, neighborhood outreach will occur and a Request for Proposals for affordable housing development will be brought to City Commission for issuance.

Local Housing Nonprofit Organizations

Over the course of the 2020-2024 Consolidated Plan, the City utilized HOME funds for affordable single-family housing development, to be carried out by Habitat for Humanity and Cass Clay Community Land Trust (CCCLT). Below are summaries of these projects:

Lake Agassiz Habitat for Humanity

The City deeded two lots (1529 10 Ave S and 702 2 St N) to Habitat in June of 2021. Construction on both of these lots was completed and the closings with the homebuyers took place in the spring and winter of 2022. In addition, Habitat for Humanity utilized 2022 HOME funds for new construction of another affordable, single-family housing unit at 2790 10 Avenue North that was completed in March of 2024, and a closing with the homebuyers occurred in May 2024. Also, the City acquired a vacant, residential, single-family lot located at 1714 5 Avenue South through a tax forfeiture in February 2023. This lot was deeded to Habitat for Humanity in June 2024, for a HOME-funded new construction project (utilizing 2023 HOME funds) of an affordable, single-family housing unit. Accomplishment for the project at 1714 5 Avenue South will be reported on in

the 2025 CAPER.

Cass Clay Community Land Trust

The CCCLT utilized HOME funds to purchase the lot at 1412 1 Avenue South in June of 2021. A second lot, located at 1410 1 Avenue South, was transferred to the CCCLT in the fall of 2022. Construction of a twinhome (resulting in two units of affordable, single-family housing) was completed and a Certificate of Occupancy for each unit was issued in September of 2023. A ratified sales contract was executed by each income-qualified homebuyer in the spring/summer of 2024, and the closings with each homebuyer occurred in the 2024 program year (in the second half of 2024 and in early 2025).

HOME Match

Upon becoming a HOME Participating Jurisdiction, the City of Fargo became responsible for documenting appropriate match in conjunction with receiving HOME funds. For the 2020-2024 Consolidated Plan, \$100,000/year in matching fund liability was estimated. Sources of match may include local payments in lieu of taxes, waived or deferred fees or charges, non-Federal cash contributions to the HOME program or specific projects, donated real property, the value of sweat equity, among other eligible sources listed in Title 24 CFR 92.220. For both waived building permits and payments in lieu of taxes, these amounts were calculated based on the percentage on units within the project that are HOME-assisted in accordance with 24 CFR 92.219(b)(2).

Program Income

During Program Year 2024, Community Development programs generated a total of \$86,263.50 in program income (PI), including \$35,258.25 in CDBG PI and \$51,005.25 in HOME program income received by the Participating Jurisdiction (PJ). All CDBG PI was drawn and expended in accordance with HUD regulations during PY2024. The HOME PI will be allocated in compliance with HOME program requirements as part of the 2025 Annual Action Plan budget.

Minority Business Enterprises and Women Business Enterprises

One HOME-funded project with subcontracts totaling \$152,303.70 was completed during the reporting period of October 1, 2023 to September 30, 2024. Of the associated contracts, no subcontracts were with a minority-owned business enterprise or a women-owned business enterprise.

Discuss the difference between goals and outcomes and problems encountered in meeting these goals.

In the 2024 Action Plan, three projects were identified to support the Affordable Housing goal, which focused on increasing the supply of affordable rental housing for low to moderate income senior and elderly households. The first project, titled *Acquisition for Affordable Multi-Family Rental Housing Development*, was to utilize CDBG funds for land acquisition for future construction of an affordable, multi-family rental housing complex in partnership with Beyond Shelter, Inc. at a location that was yet to be determined. The second project, titled *Affordable Multi-Family Rental Development*, included using HOME funding for new construction of an affordable, multi-family senior and elderly rental housing complex in partnership with Beyond Shelter, Inc. at a location that was yet to be determined. Lastly, the third project, titled *Community Housing Development Organization (CHDO) Project*, is tied to the multi-family rental housing development project and acquisition project noted above, but was to utilize HOME 'set-aside' funds for development of affordable housing in partnership with a qualified CHDO at a

location yet to be determined.

While the goal was to facilitate development of new affordable rental housing, the intended outcomes – including land acquisition and new construction – were not realized. The main challenges to executing these projects included, but were not limited to: securing adequate funding to ensure financial viability; identifying suitable, available land for development and ensuring the land acquisition process/timeline adhered to HUD requirements; capacity constraints; and other federal requirements and regulatory considerations that impacted project timelines and contributed to project risk.

As a result, these three affordable housing projects in the 2024 Action Plan were canceled through a substantial amendment process and both the CDBG and HOME funds were reallocated to other, eligible proposed projects in the 2025 Action Plan that are expected to meet housing needs and further the goals outlined in the Consolidated Plan.

Discuss how these outcomes will impact future annual action plans.

The outcomes of these canceled affordable housing projects have had a significant impact on the planning and development of the 2025 Action Plan and will inform future planning efforts. The delays and feasibility concerns associated with large-scale projects have highlighted the importance of stronger feasibility assessments and more clearly defined timelines and subrecipient/developer capacity at the time of project selection. As a result, the City will place an increased emphasis on evaluating project readiness, including detailed development/program plans and demonstrated organizational capacity, when considering future Action Plan projects. Additionally, staff will continue to strengthen assistance and collaboration with subrecipients to ensure project readiness prior to commitment of HOME and/or CDBG funds. These adjustments are intended to support more timely and impactful use of federal funds and to better achieve stated goals related to affordable housing.

Based on the challenges encountered with large-scale new construction projects, the City is also reassessing its approach to affordable housing strategies. Moving forward in future Action Plans, the City is looking to prioritize HUD-funded, affordable housing activities that are more immediately implementable, such as tenant based rental assistance and housing rehabilitation, which can more quickly address housing needs for low to moderate income residents.

Narrative Information

Worst-case Housing Needs & Cost Burdens

The City's affordable housing efforts, along with its ongoing relationships with service providers, help to alleviate some of Fargo's worst-case housing needs. Worst-case housing needs are those related to serious cost burdens or homelessness, substandard housing, or involuntary displacement.

Finding affordable housing in the Fargo area has been difficult for many years, particularly for low to moderate income households. Based on the 2021 CHAS data released September 12, 2024, 10% of homeowner households and 38% of rental households were housing cost burdened, i.e., spending more than 30% of their income on housing expenses. These households are the most likely to have to prioritize their living costs, including food, clothing, transportation, and medical care. In many cases, some basic needs are being neglected as a result of housing cost burden.

In addition to low- and moderate-income households, other households that are often affected by housing problems include single-person or single-parent households, larger families, people fleeing domestic violence, people with a criminal history, poor rental history, low or no credit, racial minority groups, immigrants and refugees, and people with disabilities.

CR-25 - Homeless and Other Special Needs 91.220(d, e); 91.320(d, e); 91.520(c)

Reaching out to homeless persons (especially unsheltered persons) and assessing their individual needs

Key accomplishments, milestones, and benchmarks for the City of Fargo in PY2024 include:

- Continued membership and support for the North Dakota Continuum of Care (CoC) which coordinates with the West Central Minnesota CoC to support the use of the region's Coordinated Access Referral Entry & Stabilization system (or "CARES", which can be found at <https://www.careslink.org>) for coordinated entry to services. Coordinated entry is required by HUD and the state if receiving funds, so most area service providers are utilizing CARES. As a centralized database, it quickly connects people to housing assistance, shelter, and other resources, based on an evaluation of their vulnerability and needs.
- Continued membership of the FM Coalition to End Homelessness, which has taken a renewed focus on enhancing coordination of the local homeless response system, particularly in how individuals can gain access to services and improved synchronization of assessment tools across systems. In addition, it continues to lead the region's Point-in-Time count that involves outreach by several partners to survey all individuals who are unsheltered and unsheltered people experiencing homelessness on a given night.
- Continued funding for the Street Outreach/Mobile Outreach program of the City's Harm Reduction division, which assists unsheltered people in crisis, typically related to mental health and substance use issues. All staff of the Mobile Outreach Program are trained in administering the VI-SPDAT assessment tool to help assess a person's individual needs and connect to appropriate housing or detox interventions. In May 2024, using CDBG funding, the City launched its first ever mobile outreach team focused on the downtown neighborhood, referred to as the Homeless Engagement And Response Team (HEART).
- Continued funding for the Downtown Engagement Center, which supports outreach to homeless persons by providing a team of case managers, outreach workers, housing navigators, and various service agencies within the facility to assess needs and encourage applying for mainstream benefits without needing to travel to different locations.
- Continued CDBG-CV funding for Family Healthcare Mobile Outreach, which included services to persons staying at homeless shelters throughout the area.

The main barriers to progress continue to be insufficient resources to keep up with demand, for which staff continue to advocate.

Addressing the emergency shelter and transitional housing needs of homeless persons

Key accomplishments, milestones, and benchmarks for the City of Fargo in PY2024 include:

- Continued funding for the City-owned and operated Gladys Ray Shelter, which primarily uses general funds and other grants. This is a low barrier shelter with capacity for 25 adult males and 10 adult females. It also provides short-term residential, social (non-medical) detoxification services at its Withdrawal Management Unit (WMU).
- Continued support for the City's overnight Winter Warming Center (WWC), which was located at 1230 25 Street South for the 2024-2025 winter season. It provided airport-style overnight shelter to prevent negative health impacts and cold weather-related injuries by providing limited overflow during the coldest months. The main barriers to progress include that emergency shelter and transitional housing needs continue to exceed supply. There are approximately 330 emergency shelter beds and 77 transitional housing beds when shelters are operating at standard capacity. However, demand has consistently been higher throughout PY2024, requiring shelters to convert to surge or overflow capacity and/or turn individuals away. There are 1,052 individuals estimated to be experiencing homelessness on any given night.

Helping low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who are: likely to become homeless after being discharged from publicly funded institutions and systems of care (such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions); and, receiving assistance from public or private agencies that address housing, health, social services, employment, education, or youth needs

Key accomplishments, milestones, and benchmarks for the City of Fargo in PY2024 include:

- Continued support for the Downtown Engagement Center, which serves as a central service hub for people who are homeless or at-risk of becoming homeless.
- Several local organizations continued efforts to enhance support for those being discharged from institutions, including but not limited to: Centre Inc., F5 Project, ShareHouse, Free Through Recovery, and the Red River Recovery Center. Some shelters also provide a limited number of beds for medical respite care programs, including the New Life Center and YWCA.
- For foster care and youth, Youthworks and Fraser, Ltd. continued to work with children and young people who are either experiencing or facing homelessness, including people transitioning out of foster care into adulthood. Not all of the youth served by Fraser lived in

foster care, but a significant portion of them have spent at least some time in foster care.

Helping homeless persons (especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth) make the transition to permanent housing and independent living, including shortening the period of time that individuals and families experience homelessness, facilitating access for homeless individuals and families to affordable housing units, and preventing individuals and families who were recently homeless from becoming homeless again

Over the past year, the City of Fargo has focused much attention toward working to address the root causes of homelessness. Multiple visits by Milwaukee Housing Administrator [James Mathy](#) (link to video can be found at <https://www.youtube.com/watch?app=desktop&v=B0uuSyalifg>) served as a catalyst for community-wide education and enthusiasm for Housing First principals, which prioritize housing access as the topmost element needed to make homelessness a rare, one-time occurrence in a person's life.

As a response to community need, and the request for a unified voice and structure to focus on homelessness, United Way of Cass-Clay and the FM Coalition to End Homelessness teamed up to mobilize our local partners who have the expertise, passion, and proven strategies for permanent solutions to prevent and end homelessness.

The purpose of this collaboration and the United to End Homelessness initiative is to create a community where homelessness is prevented or brief and families have the programs and services they deserve to thrive. Our community has had success in reducing homelessness when resources are adequately funded and supported.

In April 2025, Fargo Mayor Tim Mahoney signed a joint proclamation with neighboring mayors to establish the Cass Clay Interagency Council on Homelessness, led by United Way of Cass-Clay and the FM Coalition to End Homelessness, which will bring together local governments, service providers, and advocates to drive solutions, align resources, and implement strategies that prevent and end homelessness in our region.

In tandem, throughout PY2024:

- The City of Fargo continued its partnerships with area service providers and organizations that help homeless persons make the transition to permanent housing and independent living, including the FM Homeless Coalition, SouthEastern North Dakota Community Action Agency (SENDCAA), Presentation Partners in Housing, area shelters, and the North Dakota CoC. These agencies focus on planning and delivering housing and services for people who are homeless, including diversion and prevention; and use of the local Coordinated Access Referral and Entry Stabilization system (CARES).
- The Fargo VA continued to operate its Fargo VA Health Care System Homeless Care Team and

Community Resource and Referral Center (CRRC) at 721 1 Avenue North provides veterans who are homeless, or at risk of becoming homeless, opportunities to meet their immediate needs such as respite from the weather, showers and laundry facilities, meals and clothing. Additional services include referrals to community-based services, advocacy, internet/phone/email access, mail drop services, help with getting prescriptions filled or making appointments, and numerous other support services.

- The City continued to operate its Gladys Ray emergency homeless shelter and its harm reduction programming, which includes dedicated staff for housing navigation. As mentioned in earlier sections, the Gladys Ray Shelter (GRS) is a low barrier shelter and serves people who are unlikely to find shelter elsewhere, including people who have been actively using drugs or alcohol if they are not a harm to themselves or others. GRS continuously works to address core issues of homelessness, including chronic chemical dependency, mental illness and physical disabilities, as well as unemployment and affordable housing issues. GRS is committed to helping ensure that adequate housing options and resources are available to all guests leaving the emergency shelter.

Key challenges to implementing Housing First and the necessary supportive services continues to be funding; the lack of available, affordable units; and a direct service provider shortage, exacerbated by high turnover of staff.

CR-30 - Public Housing 91.220(h); 91.320(j)

Actions taken to address the needs of public housing

In PY2024, the Fargo Housing & Redevelopment Authority (FHRA) continued to manage its inventory of public and subsidized housing units and vouchers. It began construction of a 110-unit-low-income apartment building at the site of the demolished Lashkowitz High Rise, with expected completion now anticipated for March 2026. They also began planning the redevelopment of a 3-acre site to include construction of a 65-unit affordable housing building expected to be completed in the spring of 2026.

Actions taken to encourage public housing residents to become more involved in management and participate in homeownership

The FHRA continued to work to engage, educate, and empower residents by providing opportunities for personal development, economic stability, education, health, and fostering family and community life. In PY2024, it continued to manage programs that promote self-sufficiency and upward mobility, including its Resident Opportunity and Self Sufficiency (ROSS) Program which support tenants' preparation toward economic self-sufficiency and homeownership. The FHRA also worked closely with Job Service of North Dakota to provide necessary training opportunities to poverty-level families.

In PY2024, the FHRA continued to manage its homeownership voucher program for disabled tenant households, which was closed to new participants in 2009 but still has a handful of participants from when it was open. In addition, the FHRA continued to monitor several remaining participants who have not yet sold their soft second mortgage as part of its 1999 5H Homeownership Program.

For every 100 residents in a property, there is a resident advisory board which is convened to review annual plans, proposed policy changes, etc. Members receive a monetary stipend for participation and feedback.

Actions taken to provide assistance to troubled PHAs

FHRA is not designated as a troubled PHA.

CR-35 - Other Actions 91.220(j)-(k); 91.320(i)-(j)

Actions taken to remove or ameliorate the negative effects of public policies that serve as barriers to affordable housing such as land use controls, tax policies affecting land, zoning ordinances, building codes, fees and charges, growth limitations, and policies affecting the return on residential investment. 91.220 (j); 91.320 (i)

Availability of both new and existing units of affordable housing has been an increasing challenge in Fargo, both for renters and owners. The City's tax policies, zoning controls, building inspections and housing-related incentives, for the most part, do not act as a barrier to affordable housing creation/preservation. Each category and related action is summarized in this section.

Tax Policies

The City has a two-year property tax exemption for newly constructed owner-occupied housing that is weighted more heavily toward affordable units. Fargo also has a property tax exemption for home remodeling projects that freezes the pre-rehab value for a period of 3-5 years, depending on the age of the home. In addition, the State of North Dakota has a Homestead Tax Credit that is designed to reduce the property tax burden on low-income elderly and disabled homeowners, with the taxable value reduction being greater for those with incomes of \$40,000 or less. The City of Fargo also has Tax Increment Financing (TIF) and Payments in Lieu of Taxes (PILOT) programs with accommodations available in favor of affordable units.

Land Use Policy & Controls

Recently, the City of Fargo adopted a new Growth Plan, which will provide long-range guidance on land use and land development to the City of Fargo, its partner agencies, and the private sector. It will be used to inform updates to the Land Development Code (LDC), aid the development of capital investment plans for services and utilities, shape future transportation plans, and guide the development of new programs and policies related to development and redevelopment.

The City of Fargo continued to use the Go2030 Comprehensive Plan to guide public policies and decisions towards a community vision through established guiding principles. When considering modifications to land use controls or requests for zoning map amendments, the City of Fargo works to ensure decisions are in alignment with these guiding principles. Recent zoning amendments have led to increased density within developed areas of the City, where municipal services are already in place. This has allowed for more affordable development, taking advantage of existing infrastructure and reducing the need to pay for expensive expansions of municipal services.

In addition, the City of Fargo continued to follow the Core Neighborhoods Master Plan, which includes a comprehensive set of tools that cover land use policy, resident engagement, housing reinvestment, public infrastructure, and enforcement of basic health and safety codes.

Lastly, the City seeks to preserve the supply of existing housing stock. This is accomplished through code enforcement efforts in combination with the tax incentive programs outlined above. Enforcement of property maintenance codes works to extend the life of existing affordable housing stock.

Actions taken to address obstacles to meeting underserved needs. 91.220(k); 91.320(j)

In PY2024, the City fulfilled its proposed actions to address obstacles to meeting underserved needs, including:

- Regarding construction industry constraints: City staff worked in detail with subrecipients and contractors to identify their obstacles and set realistic timelines and budgets based on the information provided.
- Regarding homeless services staffing constraints: City staff continued to discuss with subrecipients and partners ongoing issues and possible solutions regarding worker shortage and burnout of those staffing homeless services.
- Regarding elimination of one-time funding that resulted from the pandemic: City staff held conversations to forewarn providers about the elimination of one-time funding and its impending ripple effects and try to help identify new funding streams.

Actions taken to reduce lead-based paint hazards. 91.220(k); 91.320(j)

In PY2024, the City did not convert any homes to be “lead-free” as this was not part of its proposed actions. Going forward, the City will continue to address lead-based paint hazards for all applicable HUD-funded projects on structures built before 1978. Lead-based paint hazards will be identified through lead-based paint testing and hazard evaluations. All hazards found from the lead-based paint testing will be addressed by a lead-certified contractor. In addition, the City will continue to provide educational information about the hazards of lead-based paint to subrecipients and residents of federal funds on projects involving lead-based paint.

Actions taken to reduce the number of poverty-level families. 91.220(k); 91.320(j)

In PY2024, the City continued to support the efforts of nonprofit and public agencies that work to reduce the number of families living in poverty, including those of the Fargo Housing and Redevelopment Authority (FHRA), which provides a number of self-sufficiency programs that are aimed at increasing a family’s economic independence and improving their quality of life.

In addition, the City has been in support of SouthEastern North Dakota Community Action Agency’s (SENDCAA’s) anti-poverty efforts, including prevention and diversion, and also of SENDCAA’s work in career coaching, creating career pathways for people to move out of poverty. The City also continued its support for various efforts toward housing stability, namely through programs of its Harm Reduction division and support for the FM Coalition to End Homelessness. When housing is the first barrier

addressed, things like employment, transportation, and health can become the focus, which tend to lead to fewer numbers of people experiencing poverty.

Going forward, the City will continue to coordinate anti-poverty efforts with local service providers and social service agencies.

Actions taken to develop institutional structure. 91.220(k); 91.320(j)

The strength of the institutional structure comes from the wide variety of organizations that collaborate to address housing and community development issues within the community. The City of Fargo works to maintain and build its relationships with local organizations, businesses, and residents and will continue to communicate and share existing needs assessment data to address emerging community needs.

Actions taken to enhance coordination between public and private housing and social service agencies. 91.220(k); 91.320(j)

In PY2024, the City fulfilled its proposed actions to enhance coordination between public and private housing and social service agencies including:

- Continued participation in the Fargo Moorhead Coalition to End Homelessness; the statewide Continuum of Care Planning Committee; the ND Interagency Council on Homelessness; and other community-wide partnerships that discuss a variety of housing issues facing the metropolitan area, including the newly established Cass Clay Interagency Council on Homelessness.
- Continued operation of the Downtown Engagement Center, which provides a centralized location for social service agencies to operate and coordinate.
- Continued coordination with multiple agencies, including improved coordination with Firstlink (2-1-1), the area's crisis and resource hotline, to streamline the process to connect citizens to the appropriate resources.
- Collaboration with local housing organizations to connect them with social service agencies as appropriate and to support them in developing organizational capacity in order to help address local housing needs.

Identify actions taken to overcome the effects of any impediments identified in the jurisdiction's analysis of impediments to fair housing choice. 91.520(a)

In PY2024, the City made efforts to overcome the effects of impediments to fair housing choice as identified in its [2020-2024 Analysis of Impediments to Fair Housing](#) (which can be found at

www.FargoND.gov/plansandstudies), including:

- Increased CDBG funding for High Plains Fair Housing Center to establish a new Fargo fair housing specialist who has expanded local efforts for fair housing education, outreach, testing, and mediation.
- Continued financial assistance to low-income homeowners with infrastructure assessments to help maintain the affordability of homeownership.
- Continued partnership with local organizations to create new and/or rehabilitated affordable housing.
- Continued monitoring of city-subsidized rental properties for sufficient affirmative marketing practices.

Going forward, the City will continue efforts to implement these actions as well as several others identified.

The City continues to use various administrative mechanisms to monitor the progress of its HUD-funded projects. The primary monitoring goal of the City is to provide technical assistance, identify deficiencies and promote corrections in order to improve, and reinforce or augment the City's Consolidated Plan performance.

All CDBG and CDBG-CV-funded activities are assigned a project manager who provides technical assistance and conducts remote "desk" monitoring on an ongoing basis. This includes ensuring that the subrecipients comply with the terms of their agreements, including adequate income and client eligibility verifications, procurement methods, and record-keeping. This also includes reviewing beneficiary data and progress reports. For construction projects, the project manager is also responsible for reviewing all certified timesheets and conducting employee interviews and site visits as needed to ensure Davis Bacon and Section 3 compliance.

On-site monitoring visits are determined as necessary by risk assessment. High risk factors include minimal experience managing federal grants; financial audit findings; high staff turnover; historic compliance or performance issues; and/or highly complex activities. On-site monitoring visits utilize HUD's "Checklist for On-Site Monitoring of a Subrecipient."

All HOME-funded activities are assigned a project manager who provides technical assistance and conducts monitoring on an annual basis as outlined in CR-50 and in accordance to the City's HOME Monitoring policy.

Citizen Participation Plan 91.105(d); 91.115(d)

Describe the efforts to provide citizens with reasonable notice and an opportunity to comment on performance reports.

Announcement of the public comment period for reviewing the City of Fargo's Consolidated Annual Performance and Evaluation Report (CAPER) for the 2024 Action Plan for Housing and Community Development was published as a public notice in *The Forum*, emailed to persons interested in housing and community development, and publicized through a news release and the City's website (www.FargoND.gov) on July 9, 2025. These outreach efforts provided opportunity for public input on the performance report during the 15-day public comment period of July 10 – July 24, 2025 by identifying locations of where the report was available for review, how to obtain a copy, and where to send

comments. An additional public input opportunity occurred on July 21, 2025 when the City Commission held a public hearing on the draft report.

The public notice included contact information for the City of Fargo's Section 504/ADA Coordinator, Bekki Majerus, as well as Relay North Dakota, the statewide TTY-based telecommunications relay service, and noted that Fargo's City Hall is accessible, serviced by public transit, and can accommodate persons with disabilities. The availability of alternative formats of the report (e.g., Braille, American Sign Language, etc.) or reasonable accommodations for persons with hearing/vision impairments and/or other disabilities, was publicized in the public notice. Also publicized was the availability of interpretation and translation services, as well as contact information for service requests to enable persons with limited English proficiency to fully participate in the public process. The City's website has the capability of translating posted announcements, including public notices, within the website into over 130 languages.

The report, along with any public comments received, was available during the public comment period on the City's website (www.FargoND.gov) and also made available to the public at the Fargo Planning Department, 2nd Floor City Hall, 225 4 Street North, Fargo, ND or by calling 701-241-1474, TTY/ND Relay service 800-366-6888 or 711. A link to the draft CAPER was distributed by staff to the Community Development e-mail distribution list (which includes the City Commission members and the Fargo Housing and Redevelopment Authority or "FHRA") and all Fargo public libraries. The City provides a reasonable number of free copies of the CAPER to citizens or groups as requested. The City of Fargo will consider and include within the report all comments or views of citizens received in writing or orally.

No comments were received on the 2024 Consolidated Annual Performance and Evaluation Report during the 15-day public comment period, which was from July 10, 2025 through July 24, 2025.

These properties were selected based on the City's risk assessments in addition to the frequency of ongoing inspections identified at 24 CFR 92.251(f)(3). The UPCS inspections identified only minor (Level 1) deficiencies, primarily involving exterior concrete, missing electrical outlet covers, and non-hardwired carbon monoxide detectors. The property owner has either completed or is in the process of completing all necessary corrective actions in compliance with HUD property standards. City staff will ensure all identified deficiencies are addressed and document the compliance.

Provide an assessment of the jurisdiction's affirmative marketing actions for HOME units. 92.351(b)

The City requires that the owner of each HOME development, with five or more total units, affirmatively markets their units to promote equal housing choice for prospective tenants, regardless of race, color, religion, sex, national origin, familial status, or disability. Owners must develop and execute an "Affirmative Marketing Plan" to detail outreach efforts to prospective applicants identified as "least likely to apply." For 2024, all project owners of HOME projects certified that the project maintains and follows an Affirmative Marketing Policy in compliance with 24 CFR 92.351 and the City of Fargo's Affirmative Marketing Plan. The City reviews each project's plan to verify compliance.

During the 2024 program year, the City utilized \$132,228.97 in HOME program income to support the development of two affordable single-family housing units for homeownership. One home is completed and occupied, while the second remains under construction. Both projects advance Consolidated Plan priorities to increase affordable homeownership opportunities.

The completed unit was sold to a single, non-elderly, non-Hispanic individual earning between 60–80%

of area median income (AMI). The second home will also serve a low- to moderate-income homebuyer upon completion. No program income was used for administration during the program year.

Describe other actions taken to foster and maintain affordable housing. 91.220(k) (STATES ONLY: Including the coordination of LIHTC with the development of affordable housing). 91.320(j)

Throughout the 2020-2024 Consolidated Plan and as outlined in its Core Neighborhoods Master Plan, Go2030 Comprehensive Plan, Growth Plan, and Fargo-Moorhead Regional Housing Needs Analysis, the City has remained focused on preservation and/or creation of affordable housing. Other actions taken to foster and maintain affordable housing are summarized below:

Housing Rehabilitation

In 2024, the City recommitted to the City's Neighborhood Revitalization Initiative (NRI), which is a \$2 million line of credit from Gate City Bank to offer low-interest loans with Annual Percentage Rates (APR's) as low as 5.16% for affordable homeowner improvements. In 2024, 16 housing units were rehabilitated through the NRI Program, keeping them affordable, safe, and more energy efficient for homeowners.

Low Income Housing Tax Credits (LIHTCs) – Fargo Projects

One project in Fargo, NEX Senior (located at 1728 42 Street South), was awarded LIHTCs in PY2023. NEX Senior is a 40-unit senior community with one- and two-bedroom units, onsite management, and integrated supportive services. This infill project was developed by Commonwealth Development and was awarded \$1.1 million in 9% LIHTCs; \$1,558,248 in HOME funds; and \$2,852,413.21 in HTF funds. NEX Senior is expected to be open in the summer of 2025.

Down Payment and Closing Cost Assistance

In addition, the North Dakota Housing Finance Agency continued its down payment and closing cost assistance programs in Fargo to provide many new owner-occupied housing opportunities in the City.

Multi-Family Rental Housing and Community Housing Development Organization (CHDO)

The City partnered with two local housing organizations to provide affordable, multi-family housing for low-to-moderate income senior households. One development (which was marked as complete in the 2024 program year and is further explained in the *Assessment of Objectives and Accomplishments* attachment) resulted in new construction of a 42-unit affordable senior rental housing complex and the second development (which will be marked as complete in the 2025 program year) resulted in new construction of a 52-unit affordable senior rental housing complex.

Local Housing Nonprofit Organizations (Single-Family Housing)

The City of Fargo utilized HOME funds for affordable, single-family housing development projects (in the 2020 Action Plan, 2022 Action Plan, and 2023 Action Plan), to be carried out by Habitat for Humanity and Cass Clay Community Land Trust (CCCLT). Below are summaries of these projects:

Lake Agassiz Habitat for Humanity

In the spring of 2022, Habitat for Humanity finished construction of a single-family home located at 1529 10 Avenue South in Fargo, which was then sold to a low-to-moderate income buyer. As part of the 2022 Action Plan, HOME funds were awarded to Habitat for Humanity for new construction of an affordable, single-family housing unit located at 2790 10 Avenue North in Fargo. Construction of this unit was completed in March of 2024 and a closing with the low-to-moderate income homebuyers occurred in May 2024. In addition, the City acquired a vacant, residential, single-family lot located at 1714 5 Avenue South through a tax forfeiture in February 2023. This lot was deeded to Habitat for Humanity in June 2024 for a new construction project (utilizing 2023 HOME funds) of an affordable, single-family housing unit. Accomplishment for the project at 1714 5 Avenue South will be reported on in the 2025 CAPER.

Cass Clay Community Land Trust

The CCCLT utilized 2020 HOME funds to purchase the lot at 1412 1 Avenue South in June of 2021. A second lot, located at 1410 1 Avenue South was transferred to the CCCLT in the fall of 2022. Construction of a twinhome (resulting in two units of affordable, single-family housing) was completed and a Certificate of Occupancy for each unit was issued in September of 2023. A ratified sales contract was executed by each income-qualified homebuyer in the spring/summer of 2024 and the closings with each homebuyer occurred in the 2024 program year (in the second half of 2024 and in early 2025).

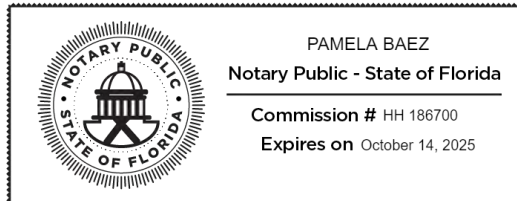

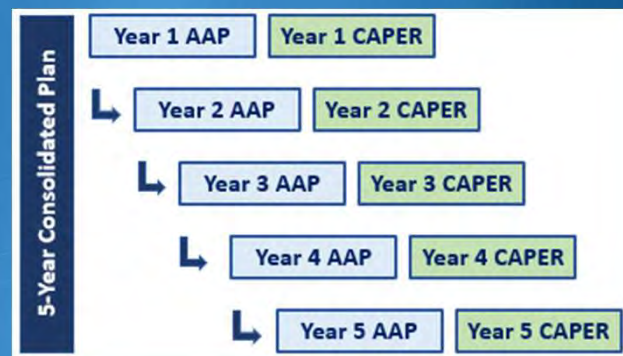

CDBG-funded projects:

1. Substantial rehabilitation of an emergency shelter's HVAC system – *project work is underway*
2. Operational support to maintain a neighborhood response team named the Homeless Engagement and Response Team (HEART), based out of the Downtown Engagement Center – *operations are underway*
3. Operational support of a fair housing specialist who will provide ongoing outreach, test coordination, and technical assistance on fair housing in Fargo – *project is underway*

Pre-2024 Activities with Accomplishments in 2024

Accomplishment Table Narrative

This CAPER covers the fifth year of the 2020-2024 Consolidated Plan. Some of the 2024 Action Plan activities are currently underway, but these 2024 activities do not have any accomplishments to report on for the 2024 program year (May 1, 2024 – April 30, 2025). The above table includes prior year activities that were accomplished in the 2024 program year. Below is a summary of these activities as well as the 2024 activities:

Affordable Housing (2020, 2021, 2022, 2023, & 2024)

HOME Funds – 2020 Action Plan

Cass Clay Community Land Trust (CCCLT) utilized 2020 HOME funds, for a 2020 Action Plan project titled *Affordable Single-Family Housing for Ownership*, to purchase the lot at 1412 1 Avenue South in June of 2021. A second lot, located at 1410 1 Avenue South, was transferred to the CCCLT in the fall of 2022. Construction of a twinhome (resulting in two units of affordable, single-family housing) was completed and a Certificate of Occupancy for each unit was issued in September of 2023. A ratified sales contract was executed by each income-qualified homebuyer in the spring/summer of 2024, and the closings with each homebuyer occurred in the 2024 program year (second half of 2024 and early 2025).

HOME Funds – 2021 Action Plan

HOME funds were used for new construction of a 42-unit affordable senior rental housing complex at 708 4 Avenue North in Fargo called “The Milton Earl” (under the 2021 Action Plan project titled *Multi-Family Rental*). In addition, 2021 HOME ‘set aside’ funds were also used for new construction of this affordable senior rental housing complex (under the 2021 Action Plan project titled *Community Housing Development Organization (CHDO) project*). Construction was completed and these activities were marked as complete in the 2024 program

year. Of this 42-unit rental housing complex, five (5) units are HOME units (3 units from the *Multi-Family Rental* project and 2 units from the *CHDO project*).

HOME Funds – 2022 Action Plan

As part of the 2022 Action Plan under a project titled *Affordable Single-Family Housing for Ownership*, Lake Agassiz Habitat for Humanity used HOME funds for new construction of an affordable, single-family housing unit at 2790 10 Avenue North. Construction was completed and a Certificate of Occupancy was issued in March of 2024. The closing between Habitat for Humanity and the homebuyers was held in early May 2024, at which time the land was deeded to the homebuyers.

CDBG Funds – 2023 Action Plan

CDBG funding in the amount of \$150,000 was allocated and set up as a 2023 Action Plan project title *Acquisition for Affordable Multi-Family Rental Housing Development*. This CDBG funding was to be utilized for acquisition of land for new construction of an affordable, multi-family rental housing complex in partnership with Beyond Shelter, Inc. at a location that was yet to be determined.

Due to extended delays and a reassessment of project feasibility, including capacity and risk analysis, this 2023 Action Plan project was canceled (through a recently-approved substantial amendment process) and CDBG funds were reallocated to proposed projects in the 2025 Action Plan.

HOME Funds – 2023 Action Plan

As part of the 2023 Action Plan under a project titled *Community Housing Development Organization (CHDO) project*, HOME ‘set aside’ funding in the amount of \$100,000 was to be utilized for creation of affordable housing in partnership with a CHDO at a location that was yet to be determined.

After reassessment of project feasibility, including capacity and risk analysis, this 2023 Action Plan project was canceled (through a recently-approved substantial amendment process) and HOME ‘set aside’ funds were reallocated to proposed projects in the 2025 Action Plan.

In addition, HOME funds in the amount of \$400,000 were allocated and set up as a 2023 Action Plan project titled *Affordable Single-Family Housing for Ownership*. This funding (\$400,000 of the \$550,000 in 2023 HOME funds that was allocated to this 2023 Action Plan project) was to be used by Lake Agassiz Habitat for Humanity towards new construction of an affordable, single-family residential twinhome (resulting in two housing units) at two, adjacent sites in Fargo (213 24 Street South and 221 24 Street South).

This proposed HOME-funded twinhome new construction activity is being canceled due to various federal constraints associated with larger-scale development, which contributed to extended project delays and lack of available, qualified contractors. These HOME funds

were reallocated to proposed, eligible projects outlined in the 2025 Action Plan (through a recently-approved substantial amendment process).

To note, there is still an “in progress” activity under the 2023 Action Plan project titled *Affordable Single-Family Housing for Ownership*. Lake Agassiz Habitat for Humanity is utilizing \$150,000 in 2023 HOME funds (the remainder of the \$550,000 in 2023 HOME funds that was originally allocated to this Action Plan project) for this project, which includes new construction of an affordable, single-family housing unit at 1714 5 Avenue South in Fargo. Completion of this housing unit and a closing with an income-eligible homebuyer will be done in the 2025 program year and will be reported on in the next CAPER.

CDBG Funds – 2024 Action Plan

CDBG funding in the amount of \$336,000 was allocated and set up as a 2024 Action Plan project title *Acquisition for Affordable Multi-Family Rental Housing Development*. This CDBG funding was to be utilized for acquisition of land for new construction of an affordable, multi-family rental housing complex in partnership with Beyond Shelter, Inc. at a location that was yet to be determined.

Due to extended delays and a reassessment of project feasibility, including capacity and risk analysis, this 2024 Action Plan project was canceled (through a recently-approved substantial amendment process) and CDBG funds were reallocated to proposed projects in the 2025 Action Plan.

HOME Funds – 2024 Action Plan

As part of the 2024 Action Plan, HOME funding in the amount of \$500,000 was allocated and set up as a 2024 Action Plan project titled *Affordable Multi-Family Rental Housing Development*. This project was to utilize HOME funds for new construction of an affordable, multi-family senior and elderly rental housing complex in partnership with Beyond Shelter, Inc. at a location that was yet to be determined.

In addition, HOME ‘set aside’ funding in the amount of \$95,000 was allocated and set up as a 2024 Action Plan project titled *Community Housing Development Organization (CHDO)*. This project was to utilize HOME funds for creation of affordable housing in partnership with a Community Housing Development Organization at a location that was yet to be determined.

Again, after reassessment of project feasibility, including capacity and risk analysis, these 2024 Action Plan projects were canceled (through a recently-approved substantial amendment process) and the HOME funds and HOME ‘set aside’ funds were reallocated to proposed projects in the 2025 Action Plan.

Homelessness (2019)/Ending and Preventing Homelessness (2023 & 2024)

CDBG-CV Funds – 2019 Action Plan (tied to 2020 Action Plan Program Year)

CDBG COVID funds continue to provide a *mobile homeless health services outreach program*. The funds helped support staffing for a mobile medical unit to provide flexible COVID-19 testing and treatment capabilities to homeless patients at various FM area shelters. The vehicle contains all of the necessary features to provide flexible, comprehensive testing and medical treatment to combat the COVID-19 disease in locations and populations that are traditionally more difficult to reach and serve. It also services as an alternative to the fixed Family Healthcare Homeless Services clinic. In the 2024 Action Plan program year, this activity served 46 low/moderate income persons in public housing or presumed to be homeless. Services have been delivered at several mobile outreach events at sites serving low/moderate income persons (e.g., homeless shelters and/or public housing sites).

CDBG Funds – 2023 Action Plan

The 2023 Action Plan includes a project titled *Downtown Engagement Center Operations*, which utilized 2023 CDBG funds to provide operational support to maintain a neighborhood response team, named the Homeless Engagement And Response Team (HEART), which is based out of Fargo Cass Public Health – Harm Reduction Division’s Downtown Engagement Center (located at 222 4 Street North in Fargo). The staff positions that make up the team provided street outreach services in the downtown neighborhood. This included, but was not limited to: 1) promoting and providing direct assistance in connecting individuals to resources related to housing, healthcare, substance use treatment, etc.; 2) building trust and relationships and developing a by-name list to capture the needs of individuals and enhance the ability to serve them; 3) responding to requests for crisis intervention and de-escalating from local law enforcement, downtown businesses, etc. for clients experiencing homelessness or another crisis; 4) conducting acuity assessments to assess risk of housing instability and service needs and/or the need to refer them to police or alternative interventions; and 5) additional services as approved by the City on a case-by-case basis. For the 2024 Program Year, this activity served 199 persons who were literally homeless, at-risk of homelessness, housed, or had unknown housing statuses, through targeted outreach by the HEART street outreach team.

CDBG Funds – 2024 Action Plan

The 2024 Action Plan includes a project titled *Downtown Engagement Center Operations*, which will utilize 2024 CDBG funds to provide operational support to the City of Fargo’s neighborhood response team, named the Homeless Engagement And Response Team (HEART), based out of the Fargo Cass Public Health – Harm Reduction Division’s Downtown Engagement Center. This project is currently underway and will have accomplishment to report in the 2025 CAPER.

In addition, CDBG funds are being utilized (as part of the 2024 Action Plan project titled *YWCA Cass-Clay Emergency Shelter Facility Improvements*) towards substantial rehabilitation of the YWCA Cass-Clay emergency shelter’s HVAC system (specifically replacement of heat pumps). Work on this project is currently underway.

Neighborhood Improvements and Initiatives (2023)

As part of the 2023 Action Plan project titled *Core Neighborhood Deteriorated Structure Removal*, CDBG funds were used for demolition to address and eliminate blighted conditions at four properties located in the Jefferson/Carl Ben, Madison, and Washington core neighborhoods of Fargo. This project was carried out by Cass Clay Community Land Trust. The demolitions at each of the four properties were completed by the end of the 2023 program year and, once the weather allowed, the filling, grading, and overlay of black dirt and grass seed for turf establishment at each site was completed in the 2024 program year. To note, there was \$110,140 in remaining, unexpended CDBG funds from this Action Plan project that were reallocated to proposed projects in the 2025 Action Plan that will benefit low to moderate income persons (this was included in a substantial amendment process that was recently completed).

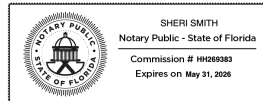

1b. **Cancel Community Housing Development Organization (CHDO) Project (HOME)** - \$100,000 in HOME 'set-aside' funds were to be used in partnership with a Community Housing Development Organization (CHDO) to create affordable housing in Fargo. The location of this project was yet to be determined. This activity's timeline has been delayed and therefore this 2023 Action Plan project is being canceled and funds reallocated to proposed projects in the 2025 Action Plan.

1. **Revise Core Neighborhood Deteriorated Structure Removal**

Project (CDBG) - Reduce project budget by \$110,140 in unexpended CDBG funds, to be reallocated to proposed projects within the 2025 Annual Action Plan.

2. **Cancel One Affordable Single-Family Housing for Ownership Project (HOME) and Reallocate Funds** - \$400,000 in HOME funds were to be used by Lake Agassiz Habitat for Humanity towards new construction of an affordable, single-family residential twinhome (resulting in two housing units) at two, adjacent sites in Fargo at 213 24 Street South and 221 24 Street South. Due to the various federal constraints tied to this larger-scale new construction build, contributing to delayed timelines and lack of available contractors, this proposed twinhome activity is being canceled and the funds reallocated to proposed projects in the 2025 Action Plan.

This activity's timeline has been delayed and therefore this 2024 Action Plan project is being canceled and funds reallocated to proposed projects in the 2025 Action Plan.

1b. **Cancel Affordable Multi-Family Rental Housing Project (HOME)** - \$500,000 in HOME funds were allocated in the 2024 Action Plan for new construction of affordable multi-family senior and elderly rental housing complex, in partnership with Beyond Shelter, Inc. The location of this project was yet to be determined. This activity's timeline has been delayed and therefore this 2024 Action Plan project is being canceled and funds reallocated to proposed projects in the 2025 Action Plan.

1c. **Cancel Community Housing Development Organization (CHDO) Project (HOME)** - \$95,000 in HOME 'set-aside' funds were to be used in partnership with a Community Housing Development Organization (CHDO) to create affordable housing in Fargo. The location of this project was yet to be determined. This activity's timeline has been delayed and therefore this 2024 Action Plan project is being canceled and funds reallocated to proposed projects in the 2025 Action Plan.

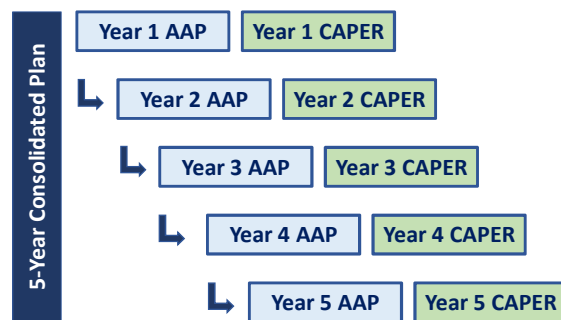




Background on HUD Plans & Programs

1. Every five years, the City creates a 5-Year Consolidated Plan ("Con Plan") that identifies housing and community development priorities.
2. Each year, the City creates an Annual Action Plan ("AAP") on how it will use its CDBG & HOME funding to fulfill the goals of the Con Plan.
3. Annually, the City reports on its progress through its Consolidated Annual Performance and Evaluation Report ("CAPER").

We are currently in the public comment period for Fargo's "draft" 2025-2029 Con Plan and 2025 Annual Action Plan (the 2025 Action Plan is Year 1 of Fargo's "draft" Con Plan).



Background on HUD Programs

There are two separate HUD programs that are funded:

1. Community Development Block Grant (CDBG)

Projects typically include activities to support housing or community programs and facilities, such as, but not limited to: public infrastructure/public facilities improvements, property acquisition, or homelessness services.

2. HOME Investment Partnerships Program (HOME)

Projects are solely focused on housing (i.e., single & multi-family, homeownership & rental). Specific activities typically include rehabilitation, tenant based rental assistance, construction, or demolition.

Goals Identified in Development of the 5-Year Con Plan

1. Affordable Housing (housing stability, housing preservation)
2. Ending & Preventing Homelessness (services for individuals with extremely low incomes)

Planning & Development Department staff has prepared the 2025-2029 Five Year Consolidated Plan and 2025 Action Plan for the use of U.S. Department of Housing and Urban Development (HUD) funds. A total of \$3,104,476.57 is anticipated to be available for the 2025 Community Development budget. In addition, staff are proposing amendments to the City's 2023 Action Plan and 2024 Action Plan.

During the hearing an overview of the proposed five-year goals, the proposed 2025 Community Development Block Grant (CDBG) and HOME projects, and the amendments to the 2023 Action Plan and 2024 Action Plan will be presented.

Details of the proposed 2025-2029 Consolidated Plan and 2025 Action Plan funding sources and projects, along with proposed amendments to the 2023 Action Plan and 2024 Action Plan are outlined in the public notice published in *The Forum* newspaper on June 18, 2025, and a version is attached as an exhibit for reference. Per the required and adopted Citizen Participation Plan, this proposal is being presented at the July 7, 2025 City Commission meeting as a Public Hearing. The timeline, including the 30-day public comment period, June 19 – July 18, 2025, is outlined in the public notice. Once approved locally, the 2025-2029 Consolidated Plan and 2025 Action Plan, 2023 Action Plan amendments, and 2024 Action Plan amendments, along with all comments received, will be submitted to HUD for federal approval.

The 2025-2029 Consolidated Plan and 2025 Action Plan have been drafted in compliance with federal regulations. The draft plans are available on the City website at www.FargoND.gov/plansandstudies (posted June 18, 2025). No action is intended for the July 7, 2025 City Commission meeting. Staff will confirm public input received during the



public hearing and through the open comment period as we seek action at the July 21, 2025 City Commission meeting.

Recommended Motion: No action is required at this time; public hearing only. Final consideration of the 2025-2029 Consolidated Plan and 2025 Action Plan, and proposed amendments to the 2023 Action Plan and 2024 Action Plan, is scheduled for July 21, 2025.

The public comment period begins on June 19, 2025 and includes a public hearing on Monday, July 7, 2025 during the regular Fargo City Commission meeting. All items will be given final consideration at the July 21, 2025 City Commission meeting. Comments on these draft plans should be provided during the public comment period (June 19 through July 18, 2025). Each item is summarized in this notice.

2025 – 2029 HUD CONSOLIDATED PLAN

The City of Fargo has available for public review and comment a draft Five-Year Consolidated Plan for the use of U.S. Housing and Urban Development (HUD) funds for Program Years 2025–2029 (May 1, 2025 to April 30, 2030). The Consolidated Plan includes the Program Year 2025 budget and allocation (May 1, 2025 to April 30, 2026). The exact amount of HUD funds each year is determined by Congress, but based on previous funding levels, the City estimates approximately \$4,374,305 in CDBG funds and \$2,286,518 in HOME funds over the course of the Five-Year Consolidated Plan.

The Consolidated Plan provides information about the housing and non-housing community development needs in the City and includes a five-year strategy to address those needs, emphasizing benefit to low- and moderate-income persons and households.

The City of Fargo encouraged residents and stakeholders to participate in developing the 2025-2029 Consolidated Plan and 2025 Action Plan through multiple outreach methods, including a public input meeting held on June 10, 2025. The following priority areas were identified through this public participation: rental assistance, affordable housing, public infrastructure and public facilities improvements, and public services for low-and moderate-income households and the homeless populations. The Consolidated Plan addresses these needs in three goals: (1) affordable housing, (2) ending and preventing homelessness, and (3) public infrastructure and public facilities improvements.

2025 HUD ACTION PLAN

The City of Fargo has prepared a draft version of the 2025 HUD Action Plan for Housing and Community Development for the Community Development Block Grant (CDBG) and HOME Programs. The Action Plan provides a summary of actions, activities, and specific federal and non-federal resources that will be used during the year to address priority needs and goals identified in the Consolidated Plan and plans for allocating the U.S. Department of Housing and Urban Development Office of Community Planning and Development (CPD) formula block grant programs: Community Development Block Grant and HOME Investment Partnerships Program. The Action Plan describes how the funds from these programs will be distributed during the 2025 program year, which begins on May 1, 2025. Funds are expected to be made available to the City by the end of 2025.

This activity's timeline has been delayed and therefore this 2024 Action Plan project is being canceled and funds reallocated to proposed projects in the 2025 Action Plan.
- 1b. Cancel Affordable Multi-Family Rental Housing Project (HOME) – \$500,000 in HOME funds were allocated in the 2024 Action Plan for new construction of affordable multi-family senior and elderly rental housing complex, in partnership with Beyond Shelter, Inc. The location of this project was yet to be determined. This activity's timeline has been delayed and therefore this 2024 Action Plan project is being canceled and funds reallocated to proposed projects in the 2025 Action Plan.
- 1c. Cancel Community Housing Development Organization (CHDO) Project (HOME) – \$95,000 in HOME 'set-aside' funds were to be used in partnership with a Community Housing Development Organization (CHDO) to create affordable housing in Fargo. The location of this project was yet to be determined. This activity's timeline has

been delayed and therefore this 2024 Action Plan project is being canceled and funds reallocated to proposed projects in the 2025 Action Plan.

Following the required 30-day public comment period and Public Hearing held during the July 7, 2025 City Commission meeting, staff is seeking approval of the proposed 2025-2029 Five Year Consolidated Plan and 2025 Action Plan for Community Development Block Grant (CDBG) and HOME programming and expenditures. In addition, staff have proposed amendments to the City's 2023 Action Plan and 2024 Action Plan. To date, 2 comments have been received during the public comment period (a summary of comments received is attached).

The proposed 2025-2029 Consolidated Plan and 2025 Action Plan, and amendments to the 2023 Action Plan and 2024 Action Plan, have been drafted in compliance with federal regulations for the U.S. Department of Housing and Urban Development (HUD) CDBG and HOME programs and are detailed in the public notice, which was published in *The Forum* newspaper on June 18, 2025 (a version is attached as an exhibit for reference). The draft plans are also available on the City website at www.FargoND.gov/plansandstudies (posted June 18, 2025).

Upon approval by the City Commission, the 2025-2029 Consolidated Plan and 2025 Action Plan, 2023 Action Plan amendments, and 2024 Action Plan amendments, along with all comments received, will be submitted to HUD for federal approval.

Recommended Action: Approve the 2025-2029 Consolidated Plan and 2025 Action Plan for HUD Community Development Block Grant (CDBG) / HOME Investment Partnerships Program (HOME) funding, and proposed amendments to the 2023 Action Plan and 2024 Action Plan, and authorize submittal to the U.S. Department of Housing and Urban Development.

The City of Fargo announces the opening of the 30-day public comment period for Fargo's 2025-2029 Consolidated Plan and 2025 Action Plan, and amendments to Fargo's 2023 Action Plan and 2024 Action Plan. The public comment period begins on June 19, 2025 and includes a public hearing on Monday, July 7, 2025 during the regular Fargo City Commission meeting. All items will be given final consideration at the July 21, 2025 City Commission meeting. Comments on these draft plans should be provided during the public comment period (June 19 through July 18, 2025). Each item is summarized in this notice.

2025 – 2029 HUD CONSOLIDATED PLAN

The City of Fargo has available for public review and comment a draft Five-Year Consolidated Plan for the use of U.S. Housing and Urban Development (HUD) funds for Program Years 2025–2029 (May 1, 2025 to April 30, 2030). The Consolidated Plan includes the Program Year 2025 budget and allocation (May 1, 2025 to April 30, 2026). The exact amount of HUD funds each year is determined by Congress, but based on previous funding levels, the City estimates approximately \$4,374,305 in CDBG funds and \$2,286,518 in HOME funds over the course of the Five-Year Consolidated Plan.

The Consolidated Plan provides information about the housing and non-housing community development needs in the City and includes a five-year strategy to address those needs, emphasizing benefit to low- and moderate-income persons and households.

The City of Fargo encouraged residents and stakeholders to participate in developing the 2025-2029 Consolidated Plan and 2025 Action Plan through multiple outreach methods, including a public input meeting held on June 10, 2025. The following priority areas were identified through this public participation: rental assistance, affordable housing, public infrastructure and public facilities improvements, and public services for low-and moderate-income households and the homeless populations. The Consolidated Plan addresses these needs in three goals: (1) affordable housing, (2) ending and preventing homelessness, and (3) public infrastructure and public facilities improvements.

2025 HUD ACTION PLAN

The City of Fargo has prepared a draft version of the 2025 HUD Action Plan for Housing and Community Development for the Community Development Block Grant (CDBG) and HOME Programs. The Action Plan provides a summary of actions, activities, and specific federal and non-federal resources that will be used during the year to address priority needs and goals identified in the Consolidated Plan and plans for allocating the U.S. Department of Housing and Urban Development Office of Community Planning and Development (CPD) formula block grant programs: Community Development Block Grant and HOME Investment Partnerships Program. The Action Plan describes how the funds from these programs will be distributed during the 2025 program year, which begins on May 1, 2025. Funds are expected to be made available to the City by the end of 2025.

Planning, Administration & Fair Housing

1. CDBG Planning and Administration - \$122,000 in CDBG funds. Planning, implementation, reporting, and monitoring of CDBG resources. Prior year admin dollars may be used for startup planning and administration costs in future years. *National Objective: Not applicable for administration. Eligibility & Regulation Citation: 21A General Program Administration, 24 CFR Part 570.206(a).*
2. HOME Planning and Administration - \$42,000 in HOME funds. Planning, implementation, reporting, and monitoring of HOME resources. Prior year admin dollars may be used for startup planning and administration costs in future years. *National Objective: Not applicable for administration.*
3. Fair Housing - \$45,000 in CDBG funds. Support a part-time fair housing specialist who will provide ongoing outreach, test coordination, and technical assistance in Fargo, ND. This includes comprehensive outreach and fair housing education as part of the requirement to affirmatively further fair housing under the Fair Housing Act (42 U.S.C. 3601-20). *Eligibility & Regulation Citation: 21D Fair Housing Activities (subject to 20% Admin. Capital/Neighborhood Improvements

Affordable Housing

1. Tenant Based Rental Assistance - \$1,565,000 in HOME funds. Assist eligible households with their rental housing expenses. *HOME Eligible Activity under 24 CFR Part 92.205(a)(1).*

Contingency Funds

1. Contingency - Funds held in contingency for issues that may arise during the program year – \$4,461.25 CDBG funds and \$5,015.32 HOME funds.

CONTINGENCY PROVISIONS/POTENTIAL ADJUSTMENTS TO 2025 ACTIVITIES & BUDGET

- Budget adjustments transferring amounts greater than 10% of the amount allocated to the City's entitlement grant programs for program year 2025 are considered substantial amendments and will be implemented in accordance with Fargo's Citizen Participation Plan (www.fargond.gov).
- Unanticipated program income may result in a substantial amendment to amend activities and budgets in accordance with Fargo's Citizen Participation Plan.
- Any unused funds will be reallocated in an amendment or the following year's action plan, either of which require a 30-day public comment period.

PROPOSED AMENDMENTS TO 2023 HUD ACTION PLAN

- 1a. Cancel Acquisition for Affordable Multi-Family Rental Housing Project (CDBG) - \$150,000 in CDBG funds were allocated in the 2023 Action Plan for acquisition of land for new construction of an affordable multi-family rental housing complex in partnership with Beyond Shelter, Inc. The location of this project was yet to be determined. This activity's timeline has been delayed and therefore this 2023 Action Plan project is being canceled and funds reallocated to proposed projects in the 2025 Action Plan.
- 1b. Cancel Community Housing Development Organization (CHDO) Project (HOME) - \$100,000 in HOME 'set-aside' funds were to be used in partnership with a Community Housing Development Organization (CHDO) to create affordable housing in Fargo. The location of this project was yet to be determined. This activity's timeline has been delayed and therefore this 2023 Action Plan project is being canceled and funds reallocated to proposed projects in the 2025 Action Plan.
2. Revise Core Neighborhood Deteriorated Structure Removal Project (CDBG) – Reduce project budget by \$110,140 in unexpended CDBG funds, to be reallocated to proposed projects within the 2025 Annual Action Plan.
3. Cancel One Affordable Single-Family Housing for Ownership Project (HOME) and Reallocate Funds - \$400,000 in HOME funds were to be used by Lake Agassiz Habitat for Humanity towards new construction of an affordable, single-family residential twinhome (resulting in two housing units) at two, adjacent sites in Fargo at 213 24 Street South and 221 24 Street South. Due to the various federal constraints tied to this larger-scale new construction build, contributing to delayed timelines and lack of available contractors, this proposed twinhome activity is being canceled and the funds reallocated to proposed projects in the 2025 Action Plan.

PROPOSED AMENDMENTS TO 2024 HUD ACTION PLAN

- 1a. Cancel Acquisition for Affordable Multi-Family Rental Housing Project (CDBG) - \$336,000 in CDBG funds were allocated in the 2024 Action Plan for acquisition of land for new construction of an affordable multi-family rental housing complex in partnership with Beyond Shelter, Inc. The location of this project was yet to be determined. This activity's timeline has been delayed and therefore this 2024 Action Plan project is being canceled and funds reallocated to proposed projects in the 2025 Action Plan.

- 1b. Cancel Affordable Multi-Family Rental Housing Project (HOME) – \$500,000 in HOME funds were allocated in the 2024 Action Plan for new construction of affordable multi-family senior and elderly rental housing complex, in partnership with Beyond Shelter, Inc. The location of this project was yet to be determined. This activity’s timeline has been delayed and therefore this 2024 Action Plan project is being canceled and funds reallocated to proposed projects in the 2025 Action Plan.
- 1c. Cancel Community Housing Development Organization (CHDO) Project (HOME) – \$95,000 in HOME ‘set-aside’ funds were to be used in partnership with a Community Housing Development Organization (CHDO) to create affordable housing in Fargo. The location of this project was yet to be determined. This activity’s timeline has been delayed and therefore this 2024 Action Plan project is being canceled and funds reallocated to proposed projects in the 2025 Action Plan.
