 The Commercial General Liability and Automobile policies shall contain a "Waiver of Subrogation" to waive any right of recovery that the Insurance Company may have against KLJ Engineering LLC and the Owner.

2) No firearms, no tobacco and no music are allowed on the premises. All city ordinances must be complied with.

3) A temporary sheetrock or plywood wall will be installed from the entry vestibule to the glass partition to the east as a means to separate the work area from the lobby where the general public will be.

4) The staging area will be located in the West lot as designated below. The dumpster should be placed on the south end in the area indicated by the blue box. The contractors may park trailers and vehicles in this lot with the exception of the visitor parking spots indicated by the red hatched area. The south entrance to the lot must remain clear and visitors must have adequate room to enter and exit the designated parking spots with their vehicles.



5) Additional information was obtained regarding the installation of the granite piece currently located on the East wall. The granite was glued to the wall and removal could jeopardize the piece. Based on this information, the decision has been made to leave the granite and the veneer panels as is. Bid Alternate 1 is removed from the scope of this bid. A Revised Fee Proposal Form is included in this addendum and replaces the previous Bid Form in the RFP.

6) Clarification of the statement "The proposal will include all fees required to complete the project as described in the RFP" in Section III.C. This means that the Base Bid

should be a complete price including all subcontractor prices, permit costs, and other fees.
