Bids shall be on the basis of cash payment for work performed. All work included in the contract must be fully completed on or before December 15, 2021

Bids must be in a sealed envelope plainly marked "Landfill Gas Wellfield Expansion Project SW 21-01", and attached to the outside of the bid envelope must be **A SEPARATE ENVELOPE CONTAINING A LIST OF ALL ADDENDA TO THE PLANS AND SPECIFICATIONS AND AN ACKNOWLEDGEMENT BY THE BIDDER OF RECEIPT OF SUCH ADDENDA. THE SEPARATE ENVELOPE SHALL ALSO CONTAIN A CONTRACTORS LICENSE, And A BIDDER'S BOND IN THE AMOUNT OF 5% OF THE FULL AMOUNT OF THE BID** executed by the bidder as principal and by a surety, conditioned that if the principal's bid is accepted and the contract awarded to the principal, the principal, within 10 days after notice of award, shall execute a contract in accordance with the terms of the bid and a contractor's bond as required by law and the regulations and determinations of the governing body. Countersignature of a bid bond is not required under this section.

All bidder's, except a bidder on a municipal, rural, and industrial water supply project authorized for funding under public law No. 99-294 [100 Stat. 426; 43 U.S.C. 390a], must be licensed for the full amount of the bid, as required by section 43-07-05. A copy of the contractor's license or certificate of renewal thereof, issued by the secretary of state, **must** be enclosed in the bid bond envelope as required under North Dakota Century Code section 43-07-12.

No bid may be read or considered if it does not fully comply with these requirements and any deficient bid submitted must be resealed and returned to the bidder immediately.
