Resolution Adopted Establishing the Truck Routes Within the City of Fargo as Shown on the Official Truck Route Map (Attachment "C"):

The Board received a communication from Assistant City Attorney Nancy Morris stating the resolution relates to the establishing of truck routes within the City of Fargo as shown on the Official Truck Route Map (Revised April 2012) which is attached to the Resolution.

Engineering Tech Supervisor Al Schumacher said in order to officially change the routes the City has to pass a Resolution. The map includes new streets that have been put in, he said, and the City may want to approve a new map on a yearly basis.

Commissioner Williams offered the following Resolution and moved its adoption:

BE IT RESOLVED BY THE BOARD OF CITY COMMISSIONERS OF THE CITY OF FARGO:

WHEREAS, The electorate of the City of Fargo has adopted a Home Rule Charter in accordance with Chapter 40-05.1 of the North Dakota Century Code; and

WHEREAS, Section 40-05.1-06 of the North Dakota Century Code provides that the City shall have the right to implement home rule powers by Ordinance; and

WHEREAS, Article 3(G) of the Home Rule Charter of the City of Fargo, North Dakota grants the City of Fargo power to provide for the adoption, amendment and repeal of Ordinances and Resolutions, and regulations to carry out its governmental and proprietary powers and to provide for public health, safety, morals and welfare, and penalties for a violation thereof; and

WHEREAS, The Board of City Commissioners, Fargo, North Dakota, pursuant to authority granted to it under Home Rule, has adopted and approved an Ordinance to establish such rules and regulations as are necessary to restrict truck and commercial vehicle traffic in the City of Fargo; and

WHEREAS, Section 8-0923 of the Fargo Municipal Code provides that the truck routes shall be established by Resolution of the Board of City Commissioners, after notice and hearing.

NOW, THEREFORE, BE IT RESOLVED, By the Board of City Commissioners of the City of Fargo, North Dakota:

Truck routes in the City of Fargo are established as shown on the Official Truck Route Map (Revised April 2012) attached hereto and incorporated herein.

Second by Wimmer. On the vote being taken on the question of the adoption of the Resolution Commissioners Williams, Wimmer, Piepkorn, Mahoney and Walaker voted aye.

No Commissioner being absent and none voting nay, the Resolution was adopted.

Resolution Approving of the Issuance of University Facilities Revenue Refunding Bonds, Series 2012A (NDSU Development Foundation Project):

The Board received a communication from Finance Director Kent Costin stating a public hearing is required under existing bond regulations. The refinancing of the bonds is for interest savings, he said.

Jim Stewart, representing the NDSU Development Foundation, said the bond proceeds will be used to pay off the 2007 series of bonds which were used to finance Barry and Klai Hall.

Commissioner Wimmer moved the Resolution entitled "Resolution Approving of the Issuance of University Facilities Revenue Refunding Bonds, Series 2012A (NDSU Development Foundation Project) and referred to as Attachment "D", be adopted and attached hereto.

Second by Mahoney. On call of the roll Commissioners Wimmer, Mahoney, Williams, Piepkorn and Walaker voted aye.

No Commissioner being absent and none voting nay, the motion was declared carried.

Commissioner Mahoney moved that the Board adjourn to 5:00 o'clock p.m., Monday, May 14, 2012.

Second by Piepkorn. All the Commissioners voted aye and the motion was declared carried.
