No Commissioner being absent and none voting nay, the motion was declared carried.

Conversion of Existing 90 Minute Parking on First Avenue South from 4th Street to 8th Street to Two Hour Parking Approved:

The Board received a communication from Planner Joe Nigg stating in May the Parking Commission directed staff to work with the newly established Downtown Parking Task Force to analyze a request to convert the existing 90 minute parking on First Avenue South between 4th Street and Broadway from a 90 minute zone to a 2 hour zone. He said the Parking Commission felt it beneficial to consider adjacent parking zones and usage, in addition to other dynamics. According to the on-street occupancy data outlined within the 2012 Parking Evaluation Study, he said, peak hour

(11 a.m.) occupancy on this block is 37 percent. For comparison purposes, Broadway has an on-street occupancy rate of 76 percent, he said, and the entire downtown core is at approximately 54 percent usage during peak hours. He said the 2012 study documents this block as having a parking surplus largely due to the public ramp on this block. At the August 19, 2013 Task Force meeting, he said, a recommendation was set forth to convert all existing 90 minute parking on both the north and south side of First Avenue from 4th Street to 8th Street to two hour parking. The Parking Commission supported this proposed revision and at their August 31, 2013 meeting recommended approval of the change. He said this change aligns the time zones more closely with the enforcement schedules/routes, creates more consistency on these blocks and should encourage increased use of the on-street spaces, as well as addressing the YMCA's concerns regarding the adjacent on-street time zones.

Commissioner Williams moved the conversion of all existing 90 minute parking on both the north and south side of First Avenue South from 4th Street to 8th Street to two hour parking be approved.

Second by Wimmer. On call of the roll Commissioners Williams, Wimmer, Sobolik, Mahoney and Walaker voted aye.

No Commissioner being absent and none voting nay, the motion was declared carried.

Communication Regarding the Board of Adjustment Received and Filed:

The Board received a communication from Board of Adjustment Chair Dr. Kenneth Lepper stating recent decisions made by the Board of Adjustment (BOA) for variances to the Land Development Code (LDC) have been overturned by the City Commission. He said the intended function of the Board of Adjustment is to hear requests from citizens or organizations who would like to undertake projects not in compliance with the LDC. The panel of five volunteer citizens is well suited to evaluate the potential effect of projects, he said, and if the Board of Adjustment rejects a request for a variance, the requestor has the right to appeal the decision to the City Commission. Over the past two to three years, the BOA has rejected several requests for three stall garages in the City's heritage neighborhoods, he said, and at least two requests to destroy vintage homes and replace them with other construction. These are very contentious issues for neighborhood citizens, he said, and the LDC does not adequately address these problems. The City Commission has overturned most of these decisions made by the BOA, he said, which in effect circumvents the purpose of the Board and renders the volunteer service non-productive. He suggested the BOA be dissolved and the Planning Department staff revise the LDC such that all requests for variances be taken directly to the City Commission. If the Commission feels the BOA does have a function, and the BOA volunteers can serve the City, he said, an option would be that the Commission work to uphold the decisions of the BOA involving heritage neighborhoods, particularly when requests for variances involve three stall garages and the destruction of vintage homes.

Commissioner Mahoney said the Board of Adjustment does a great job and he would not be in favor of dissolving the Board. He said the City Commission values the work and guidance of the BOA and he asked that Mr. Lepper reconsider his request.

Mayor Walaker said the BOA does a great job and he would not be in favor of dissolving the Board. He said in the future it may be helpful to get more information from the BOA on controversial issues.

Commissioner Wimmer moved the communication from Dr. Kenneth Lepper regarding the Board of Adjustment be received and filed.

Second by Sobolik. On call of the roll Commissioners Wimmer, Sobolik, Williams, Mahoney and Walaker voted aye.

No Commissioner being absent and none voting nay, the motion was declared carried.

Renaissance Zone Project for Jay and Christina Taylor Approved:

A Hearing had been set for this day and hour to receive comments on a Renaissance Zone Project for Jay and Christina Taylor at 300 Broadway North, Suite 205.

No written protest or objection to the Project has been received or filed in the City Auditor's Office.

The Board determined that no person is present to protest or offer objection to the Project.

The Board received a communication from Planner Joe Nigg stating the Renaissance Zone Project application presented by Jay and Christina Taylor meets all of the minimum criteria set forth in the Renaissance Zone Plan and is consistent with the established goals and objectives. Mr. Nigg recommended that the project be approved.

Commissioner Sobolik moved the Renaissance Zone application filed by Jay and Christina Taylor for a project located at 300 Broadway North, Suite 205 be approved and the income tax and property tax exemptions be granted as recommended by the Renaissance Zone Authority.

Second by Wimmer. On call of the roll Commissioners Sobolik, Wimmer, Williams, Mahoney and Walaker voted aye.

No Commissioner being absent and none voting nay, the motion was declared carried.

Parcels of Land in Cottagewood First Addition Rezoned (5080 38th Street South):

At a Hearing held on May 7, 2013 the Fargo Planning Commission recommended approval of a change in zoning from AG, Agricultural to SR-2, Single-Dwelling, SR-4, Single-Dwelling, MR-3, Multi-Dwelling and P/I, Public and Institutional of the proposed Cottagewood First Addition.

The City Auditor's Office published a Notice of Hearing stating September 3, 2013 was the time and date set for said Hearing at which time all interested persons could appear and would be heard.

At the September 3, 2013 meeting the Hearing was continued to this day and hour.

Commissioner Sobolik offered the following Resolution and moved its adoption:

WHEREAS, All legal requirements in connection with the above-described request for rezoning have been complied with; and

WHEREAS, There have been no written or verbal protests to the request for rezoning and no one is present to protest thereto.

NOW, THEREFORE, BE IT RESOLVED, That the findings of staff be accepted and the rezoning be approved on the basis that the proposal satisfactorily complies with the Comprehensive Plan, Standards of Section 20-0906.F (1-4) and all other applicable requirements of the LDC.

Second by Wimmer. On the vote being taken on the question of the adoption of the Resolution Commissioners Sobolik, Wimmer, Williams, Mahoney and Walaker voted aye.

No Commissioner being absent and none voting nay, the Resolution was adopted.

First Reading of an Ordinance Rezoning Certain Parcels of Land Lying in Cottagewood First Addition, Fargo, Cass County, North Dakota:

Commissioner Sobolik moved the requirement relating to receipt of the Ordinance by the Commission one week prior to first reading be waived and that the Ordinance Rezoning Certain Parcels of Land Lying in Cottagewood First Addition, Fargo, Cass County, North Dakota be placed on first reading.

Second by Wimmer. On call of the roll Commissioners Sobolik, Wimmer, Williams, Mahoney and Walaker voted aye.

No Commissioner being absent and none voting nay, the motion was declared carried.

Resolution Adopted Approving Cottagewood First Addition:

Commissioner Sobolik offered the following Resolution and moved its adoption:

BE IT RESOLVED BY THE BOARD OF CITY COMMISSIONERS OF THE CITY OF FARGO:

WHEREAS, A Plat has been filed in the office of the City Auditor entitled "Cottagewood First Addition" containing 104 Lots, 5 Blocks, and 52.020 acres of land more or less, located at 5080 38th Street South; and

WHEREAS, A Hearing was held May 7, 2013 by the Fargo Planning Commission, and notice of such Hearing had been published, as required by law, and said Plat had been approved by the Fargo Planning Commission and by the City Engineer; and

WHEREAS, The City Auditor's Office published a Notice of Hearing on said Plat in the official newspaper for the City of Fargo on August 19 and 26, 2013 that a Hearing would be held in the City Commission Room, City Hall, Fargo, North Dakota at 5:15 p.m., September 3, 2013 at which time said Plat would be considered and all interested persons would be heard. At the September 3, 2013 City Commission meeting, the Hearing was continued to September 16, 2013.

NOW, THEREFORE, BE IT RESOLVED, That the findings and recommendations of staff and the Planning Commission be accepted and the Plat entitled "Cottagewood First Addition" be and the same is hereby in all things affirmed and approved on the basis that it complies with the Standards of Article 20-06, and all other applicable requirements of the Land Development Code, and that the Mayor of the City of Fargo and the appropriate City Officials are hereby directed to endorse their approval on the Plat and then direct Petitioner to file same for record in the Office of the Recorder of Cass County, North Dakota.

Second by Wimmer. On the vote being taken on the question of the adoption of the Resolution Commissioners Sobolik, Wimmer, Williams, Mahoney and Walaker voted aye.

No Commissioner being absent and none voting nay, the Resolution was adopted.

Access, Right-of-Way and Utility Easement Agreement for Cottagewood First Addition Approved:

Commissioner Sobolik moved the Access, Right-of-Way and Utility Easement Agreement for Cottagewood First Addition be approved.

Second by Wimmer. On call of the roll Commissioners Sobolik, Wimmer, Williams, Mahoney and Walaker voted aye.

No Commissioner being absent and none voting nay, the motion was declared carried.

Hearing on a Petition for Annexation of 22.10 Acres of Land Located in Section 5, Township 138 North, Range 49 West in Stanley Township and Within the Extraterritorial Area Continued to September 30, 2013:

A Hearing had been set for June 24, 2013 on a petition for annexation of 22.10 acres of land located in Section 5, Township 138 North, Range 49 West in Stanley Township and within the extraterritorial area.

At the June 24, 2013, the Hearing was continued to July 22, 2013.

At the July 22, 2013 meeting, the Hearing was continued to August 5, 2013.

At the August 5, 2013 meeting, the Hearing was continued to August 19, 2013.

At the August 19, 2013 meeting, the Hearing was continued to this day and hour; however, Planning Administrator Nicole Crutchfield is requesting the Hearing be continued to September 30, 2013.

Commissioner Sobolik moved the Hearing be continued to 5:15 o'clock p.m. Monday, September 30, 2013.

Second by Wimmer. On call of the roll Commissioners Sobolik, Wimmer, Williams, Mahoney and Walaker voted aye.

No Commissioner being absent and none voting nay, the motion was declared carried.

Hearing on a Petition for a Zoning Change, Plat of Ashwood Fourth Addition and Street Vacation Continued to September 30, 2013 (6050 Unit A County Road 17; 6705 56th Avenue South; 6691, 6696, and 6684 58th Avenue South; 6722, 6746, 6770, 6797, 6775, 6741, and 6719 Smylie Lane South; 6680, 6683, 6694, 6699, 6708, 6711, 6724, and 6729 59th Avenue South; and 5773 and 5791 67th Street South):

This was the time and date set for a Hearing on a petition for a zoning change from AG, Agricultural and SR-2, Single-Dwelling to SR-2, Single-Dwelling; Plat of Ashwood Fourth Addition and Street Vacation of part of 67th Street South, 58th Avenue East, 59th Avenue East and Smylie Lane; however, Planning Administrator Nicole Crutchfield said two more weeks are needed to meet advertising requirements.

Commissioner Sobolik moved the Hearing be continued to 5:15 o'clock p.m. Monday, September 30, 2013.

Second by Wimmer. On call of the roll Commissioners Sobolik, Wimmer, Williams, Mahoney and Walaker voted aye.

No Commissioner being absent and none voting nay, the motion was declared carried.

Recommendation to Establish a Single Management Model for the Gladys Ray Emergency Homeless Shelter and the Detox Center Approved:

The Board received a communication from City Administrator Pat Zavoral stating for the past four years the City's Detox Center and the Gladys Ray Emergency Homeless Shelter have operated within the same facility at 1st Avenue South and 15th Street under separate management arrangements. Detox staff, he said, is employed by Centre, Inc., a non-profit agency, while the emergency shelter staff has employment contracts directly with the City. Since 2012, he said, an ad hoc city staff group made up of Police Chief Keith Ternes, Public Health Director Ruth Bachmeier, Community Development Administrator Dan Mahli, and himself have been meeting with various stakeholders to determine if there is a better management or program model to address the issues these two services encounter. Homelessness, mental health and alcohol related illnesses appear to be on the rise for some of the less fortunate in the community, he said, and the City is seeing a revolving door for these services by some people who cannot seem to break the cycle. The ad hoc committee, he said, has concluded that some changes to the current Shelter/Detox model are necessary and the start would be to have a single point of management for this facility. He said the Committee is recommending that the current Shelter Administrator be the manager for the facility and programs, and all of the employees for these programs become City employees and the Shelter/Detox facility and staff become part of the Public Health portfolio of services offered to the community. From this model, he said, it is envisioned that clients in need of these services will receive assistance from staff in how to access local, state and federal support for their problems. He said this referral concept will hopefully reduce the number of times a person needs emergency shelter or detoxification support. In addition, he said, it is hoped that the revenue for these services will increase through development of a rate structure for those using the services. Currently, he said, the City of Fargo has the only Shelter/Detox facility in the metro area and this region of the state and other communities and counties in the area (sometimes the state) bring or send their clients to Fargo without paying for this service. The next step for the City, he said, is to accept the recommendations of the committee and if it is accepted, the changes would take place on January 1, 2014, the start of the City's fiscal year. He said given the current level of funding for these services, it will not be necessary to adjust the budgets for 2014 as presented in the Mayor's budget.

Director of Public Health Ruth Bachmeier said mental health issues, alcoholism and drug use are huge issues in the community. She said many detox facilities are seeing a reoccurrence from individuals who are not able to or equipped with the tools to make significant changes in their lives. For chronic long-term addicts, she said, the City needs to be able to reach those individuals and as a community, the issues of drugs, mental health and alcoholism need to be addressed. She said putting these programs under the Health Department umbrella is the first step in taking a larger, community-wide look at the ever increasing problem of mental health and drug

dependency issues. In order for the community to get to the root of the issues, more needs to be offered, she said.

Chief of Police Keith Ternes said what has been a significant concern of his and within the police department is the number of admissions into the Detox Center. He said a large number of the people being admitted into the facility need the service on a continual basis. He said from an effectiveness and efficiency standpoint, it makes a lot of sense to combine these services so as to stabilize, if not minimize, the number of admissions. He said there is a lot of room for improvement in terms of how the City attempts to handle this situation; however, this is the first step in stopping the constant revolving door.

Jan Eliassen, Gladys Ray Shelter, said when individuals come to the shelter, the number one focus of staff is to make a relationship with the individuals because without that connection, the shelter employees cannot make the connection to local services that the shelter hopes to make. She said what she has found is the majority of the folks who come to the shelter, even those that are chronic in terms of addiction and mental health, are able to connect to services and quite often that results in housing and improved situations. Some of the folks that they deal with, she said, are so incredibly chronic that they need to stabilize them for a longer period of time than what is currently being offered. She said it is really difficult to connect people to services if they are still experiencing some of the physical challenges related to withdrawal. She said this is not a medical detox; however, it can provide an improved possibility for an individual to connect to the necessary services.

At 6:00 p.m., the time advertised for public hearings, the Board deferred additional discussion on this item until after the hearings.
