

## MINUTES OF THE FARGO DOME AUTHORITY MEETING

A regular meeting of the Fargo Dome Authority was held on Tuesday, May 28, 2024 at 3:30 p.m. in the FARGODOME Conference Room with President David Suppes presiding.

President David Suppes called the meeting to order at 3:32 p.m.

Michael Ellingson made a motion, seconded by Rick Steen, to approve the agenda of the May 28, 2024 Fargo Dome Authority meeting as presented. Motion carried.

Nancy Jordheim made a motion, seconded by Dan Armbrust, to approve the minutes from the April 30, 2024 Fargo Dome Authority meeting. Motion carried.

Rob Sobolik presented the General Manager's report as follows:

- Year-to-Date Net Income through April 2024 is stated at \$333,602 which is a positive variance (to budget) of \$191,113.  
Upon review, Michael Ellingson made a motion, seconded by Rick Steen, to approve the April 2024 financial statements as presented.

The Building and Finance Committees each accepted a motion to approve the 2025 Capital Budget as presented.
- Rob presented the 2024 capital budget (Including prior year's carryover). Please see attached memo. Rob requested a motion to re-allocate \$224,915 from projects FD2405, FD2221, FD2411 and FD 2205 to projects FD2418, FD2419, FD2420, FD2421, FD2422, FD 2215 and FD1614 as presented in the memo.  
The Building and Finance Committees each accepted a motion to approve the above re-allocation request.
- April 2024 Financial Statements: The April 2024 Financial Statements were approved by the Finance Committee at the meeting on May 22, 2024.
- Project and Capital Budget Updates:
  - Football Turf: AstroTurf has completed the repairs to the turf. Additional items to further address issues with turf conversions were addressed in the above capital budget re-allocation request.
  - Loading Dock Ramp Upper Drain Trench Project: Work on this project began on May 22, 2024.
- Escrow Balance & Performance Reports: The FARGODOME permanent fund performance, year-to-date, through March 2024 is 9.71% Please see attachments.
