

MINUTES OF THE FARGO DOME AUTHORITY MEETING

A regular meeting of the Fargo Dome Authority was held on Tuesday, November 28, 2023 at 3:30 p.m. in FARGODOME Conference Room with President Michael Ellingson presiding.

President Michael Ellingson called the meeting to order at 3:31 p.m.

Rob requested to add a discussion on the Food and Beverage Services Agreement Extension between FARGODOME and OVG Hospitality to the agenda under additional items.

David Suppes made a motion, seconded by Rick Steen, to approve the agenda of the November 28, 2023 Fargo Dome Authority meeting as amended. Motion carried.

Troy Goergen made a motion, seconded by Blake Nelson, to approve the minutes from the October 31, 2023 Fargo Dome Authority meeting. Motion carried.

Rob Sobolik presented the General Manager's report as follows:

- Year-to-Date Net Income through October 2023 is stated at \$554,765 which is a positive variance (to budget) of \$519,865.

Upon review, David Suppes made a motion to approve the October 2023 financial statements as presented.

On call of the roll, Armbrust, Ellingson, Goergen, Jordheim, Nelson, Steen and Suppes voted aye.

David Suppes presented the Fargo Dome Authority Building and Finance Committee report. The Fargo Dome Authority Building and Finance Committees met on Wednesday, November 21, 2023. Items discussed included:

- October 2023 Financial Statements: The October 2023 Financial Statements were approved by the Finance Committee at the meeting on November 21, 2023.
- Insurance Renewal Update: Ben Armbrust and Ryan Hoffman from Dawson Insurance/Marsh & McLennan Agency provided the committees with an overview on insurance renewals for 2024. Please see attachments. K&K provided pricing for liability insurance at \$126,459 and Zurich provided pricing for property insurance at \$239,727. The total program premium would be approximately \$380,866 which is an 8.7% increase overall from last year. Upon review of the carriers' proposals and based on the climate of the current market, it was the recommendation of Ben and Ryan to move forward with Zurich (incumbent) for property insurance and K&K (incumbent) for liability coverage. The Finance and Building Committees each approved motions to accept the above recommendation.
- Food Purveyor Approval: Zack reviewed the FARGODOME Food Purveyor RFP Evaluation Form. Please see attachment. Based on the evaluation form, Sysco had the highest total score and it was the recommendation from FARGODOME management to move forward with them. The Finance Committee accepted a motion to approve the bid from Sysco for food purveyor.
- Project and Capital Budget Updates:
 - Football Turf: The winch motor conversion for the football turf is slated for December 10.
- Escrow Balance & Performance Reports: The FARGODOME permanent fund performance, year-to-date, through September 2023 is -2.86%. Please see attachments.
- Additional Items: Troy Goergen noted that Jeff Volk had reached out to him regarding stepping down from the Fargo Dome Authority Building Committee.

David Suppes made a motion to approve the Building and Finance Committee report as presented.

On call of the roll, Armbrust, Ellingson, Goergen, Jordheim, Nelson, Steen and Suppes voted aye.

Discussion of FARGODOME Remodel and Conference Center Addition: Rob noted that absentee ballots are still available for the Special Election. The in person vote will be held December 5, 2023 at the Ramada, FARGODOME and Civic Center.

Fargo Dome Authority Building Committee Membership Update: Troy updated the group that Jeff Volk had reached out to him regarding stepping down from the Fargo Dome Authority Building Committee. Troy brought forward Brent DeKrey, Associate Director of Facilities Management Construction and Maintenance at NDSU, as a replacement.

Troy Goergen made a motion, seconded by David Suppes, to approve Brent DeKrey as a new member of the Fargo Dome Authority Building Committee.

On call of the roll, Armbrust, Ellingson, Goergen, Jordheim, Nelson, Steen and Suppes voted aye.

Absent and not voting:

The motion was declared carried.

Additional Items:

- Discussion on the Food and Beverage Services Agreement Extension between FARGODOME and OVG Hospitality. Rob reviewed the Food and Beverage Services agreement extension between FARGODOME and OVG Hospitality. Please see attachment. The term of the extension would begin on January 1, 2024 and conclude on December 31, 2025. The compensation and fees would remain the same as the current agreement in place. Rob recommended that the Authority accept a motion to move forward with the Food and Beverage Services Agreement Extension between FARGODOME and OVG Hospitality as presented.
Rick Steen made a motion, seconded by Troy Goergen, to approve the motion requested above.
