PROJECT SUMMARY:

Last year, we held a conference called “Erasing Stigma” and the intent was to begin the conversation of erasing all types of stigmas in an event each year. The flavor of the event was Ted-style talks from those with lived experience and discussion panels about forward direction and change-making. The first year was centered on the stigma associated with having a successful career that changed when a felony is one’s background. The keynote speaker was Ryan Leaf, former NFL athlete who now has a very different life than the public once knew. The overall conference had the underlying theme of resilience and empowerment, but there was need to face and work on erasing stigma.

The 2018 conference planning is just beginning at this time. We have not yet selected a final theme, but we are exploring topics such as the following: women with felony backgrounds, being a single parent trying to overcome a background, the effect on the family when there is incarceration, etc. There will be a larger national or regional speaker and we will get additional regional and local speakers and panelists. **We would apply the funds toward a speaker fee for the keynote, so the funds will go to public education.** In 2017, the keynote was over thousands of dollars, so this request would go toward that cost.

Our mission is to be an open door to the Golden Ridge community as a gathering place for people of all faiths and cultures, the most culturally diverse neighborhood in Fargo. This is the fourth year of All Nations Community Event, where numerous cultures and faiths gather for a day of celebrating our diversity. It is not a religious event; rather it is a neighborhood sharing food, dance, music, and family activities that are interactive, enabling us to get to know our neighbors in a non-threatening, fun way. This helps us with our goals to continually be building bridges and become more tolerant of each other as we journey together in life.

All Nations Community Celebration has become a wonderful annual event for the Golden Ridge neighborhood and beyond. Golden Ridge is known as a low-income area, with more than half the residents living in subsidized housing. Many New Americans live within this small quadrant, and a minimum of 12 different cultures are known to reside in a little more than 1000 family units.

Despite the variety of cultures and faiths within the boundaries of Golden Ridge, a study which was done two years ago through the generosity of a Community Innovation Grant (Bush Foundation) indicated there are many who do not know their neighbors. There is fear of the unknown, and there are misunderstandings between culture practices and norms. People are sometimes afraid to step out of their comfort zone and meet others different from them.

Golden Ridge Lutheran Church acknowledges the decline in membership over the years and has been working to become a community center, a gathering place, where all people are welcome to use the building for meetings and athletic activities outdoors. Thus a new basketball hoop is being installed this summer for residents to use as they would like. A picnic table or two will be installed on the lawn as well as some benches for spectators. A newly installed elevator has made the building accessible for the first time, and a new kitchen is open for groups to use for their activities. On the first Wednesday of each month, a "Know Your Neighbor" potluck has brought together neighbors in a non-threatening way to enjoy food, conversation and games. It is not a religious event – all faiths have come together to share.

The primary goal of All Nations Community Celebration is to affirm the presence of a diverse community and celebrate the gifts of all people. This is accomplished through interactive games and activities, such as painting a large mural together; at least seven cultures are preparing dances or other musical entertainment on a rented stage on the lawn; kids will play together on bouncy houses and basketball three-on-three; shared ethnic foods, barrel train rides, horse carriage rides, and a petting zoo will also bring people together. The Fargo Fire Department and Police will be on hand and they allow people to get into the vehicles, while telling them about their work to keep the neighborhood safe. For the first time this year, local artisans are being invited to share their crafts or art with demonstrations and the ability to sell their wares. At least six vendors are planning to attend. The event is free.

Canvassing the neighborhood with door hangers will take place the day before the event by volunteers. Attempts at local media being present will be made.

We expect the most inclusive and diverse All Nations Community Celebration ever and would appreciate the financial support of the Fargo Human Relations Commission.

The Human Family is excited to share that the North Dakota Human Rights Film and Arts Festival is preparing for its 2018 exhibition. This year, we're proud to announce that the festival has expanded as a touring festival, and will hold screenings and receptions in three cities in North Dakota: Bismarck, Fargo and Grand Forks. This grant application is for costs associated with the Fargo component of the festival.

In Fargo, the film festival will take place over two nights in November, 2018: Thursday, November 15 and Friday, November 16. This year the festival will utilize Theater 1, expanding the number of seats available at the festival to 700 people. Submissions to the film festival began in February, and to date 79 films from 23 countries have been received. Announcements about the films selected to screen at the festival will be made in early October, 2018.

Panel discussions including local human rights and social justice leaders and advocates will take place at the end of each screening. They include:

- **Thursday, November 15:** To commemorate Hunger and Homelessness Awareness Week, a panel discussion about **Homelessness in North Dakota** will take place. We have invited Jessica Thomasson, ED of LSSND moderate the discussion. Invitations to participate as a panelist have also been extended to: Cody Schuler, ED of the FM Coalition for Homelessness; George Connell, Professor at Concordia College; Jan Eliasson, ED of the Gladys Ray homeless shelter; Whitney Fear, of Homeless Health; and Jesseca White of the Fargo PD. We may also have a current or former homeless individual to share about their experiences, but that won't be confirmed until closer to the event.
- **Friday, November 16: The Missing and Murdered Indigenous Women Crisis.** We have invited Michael Yellowbird to moderate an intimate discussion with Lisa Brunner, enrolled member of the White Earth Ojibwe Nation and 2016 Bush Fellow, and B.J. Jones, Director of the Tribal Judicial Institute and Affiliated Faculty at UND's School of Law. Their discussion will educate the audience around the impacts of historical trauma and the roots the MMIW crisis has in colonization - and how that history still impacts women today.

As part of this panel discussion, we are also currently working with artists and will be coordinating an exhibition that will take place in Fargo as part of the film festival (separate from the traveling exhibition, and taking place only in Fargo). We're currently working on engaging the [REDress Project](#), and working with as many downtown businesses as possible to adorn their store-front windows that week with Red Dresses or the like to bring awareness to the MMIW crisis.

The Human Rights Art Festival will be held separately from the film festival in 2018. The art festival is opening in Grand Forks in November, and is expected to come to Fargo in January of 2019. We are currently working with a local art museum as a potential host for the festival (the facility is ADA compliant). Details about the art festival's location in Fargo will be finalized in the coming weeks.

The Fargo Human Relations Commission branding will be utilized on all materials relating to the festival from approval of the grant through the conclusion of the festival in March of 2019.

Funding provided by the Fargo Human Relations Commission will be used directly to:

- Offset the cost of Theater 1 Rental at the Fargo Theatre (\$250)
- Offset the cost of an art event such as the REDress Project (\$250)

Hi Kara,

I wanted to let you know that we have a soft-launch of our ticket sales for the 2018 North Dakota Human Rights Film Festival that we'll be promoting more in the coming weeks. Now through October 1, we're offering a \$5 savings per individual tickets to the festival (\$10 each for individual seats each night or \$25 for a Festival Pass to all screenings in Bismarck, Fargo and Grand Forks. After Oct. 1, ticket prices are \$15 and \$30 respectively). We've also introduced group pricing for groups of 10 or more.

I'm not sure how many people are on the Commission, but if there's a group that's interested in attending we can work out a discount based on that number (and since you're also managing the NAC, we can certainly combine those Commission members into this as well).

This year, the festival will take place in Fargo on Thursday, November 15 and Friday, November 16. Doors open at 6 and screenings start at 7.

If anyone from the two Commissions are interested in attending, let me know and we can get them seats and take care of everything pretty quickly!
