B. The second application to be considered is for the transfer of a Class ABH-Limited alcoholic beverage license from FCH Fargo HIE LLC d/b/a Holiday Inn Express to 3803 Hospitality LLP d/b/a Holiday Inn Express to be located at 1040 40th Street South.

Moved by Todd, seconded by Johnson to approve the transfer of a Class ABH-Limited alcoholic beverage license from FCH Fargo HIE LLC d/b/a Holiday Inn Express to 3803 Hospitality LLP d/b/a Holiday Inn Express to be located at 1040 40th Street South. All voted in favor, motion carried.

3. City Auditor's office requested the Board reconsider the application from Nail Concepts d/b/a Nail Deluxe for a class G liquor license. The applicant submitted additional information and now has a limited food service permit from Environmental Health. They now have a similar set up as The Nail Bar who has a Class G liquor license. Moved by Pagel, seconded by Todd to approve the issuance of a Class G alcoholic beverage license be issued to Nail Concepts d/b/a Nail Deluxe. Motion Carried

4. Joe Burgum updated the Liquor Board on the status of the subcommittee. The subcommittee is working on the penalty structure and the process of the Task Force.
