Purchase Description: NIJ Level IV Armored Caterpillar Multi-Terrain Loader The Caterpillar 297D has a cab with A/C as well as a high flow, two-speed, self level, dual level suspension undercarriage, advanced machine information and control system. The subject ROOK comes equipped with an electro/hydraulic implement control, RH; electro/hydraulic hydrostatic transmission control LH; hand and foot throttle, 12 volt electrical system, 90 ampere alternator, gauges, operator warning system indicators, a vinyl seat with an ergonomically contoured armrest and a control interlock system. In addition, the machine carries a Cat C3.8 DIT Turbo, Tier IV compliant diesel engine that has 106 net HP @ 2500 RPM, SOS Sampling valves, Engine Oil and Hydraulic Oil, Tilt up Radiator/Hydraulic Oil Cooler, Lockable Engine Enclosure, 4 Machine Tie Down Points. The ROOK comes with ballistic resistant glass and is SCBA compatible for Hazardous Material and WMD response.

The Hydraulic breaching Ram A Hydraulic Breaching Device with 6500psi is fitted with four low-light video cameras attached to its face that allows for a 360 Degrees field of view and one infrared camera for frontal view. Tactical Non-Lethal Chemical Agent Delivery System **Grapple Claw** The Grapple Claw is an attachment that has over 4,000 pounds of lift capacity for debris removal and site preparation. **Vehicle Extraction** An attachment used for vehicle removal and recovery **Armored Personnel Platform** One can raise the attachment (with or without personnel) to heights that allows for second story entries/rescue operations or fortified positions. The platform also has video monitoring, self-contained lighting and shooting ports. **Trailer** 12 ton Trailer with goose neck, 25' flat deck 5' dove tail, and electric brakes **Standard Electronics** 1 – Infrared Camera's, 8-IP Low Light Camera's, NVR, WIFI, and Transmitted Capability Wireless remote control of the loader with video feed to the operator, 1000 ft line of site control. **Warranty** 36 Months Warranty on the Machine and 12 Months Warranty on the cameras and electronic installations.
