The applicant agrees to follow all the regulations in the City of Fargo Overdimensional Vehicle Policy. Any false information voids this permit. Permission for this movement is hereby granted, subject to compliance with provisions of the laws of the State of North Dakota, City of Fargo, and under the terms, conditions and restrictions contained herein and subject to revocation upon non-compliance. Permittee is responsible for all accuracy on the permit form. Permittee agrees to all information listed on permit to be truthful.
