REQUEST FOR PROPOSAL

CITY OF FARGO

I. PURPOSE OF REQUEST

The City of Fargo is requesting proposals for tobacco prevention and cessation activities through reducing tobacco-related disparities in special populations (American Indians, behavioral health, low socioeconomic status, and Lesbian, Gay, Bisexual, Transgender) through tobacco cessation-related activities and/or preventing the initiation of tobacco use, including e-cigarettes and other vaping devices among youth and young adults. In addition, proposals may be used to engage youth in activities to become advocates to counteract tobacco industry marketing influences. Services will commence Fall 2020. All detailed information is outlined in the following Request for Proposal (RFP).

II. HISTORY OF THE PROJECT

Fargo Cass Public Health received grant funds from the North Dakota Department of Health through funds allocated from the North Dakota Legislature to be used for tobacco prevention, control, and cessation activities. Funding for such activities are a result of the Master Settlement Agreement (MSA) and are to be use for residents of Cass County and the State of North Dakota. Fargo Cass Public Health has received funding because of the MSA since 2001.

- B. All proposals must be presented to the Fargo Cass Public Health Tobacco Prevention Committee by 3:00 pm on August 5, 2020 (1240 25th Street South, Fargo, ND 58103). Three copies of the proposal are required.
- C. Fargo Cass Public Health Tobacco Prevention Committee will review, score, and approve all proposals.
- D. The City of Fargo reserves the right to reject all submittals.

IV. FUNDING AVAILABLE

The total amount of funding available is \$50,000. Funding may be spread across multiple proposals. Funding amounts awarded may be adjusted as determined

by the Fargo Cass Public Health Tobacco Prevention Committee. Funding provided must be utilized in programs serving the residents of Cass County.

The strategies identified for funding are:

- A. Preventing the initiation of tobacco use, including e-cigarettes and other vaping devices among youth and young adults.
- B. Engage youth in activities to become advocates to counteract tobacco industry marketing influences.
- C. Reducing tobacco-related disparities in special populations (American Indians, behavioral health, low socioeconomic status, and Lesbian, Gay, Bisexual, Transgender) through tobacco cessation-related activities.

VI. SELECTION CRITERIA

- A. The City of Fargo intends to award contracts to entities whose proposal fulfills each of the below selection criteria, addresses at least one of the strategies listed above, and best meets the program needs. Written proposals shall contain all items listed in the selection criteria and will be weighed equally against one another based on the following grading system. The maximum number of points per category is noted after each item below:
 - i. Contact Information: (Maximum points: 5).
 - ii. Organizational Background: (Maximum points: 20).
 - iii. Proposed Activity: (Maximum points: 20).
 - iv. Project Sustainability: (Maximum points: 15).
 - v. Project Evaluation and Data Collection: (Maximum points: 10).
 - vi. Description of past and current work experience with tobacco initiation, prevention, and cessation: (Maximum points: 15).
 - vii. Project Budget and Justification: (Maximum points: 15).
- B. The Fargo Cass Public Health Tobacco Prevention Committee (TPC) will evaluate each proposal on the above criteria. The TPC will determine which proposals would best meet the identified strategies.

I. PROPOSAL INSTRUCTIONS

- A. Proposals must be ten pages or less.
- B. Activities must address one or more of the strategies identified (see Funding Available).
- C. All <u>seven sections</u> of the RFP are to be completed.
