1. PURPOSE OF REQUEST

The City of Fargo requests proposals from qualified vendors for **Emergency Flood Preparation Equipment** to be used in preparation of protective measures from anticipated spring flooding on the Red River. The City desires to secure various rental equipment. Vendors will be responsible for delivery to the City of Fargo Public Works and Solid Waste Facilities, address as listed below, prior to flood event and reclamation following flood event.

It is anticipated that a single vendor will not have the capacity to accommodate the security of the total equipment requested therefore vendor will need to fully identify intended quantities on submitted proposal.

Selection of vendors will be based on cost (50%), experience (20%) and specifications (30%) of requested equipment.

2. GENERAL INSTRUCTIONS

The City reserves the right to cancel this RFQ in writing or postpone the date and time for submitting proposals at any time prior to the proposal due date. The City by this RFQ does not promise to accept the lowest cost or any other proposal and specifically reserves the right to reject any or all proposals, to waive any formal proposal requirements, to investigate the qualifications and experience of any Proposer, to reject any provisions in any proposal, to modify RFQ contents, to obtain new proposals, to negotiate the requested services and contract terms with any Proposer, or to proceed to do the work otherwise.

The City hereby notifies all bidders that it will affirmatively insure that in regard to any contract entered into, pursuant to this request, minority business enterprises will be afforded full opportunity and are encouraged to submit proposals in response to this invitation and will not be discriminated against on the grounds of race, color, sex, or national origin in consideration for an award. 3. **SCOPE OF WORK**

A. **Rental Equipment**

1. **Equipment Delivery**
Equipment will be available for use three (3) days from request to Public Works location, address as previously stated. Inventory shall be staged by supplier and acceptance made by renter.
2. **Equipment Mechanical Condition**
All equipment will be mechanically sound and fully operational upon delivery. If the equipment becomes inoperable during rental period vendor will be required to provide replacement unit of equal or greater within 12 hours of initial contact of loader failure. All costs encumbered to replace inoperable equipment will be the responsibility of the vendor.
3. **Payment**
Rental rates shall consist of a base weekly rate plus hourly run time of each unit.
Payment for rentals will be on a weekly (7 day) basis for each individual unit. Partial weeks shall be prorated.
4. **Rental Period**
Rental period will begin on delivery at above specified location and terminate upon request for removal.

B. **Reclamation**

Upon request for removal, vendor will be required to remove all units from City of Fargo location's within five (5) calendar days.
