# REQUEST FOR PROPOSALS For 2020 EMERGENCY PUMP RENTAL FLOOD STAGE

#### 1. PURPOSE OF REQUEST

The City of Fargo requests proposals from qualified vendors for emergency pump rental required for protection from anticipated spring flooding on the Red River. The City desires to secure fourteen (14) rental pumps ranging in size from 4" to 6". Vendors will be responsible for pump delivery to the locations provided by the City of Fargo Public Works Facility prior to flood event. Reclamation following the flood event from the listed locations will be the renter's responsibility.

Selection of vendors will be based on cost, experience and specifications of requested equipment.

All proposals must be received by 2:00 PM, Friday, February 14th, 2020.

#### 3. SCOPE OF WORK

#### A. Pumps

#### 1. Pump Delivery

Pumps will be available for setup three (3) days from request to Public Works location, address as previously stated. **Inventory shall be staged by supplier to the locations provided by the renter and acceptance made by renter**.

#### 2. Pump Mechanical Condition

All pumps will be mechanically sound and fully operational upon delivery. If pump becomes inoperable during rental period vendor will be required to provide replacement pump within 12 hours of initial contact of pump failure. All costs encumbered to replace inoperable pumps will be the responsibility of the vendor.

#### 3. Payment

Rental rates shall consist of a base weekly rate plus hourly run time of each unit. Payment for pump rental will be on a weekly (7 day) basis for each individual pump. Partial weeks shall be prorated.

#### 4. Rental Period

Pump rental period will begin on delivery at above specified location and terminate upon request for removal.

#### B. Reclamation

Upon request for pump removal, vendor will be required to remove all pumps from Public Works location within five (5) calendar days.

#### 5. SUCTION/DISCHARGE HOSE SPECIFICATIONS

Suction hose will consist of heavy duty spiral wound suction hose with Bauer quick disconnect fittings.

Discharge will consist of a heavy duty lay-flat discharge hose with Bauer quick disconnect fittings.

#### 6. PROPOSAL FORMAT

Contractors shall submit proposals on attached or similar forms.

The City intends to utilize a single vendor for all pump rentals.

Local contractor with full maintenance shop will be given preference.
