

RE: Simonson First Addition Conditional Overlay Revisions

Dear Barrett,

Please see enclosed proposed Conditional Overlay Revisions for Simonson First Addition located at 3825 53rd Ave South. The intent of the revisions is to mirror the changes being made by the neighboring property owner, broaden the sign and landscape regulations to more closely represent current City of Fargo requirements, and provide clarity during site permit review.

Summary of proposed revisions to the conditional overlay include:

- All revisions proposed by the property located at 3751 53rd Avenue South
- Eliminate the "Landscape Design" section and have the landscaping regulated by current City of Fargo Code Section 20-0705 "Trees and Landscaping."
- Modify the "Parking" section on page 16 of the conditional overlay by eliminating the maximum of 20% more parking spaces than the required minimum.
