REGULATIONS FOR USE:

The following restrictions apply to all Outdoor Amplified Sound permits issued by the City of Fargo pursuant to section 11-0209 of the Fargo Municipal Code:

- **The only sound(s) permitted shall be music, human speech or both.**
- **No permits shall be issued for any property located within a residential zoning district. For the purpose of this section the Downtown Mixed-Use Zoning District is not considered residential.**
- **Permits are only valid for the day(s) listed on the permit.**
- **Permits issued for any property where the source of the sound is located within 500 feet of a residential zoning district shall be valid for no longer than one day.**
- **With respect to any permit for a property where the source of the sound is within 500 feet of a residential zoning district, no more than four (4) permits may be issued every 30 days; each permit shall be at least five (5) days from any other permit**
- **As described within sections 11-0203 and 11-0204 of the Fargo Municipal Code, the noise prohibitions established between the hours of 10:00 pm and 6:00 am Sunday evening through Friday morning and 11:00 pm and 7:00 am Friday evening through Sunday morning, are applicable.**

By signing below, you acknowledge your understanding of the requirements and/or restrictions associated with obtaining an Outdoor Amplified Noise permit from the City of Fargo as described within Article 11-02 of Chapter 11 of the Fargo Municipal Code, and agree to abide by all applicable requirements. Furthermore, you hereby agree to indemnify the City of Fargo, its officers and employees from any claims arising from the events or activities under the permit to include, but not limited to, compliance with the Americans with Disabilities Act, the Fargo Municipal Building Code and all other health and safety laws and regulations.
