The Board received a communication from Michael Brooks, Vice President/Market Manager, Go Radio Broadcasting, LLC and Rib Fest Committee Member, requesting a one hour extension of the City's Noise Ordinance for Rib Fest and More from June 4 through 7, 2008 from 10:00 p.m. to 11:00 p.m. for live entertainment. Mr. Brooks stated they will make certain all City guidelines are followed and that noise is reduced as much as possible by the direction of their sound equipment. He also requested that they be able to maintain low-level sound up to midnight using their low-level PA for background music while patrons are exiting.

The Board received a communication from Senior Planner Robert Stein stating the Renaissance Zone Project application presented by Bristol Street Development, LLC meets all of the minimum criteria set forth in the Renaissance Zone Plan and is consistent with the established goals and objectives. Mr. Stein recommended that the project be approved.

No Commissioner being absent and none voting nay, the motion was declared carried.

Petition Requesting the Rezoning of Parcels of Land in the Southwest Quarter of Section 18, Township 138 North, Range 48 West Denied (8452 South University Drive):

At a Hearing held on May 14, 2008 the Fargo Planning Commission recommended approval of a change in zoning from AG, Agricultural to LC, Limited Commercial with a Conditional Overlay on an approximately 10 acre portion of the Southwest Quarter of Section 18, Township 138 North, Range 48 West, Cass County, North Dakota, described as follows: Commencing at the Northwest corner of said Southwest Quarter; thence N 89 degrees 57'09" E along the north line of said Southwest Quarter for a distance of one hundred feet to the point of beginning; thence continue N 89 degrees 57'09" E along the north line of said Southwest Quarter for a distance of five hundred sixty feet; thence S 00 degrees 36'37" E parallel to the west line of said Southwest Quarter for a distance of seven hundred seventy eight feet; thence S 89 degrees 57'09" W parallel to the north line of said Southwest Quarter for a distance of five hundred sixty feet; thence N 00 degrees 36'37" W parallel to the west line of said Southwest Quarter for a distance of seven hundred seventy eight feet to the point of beginning.

The City Auditor's Office published a Notice of Hearing stating this is the time and date set for said Hearing at which time all interested persons could appear and would be heard.

Written protests to the change in zoning as petitioned for had been received, such protests representing 29.3 per cent of the legal protest area.

Senior Planner Jim Hinderaker stated the requested zoning change is for the purpose of establishing a zoning classification that would allow the petitioner to move forward with the construction of a new office building and an attached warehouse on the property which will be used as the new home for Hogenson Construction. He said the company designs and builds commercial grain storage, feed mills, bulkweigher systems, fertilizer plants, and grain dryers, as well as providing millwright services and all of the construction equipment associated with the business is located at the various job sites. Mr. Hinderaker stated the property is located within the extraterritorial (ET) jurisdiction of the City and, therefore, the City has zoning, platting and building permitting authority within a four-mile radius of the City's corporate limits. He said this authority allows the City to ensure that development is orderly and adheres to the development standards of the Land Development Code. He said many of the City facilities and services that are typically a part of the existing infrastructure within the City limits may be limited and/or non-existent within the ET area. He said the petitioner was advised that future development may also be limited in terms of its size and scope based on the availability of these necessary facilities and services. He said in an effort to address concerns that had been raised, the petitioner made a number of changes to his request which Mr. Hinderaker summarized. He said staff and the Planning Commission are recommending approval of the requested zoning change.

There was discussion regarding the problem of providing adequate services to the petitioner.

Randy Schneider, petitioner, stated this project is one that is following the rules and regulations by the book. He summarized his project and stated this is basically going to be a one-story office building

Heather Budge, 1629 Round Hill Drive, spoke in opposition to the project. She said the residents do not feel a construction office would be good for their neighborhood.

Commissioner Williams questioned why the residents were concerned with the construction office.

Ms. Budge stated the residents are concerned that if this project is approved, it could lead to downzoning at a later date.

Commissioner Coates stated state law is really stringent on what grounds the City Commission can deny a request like this. She said it can only be denied on the basis of what criteria is not satisfied.

There was discussion regarding the criteria the project did not address.

Commissioner Wimmer stated the Commission can deny the request if all of the criteria has not been met.

Mr. Hinderaker stated an office building does fit in with the growth plan for this area.

(Commissioner Mahoney absent)

At 6:11 p.m. the Board took a five-minute recess.

After recess: All Commissioners present except Commissioner Mahoney. Mayor Walaker presiding.

Dale Ziegler, 1630 Round Hill Drive, stated there is only one access point to this area on 81st Avenue and adding more cars to that one entrance makes it a safety issue. He said the proposed project is not a good fit for this area.

Richard Thomas, 404 River Drive South, stated he is not sure the services that need to be provided for this project will be adequate. Another thing, he continued, this is zoning without representation. He said the residents in Round Hill cannot vote for Commissioners.

Rick Flacksbarth, 1241 45th Avenue North, stated he is representing Harold Newman, owner of Newman Sign Company. He said their concern is the restrictions listed in the Conditional Overlay, particularly the ones relating to signs. He said it seems like over the past year or so an overlay is thrown in and more and more conditions are being added. He said when these conditions are placed on the property, the City becomes the enforcer. He said the City should not be spending taxpayer money to have City employees making sure all of the conditions in the overlays are being followed.

Rodney Young, President of Amber Plains; Rob Hansen, 8308 Riverview Road; Dave Ekman, 1615 Round Hill Drive; Kristi Marks, 1220 76th Avenue South; and Paulette Ekman, 1615 Round Hill Drive spoke in opposition to the rezoning request and stated their concerns.

Mr. Hinderaker said their concerns have been addressed by the petitioner.

There was discussion regarding flooding concerns.

Mr. Schneider stated he has done everything the Planning staff asked him to do and changed his plan to follow everything to a tee. He said this project is for engineers who use laptops and not cranes.

City Attorney Erik Johnson stated the protest percentage is over 20% which means a super majority or 4/5 vote of the City Commissioners is needed to approve the zoning change.

State Senator Jim Pomeroy stated he and State Representative Lee Myxter are here at the request of the Round Hill residents. He said these residents cannot vote for the Fargo City Commissioners and they feel they have no representation on this issue. He said that is a concern of his and he would like to look into that issue further.

Commissioner Coates stated according to state law this body has voting control in this area. She said the way it is set up now is not fair. She said this is something that will probably be changed in the future and she is in favor of that, however, at the present time the City's actions must comply with state law.

Commissioner Coates moved to accept the findings and recommendations of staff and approve the request for rezoning.

Second by Wimmer.

There was discussion regarding certain criteria that the proposed zoning change did not comply with.

Commissioner Williams stated if the petitioner does not meet some of the criteria, the City Commission can deny the request.

On call of the roll Commissioner Coates voted aye.

Commissioners Wimmer, Williams and Walaker voted nay.

Absent and none voting: Commissioner Mahoney.

The motion was declared lost for the lack of a majority.

Commissioner Williams moved the request for rezoning be denied on the basis that approval criteria 20-0906.F.2 of the Land Development Code was not met, citing inadequate flood protection and inadequate response time for fire protection.

Second by Wimmer. On call of the roll Commissioners Williams, Wimmer, Coates and Walaker voted aye.

Absent and not voting: Commissioner Mahoney

The motion was declared carried.

At 7:00 p.m. the Board took a five-minute recess.

After recess: All Commissioners present except Commissioner Mahoney. Mayor Walaker presiding.

Plat of Dakota Boys and Girls Ranch and Petition Requesting the Rezoning of Parcels of Land in Dakota Boys and Girls Ranch Subdivision Denied (2038 76th Avenue South):

At a Hearing held on April 9, 2008 the Fargo Planning Commission recommended approval of a Plat of Dakota Boys and Girls Ranch and change in zoning from AG, Agricultural to MR-3, Multi-Dwelling on Lots 1 and 2, Block 1 and Lot 2, Block 2, Dakota Boys and Girls Ranch Subdivision, in the East Half of the Northwest Quarter of Section 13, Township 138 North, Range 49 West and from AG, Agricultural to SR-4, Single Dwelling on Lots 1, 3 and 4, Block 2, Boys and Girls Ranch Subdivision, in the East Half of the Northwest Quarter of Section 13, Township 138 North, Range 49 West.

The City Auditor's Office published a Notice of Hearing stating this is the time and date set for said Hearing at which time all interested persons could appear and would be heard.

Written protests to the plat and change in zoning as petitioned for had been received, such protests representing 61.6 per cent of the legal protest area.

Senior Planner Jim Hinderaker stated the Dakota Boys and Girls Ranch own approximately 80 acres of land on the south side of 76th Avenue South, approximately one-fourth mile east of 25th Street. He said the petitioner proposes to create a six lot subdivision on the north 52.92 acres with the intent of building the new Dakota Boys and Girls Ranch facility on the largest lot. He said the main area includes a private school, gymnasium, dining hall, chapel, residential treatment center, safe home, a future adolescent assessment center and a future childcare center along with possible soccer and softball fields. He said staff determined the Dakota Boys and Girls Ranch facility is best defined and classified as a Community Service use. He said Community Service uses are public, nonprofit or charitable uses generally providing a local service to people of the community. Mr. Hinderaker summarized the criteria required by the LDC before a major plat can be approved and stated that criteria has been satisfied.

Tim Eissenger, Vice President of Dakota Boys and Girls Ranch, stated their group purchased this property two years ago. He said they felt the property would allow for an adequate buffer and the location would put them in a position to be successful. He summarized the proposed project and also reviewed the Dakota Boys and Girls Ranch program.

In answer to a question, Mr. Eissenger stated Dakota Boys and Girls Ranch has four locations in the City.

Commissioner Williams brought up concerns relating to providing adequate services to the area.

Mr. Eissenger stated his group held meetings with the neighborhood and also offered tours of their facilities so the neighborhood could see what their program was all about. He said only two people participated in the tours.

Commissioner Wimmer stated the services the Dakota Boys and Girls Ranch provides are wonderful, however, he is concerned with the compatibility issue with the neighborhood and providing adequate services to this area.

Mr. Eissenger stated the Round Hill Neighborhood Association did contact their facility in Minot and were told it had very little impact on the neighborhood and property values. He said it would be unfortunate if they do not have the opportunity to prove themselves as good neighbors. He said he thinks they could be a good model and a contributor to South Fargo.

There was discussion regarding the types of individuals the Dakota Boys and Girls Ranch accepts into their program.

Police Chief Keith Ternes stated calls the Police Department has received for the facility have been for disturbances that were contained in the facility and runaways. He said the main calls were for runaways.

In answer to a question, Chief Ternes stated the Cass County Sheriff's Department would be responding to calls at the proposed facility.

Cass County Sheriff Paul Laney stated it is hard to predict response time in that area but they normally respond pretty quickly.

Dr. Cal Fercho, 2525 East County Club and Paula Ekman, 1615 Round Hill Drive; spoke in opposition to the zoning change and stated their concerns regarding property values and the safety of the children in the neighborhood.

At 8:03 p.m. the Board took a five-minute recess.

After recess: All Commissioners present. Mayor Walaker presiding.

Perry Ronning, Township Supervisor, stated the only access to this area is a gravel road which is a safety concern. He said his biggest concern is providing enough services for this area.

Commissioner Coates moved to accept the findings and recommendations of staff and approve the Dakota Boys and Girls Ranch Subdivision plat and zoning change.

The motion died for the lack of a second.

Commissioner Coates stated she can understand the Round Hill residents' concerns but these are the community's children. She questioned where this facility can be located if everyone says not in my back yard. She said as a community, all of the citizens' needs should be addressed and she hopes the Dakota Boys and Girls Ranch will be able to find a location in Fargo.

Commissioner Wimmer moved the Dakota Boys and Girls Ranch Subdivision plat and request for rezoning be denied on the basis that approval criteria 20-0906.F.2 of the Land Development Code had not been met citing the lack of being able to provide adequate services based on the magnitude of the project.

Second by Williams. On call of the roll Commissioners Wimmer, Williams, Coates and Walaker voted aye.

Absent and not voting: Commissioner Mahoney.

The motion was declared carried.

Commissioner Wimmer moved that the Board adjourn to 5:00 o'clock p.m., Monday, June 16, 2008.

Second by Williams. All the Commissioners present voted aye and the motion was declared carried.

The time at adjournment was 8:17 o'clock p.m.
