





The Committee reviewed a communication from Division Engineer, Jason Leonard, regarding design decisions for the shared use path that is part of the reconstruction of 17th Avenue South.

The design calls for a shared use path to be placed on one side of the street. It was determined that installing the path on the south boulevard was not feasible due to the high costs associated with relocating private utilities. Placing the path on the north side has also raised concerns about its impact on existing trees. While a 10-foot wide path was preferred, an 8-foot wide path would minimize the number of trees needing to be removed.

An investigation to evaluate the species and diameter of the affected trees showed that 6 of the 7 larger trees (greater than 12 inches in diameter) affected by the 10-foot path compared to the 8-foot path are Ash trees, a species vulnerable to the emerald ash borer. All except one of the other affected trees are less than 5 inches in diameter when comparing the difference between an 8-foot wide and a 10-foot wide path. Based on this analysis, it is recommended to proceed with the preferred 10-foot wide shared use path.

An open house public input meeting was held on September 18, 2024, to discus the overall project. There weren't many comments regarding the impact to the trees. Staff is recommending to construct a 10-foot wide shared use path on the north boulevard and replant new trees once the path is completed.

On a motion by Nicole Crutchfield, seconded by Tim Mahoney, the Committee voted to support the design decision for the construction of a 10-foot wide shared use path on the north boulevard with new trees being planted upon completion.



Background:

Engineering is planning to reconstruct 17th Avenue South, between University Drive South and 25th Street South, during the 2027 construction season as part of Improvement District BR-26-G1.

Figure 1: Project limits for 17th Avenue South



Before entering the design phase, a corridor study was conducted to assess the needs of this section. The study's preferred alternative was to install a 10-foot wide shared use path on one side of the street. The City of Fargo Engineering staff, in collaboration with Moore Engineering's design team, determined that installing the path on the south boulevard was not feasible due to the high costs associated with relocating private utilities. Consequently, the design team decided to install the shared use path on the north side of the street for the entire length of the project.

Tree Impact Considerations:

Choosing the north side for the path raised concerns about its impact on existing trees. While a 10-foot path was preferred, an 8-foot wide path was also considered to minimize tree removal. Moore Engineering conducted an analysis to assess the impact of both path widths on the existing trees.

The analysis revealed that installing an 8-foot wide path would require the removal of 23 trees, whereas a 10-foot wide path would result in the removal of 41 trees, a difference of 18 trees. Given the significant impact, we conducted a further investigation to evaluate the species and diameter of the affected trees.

The investigation showed that 6 of the 7 larger trees (greater than 12 inches in diameter) affected by the 10-foot path compared to the 8-foot path are Ash trees, a species vulnerable to the emerald ash borer. All except one of the other affected trees are less than 5 inches in diameter when comparing the difference between an 8-foot wide and a 10-foot wide path. Based on this analysis, it is recommended to proceed with the preferred 10-foot wide shared use path.

An open house public input meeting was held on September 18, 2024 to discuss the overall project gather input from the residents. A project website with a presentation of the project and an online form to submit comments was made available to residents who were unable to attend the open house public input meeting. There weren't many comments regarding the impact to the trees aside from one property owner who said this is the third time the boulevard trees were being removed since he has lived in his house.

Attached to this memorandum is a draft design decision document for the project that contains background information on the path vs. trees decision.

Recommended Motion:

Construct 17th Avenue South with a 10-foot wide shared use path on the north boulevard and replant new trees once the path is completed.



C. Purpose of Project

New/Reconstruction: The purpose of the project is to reconstruct 17th Avenue S between University Drive and 25th Street, replace underground utilities including storm sewer, sanitary sewer, and watermain, upgrade street lighting, traffic signals, and pedestrian crossing facilities near Fargo South High School. The project will also include reconstruction of pedestrian sidewalks and the conversion of an existing sidewalk to a 10 ft-wide shared use path for bicyclists and pedestrians.

D. Need for Project

The pavement and portions of the underground infrastructure along 17th Avenue S have reached the end of its useful life and are in need of replacement. The area surrounding this corridor is primarily residential, with Fargo South High School, Lewis and Clark Elementary School, and the Tharoldson Little Leage Baseball complex located along this segment of 17th Avenue S. This area is heavily utilized by pedestrians and does not have any dedicated bicycle facilities. The 17th Avenue Corridor Study dated April 2019 identified speeding as a noted problem along this segment of the corridor. Approximately 90% of vehicles were exceeding the posted speed limit by more than 7 miles per hour. This creates safety concerns for cyclists and pedestrians.

Existing Conditions: 17th Avenue S is a two-lane roadway with 4.5-ft pedestrian sidewalks on both sides of the road. A series of thin overlays have kept the surface quality of pavement in this segment in fair condition, however the road has begun to deteriorate and will require reconstruction. There are no designated bicycle facilities in this segment of 17th Avenue S to serve the two adjacent schools, as well as the sports facilities publicly used at each school in addition to the Little League complex.

Deficiencies: The watermain in the drinking water distribution system is Asbestos Cement Pipe that becomes brittle with age and is prone to watermain breaks. Portions of the sanitary sewer collection system have sags in the main that can lead to backups into basements. The east half of the storm sewer system is undersized for current design standards. The pavement condition is deteriorating and requires continual repairs. There is a lack of bicycle facilities within the corridor.

H. Comparison of Alternatives:

The desire to extend the bicycle network through the 17th Avenue S corridor leads to addition of a shared use path in either the north or south boulevard. The difference in alternatives for adding a path to either boulevard are tree and utility impacts. A combination of Alternative B options and Alternative C options may be selected, with one of the selections being a shared use path.

An 8 ft shared use path is allowable in situations when bicycle and pedestrian traffic is expected to be low, the path will not be regularly subjected to maintenance vehicle loading conditions that would cause pavement edge damage, and the corridor has physical constraints.

For added context, the path network to the west is anticipated to be located on the south side of 17th Avenue S due to the available Right-of-Way and connection to the existing 10 ft path under Interstate 29 at 35th St S roughly 0.8 miles to the west of this project. The path network to the east of the project is undetermined but the existing 10 ft path into Lindenwood Park is located on the north of 17th Avenue S, roughly 0.5 miles to the east. Crossing 17th Avenue S on the west side of 25th St is an acceptable option.


Lastly, in coordination with Fargo Public Schools and Fargo Park District to acquire a permanent easement, the north boulevard options allow the path alignment to shift 2 ft to the north up to the property line, to avoid impacting 37 trees.


