BOARD OF PARKING COMMISSIONERS MINUTES

Regular Meeting: Friday: August 26, 2016

The Regular Meeting of the Board of Parking Commissioners of the City of Fargo, North Dakota, was held in the City Commission Room at City Hall at 8:00 o'clock a.m., Friday, August 26, 2016.

The Parking Commissioners present or absent were as follows:

Also Present: Commissioner Dave Piepkorn (City Commission Liaison)

Absent: None

Chairperson Williams called the meeting to order.

Item 1: Approve Order of Agenda

Member Thorson moved the Order of Agenda be approved as presented. Second by Member Bailly. All Members present voted aye and the motion was declared carried.

Item 2: Minutes: Regular Meeting of July 29, 2016

Member Hayer moved the minutes of the July 29, 2016 Parking Commission meeting be approved. Second by Member Bailly. All Members present voted aye and the motion was declared carried.

Item 3: Roberts Ramp Project

Planner Derrick LaPoint presented an update to the Board on the status of this project, including the upcoming cost estimate on soil testing/mitigation from fuel tanks and contaminated soil found on the property; sidewalk closures; and the addition of the tower crane and multiple helical piles to the site.

Item 4: LinkFM Ridership

Derrick LaPoint updated the Board on the data report noting the amount of construction in downtown Fargo has helped to increase the ridership on LinkFM.

Item 5: Interstate Report/Financial Data

Andy Renfrew, Interstate Parking (IP), reviewed the July financial and operations report.

Board Members discussed the Downtown Residential Parking Permit Program (DRP3 Program) and its growth with more residents living downtown.

Item 6: On-Street Data Collection

Derrick LaPoint distributed an updated handout of a map showing the On-Street Parking Data Collection for April 2016. He stated this data, compiled by staff, shows the percentage of street capacity occupied at certain times of the day (9am, 12pm, 4pm, 8pm). He added parking counts will be completed again in October 2016.

Item 7: Civic Area Parking

Mr. LaPoint stated, with construction of the new Fargo City Hall, the Civic Center Parking Lot east of the current City Hall is closed, and a temporary parking lot is open in the Civic quad for City Hall visitors and Fargo Library patrons. He added this lot contains 37 parking spaces and is accessible through the Library's current parking lot entrance on 4th Street North.

Planning Director Jim Gilmour updated the Board on additional parking around City Hall and noted a portion of the Civic Center Parking Lot should be available for parking later this year.

Item 8: Downtown Master Plan

Planning Administrator Nicole Crutchfield reported staff is in the process of creating a Working Committee for the Downtown Master Plan and are looking for representatives from the Parking Commission to be on this committee. She stated the committee would start meeting in September.

Item 9: Other Issues or Public Comments

Mr. Gilmour updated the Board on the negotiations to the parking agreement for the Civic Center Ramp between the City and the Fargo Radisson Hotel. Mr. Gilmour noted City Attorney Erik Johnson is working on changes that are to be incorporated within the agreement. He added the agreement requires the City to install new automated parking equipment.

Paul Schnettler, Interstate Parking (IP), presented a handout to the Board of three proposals they have received for the TIBA, Amano and SkiData systems. He discussed the criteria considered during the review process and noted, of the three systems, TIBA was the only system that met the criteria. Mr. Schnettler stated the recommendation is to proceed with the TIBA system.

Member Walvatne moved the Parking Commission allow Interstate Parking to accept the bid from Tapco Safe Travels for the TIBA Parking System for the Civic Center Ramp. Second by Member Bailly. All Members present voted aye and the motion was declared carried.

Site Update

Excavation and earthwork services continue on-site while helical piles continue to be driven into the bedrock followed by pile cap and column forming and pouring. 2nd Avenue North will be closed to one-lane of eastbound traffic starting on October 3-7. The closure is necessary for site utility connections. The City Engineering Department has received the traffic control plan and approved the closure.

Financial Report

Revenue was down slightly, 1.7%, from July based largely on a key-card audit from a large tenant at the Island Park Ramp. Expenses were consistent with July however there were three payrolls in the month of August that is reflected in the "Enforcement Payroll" line.

On-Street Management

As of September 19th there were 249 plates at the Tier 3 level, of those 120 have outstanding citations totaling \$12,676. Additionally, the "tow list" has 7,884 plates going back many years and includes many of the "old" North Dakota plates.

As a matter of operational practice, despite City regulations allowing for the towing of vehicles with past-due citations, the Fargo PD nor Interstate Parking have made a strong effort to tow vehicles in the downtown area due to the traffic and space challenges posed.

I am requesting that the Parking Commission direct Interstate Parking to begin towing eligible vehicles for outstanding parking citations.



PROGRAM

The Downtown Residential Parking Permit Program (DRP3) is a parking program for residents who reside downtown. With a DRP3 permit, a resident can park on designated streets without being penalized by time-zone restrictions.

A parking permit can be acquired for up to 6 months.

WHERE CAN YOU PARK?

- ▶ Streets not mapped in red within Zones 1, 2, or 3.
- ▶ City-owned lots between 5:00 p.m. and 8:00 a.m.

RESTRICTIONS

You must follow street signs in the red zone at all times:

- ▶ 15-minute and 30-minute signed zones
- ▶ Fire hydrant marked zones
- ▶ Handicap accessible spaces
- ▶ Bus Stops
- ▶ Loading Zones
- ▶ In any off-street, city-owned parking lots when an attendant is present or for special events
- Night parking restricted and signed areas (see below)

NIGHT PARKING

Streets within the central business district have overnight parking restrictions throughout the year.

On-street parking is restricted on East/West Avenues between the hours of 2:00 a.m. and 7:00 a.m., Monday, Wednesday, Friday, and Sunday.

On-street parking is restricted on North/South Streets between the hours of 2:00 a.m. and 7:00 a.m., Tuesday, Thursday, and Saturday.
